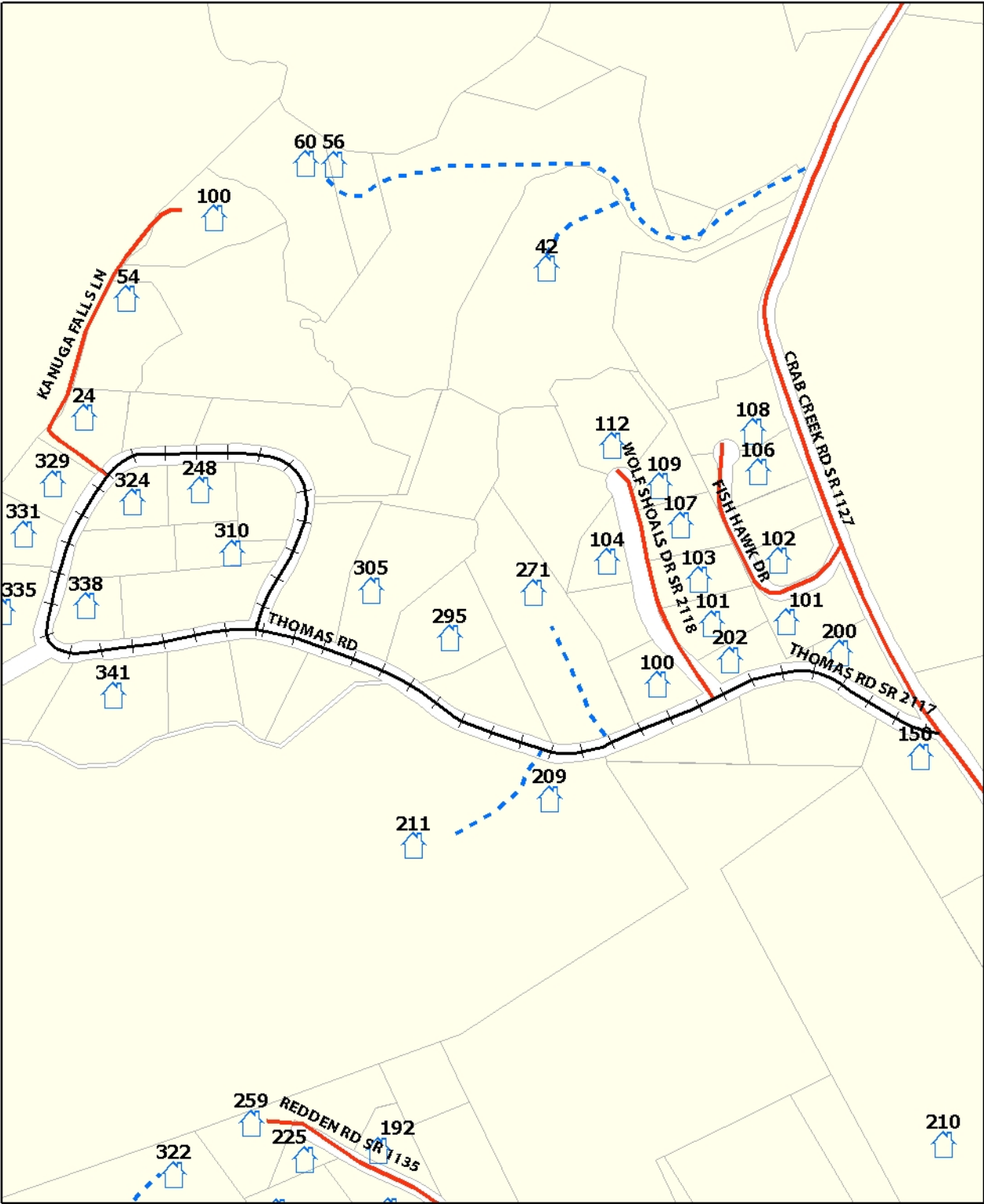

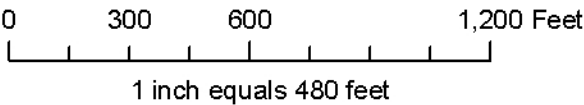
Proposed State Road Thomas Rd

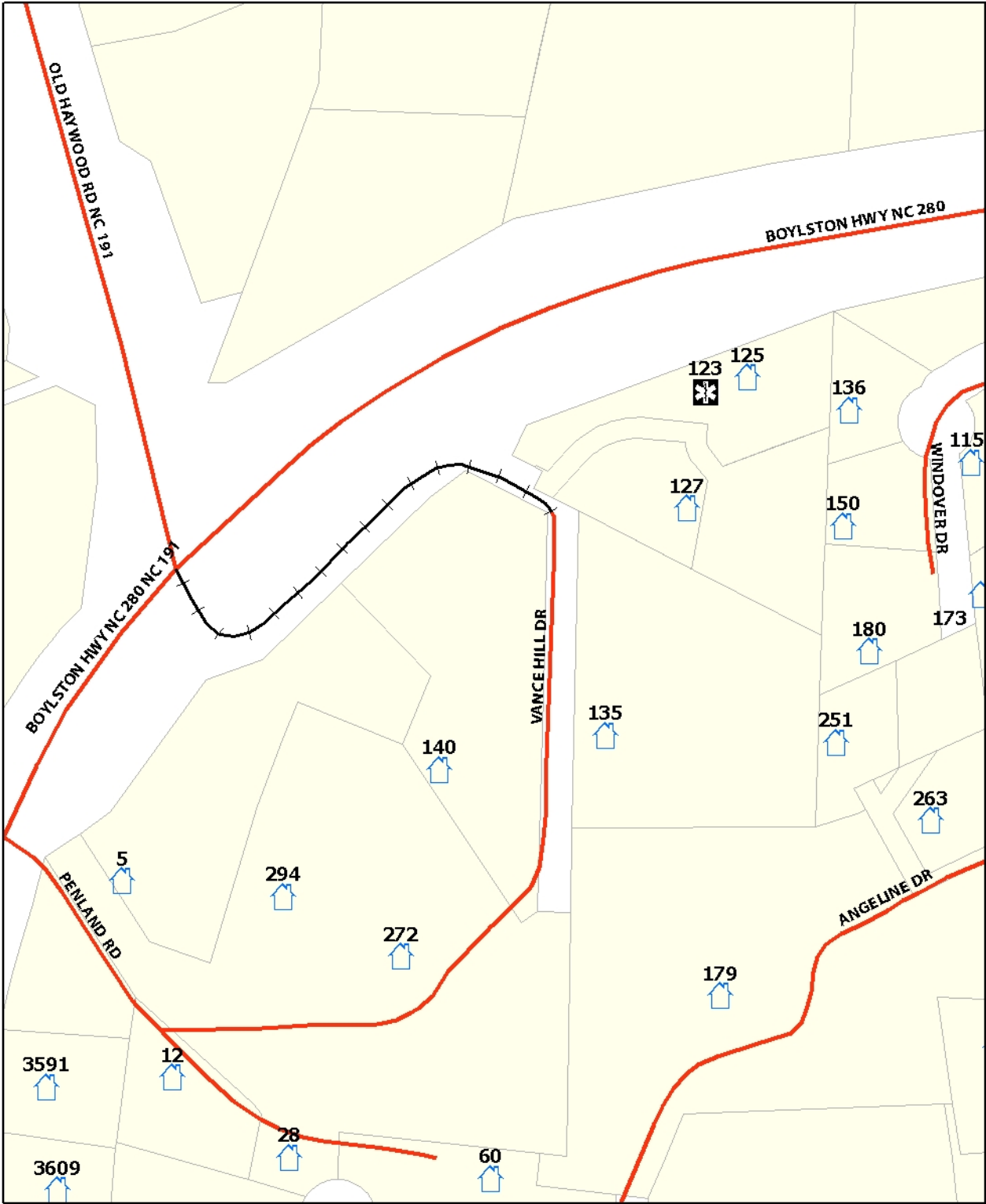
