The Local Emergency Planning Committee has worked on several projects including updating the Emergency Operation Plan and review of the December Ice Storm response.

The LEPC received Hazardous Materials Inventory Reports from sixty six (66) businesses located within the county and incorporated municipalities. These reports are kept on file for emergency planning and public access purposes in accordance with the Emergency Planning and the Community Right-to-Know Act of 1986. The LEPC has received state and national attention for innovative Emergency Planning & Preparedness pertaining to Natural and Technological hazards through the development of the on-line Emergency Operations Plan and implementation of the National Incident Management System county-wide.
