SUBJECT: Extension Request for the Leoni's Mountain Lake Homes
Improvement Guarantee

SUMMARY OF REQUEST:

On July 20, 2005 the Board of Commissioners approved an application for an improvement guarantee for Leoni's Mountain Lake Homes, Planned Unit Development. As required by the performance guarantee agreement for the improvement guarantee, the developer posted with Henderson County an irrevocable letter of credit in the amount of \$82,219.00. The improvement guarantee covered grading, road construction, installation of sidewalks, water system construction and road shoulder stabilization. The original agreement required that the improvements be completed by June 30, 2006.

The Planning Department recently received a letter from Mr. Todd Leoni, owner and developer, requesting to extend the completion date to June 30, 2007. Section 170-39 of the Subdivision Ordinance allows the Board of Commissioners to grant extensions to completion dates for a maximum of one additional year, provided that the time between initiation and completion of the improvements does not exceed two years. If the Board of Commissioners agrees to grant the requested extension, staff has attached for the Board's consideration, a draft performance guarantee agreement. This agreement reflects a new completion date of June 30, 2007 and requires submittal of an amendment to the original irrevocable letter of credit showing an expiration date not earlier than 60 days after the new improvements completion date.

COUNTY MANAGER'S RECOMMENDATION/BOARD ACTION REQUESTED:

The extension, if granted, would not cause the developer to exceed the two-year maximum time period for completion of the required improvements. Therefore, I recommend that the Board approve the request to extend the completion date of the improvement guarantee for Leoni's Mountain Lake Homes to June 30, 2007.

PERFORMANCE GUARANTEE AGREEMENT

COUNTY OF HENDERSON

THIS AGREEMENT made and entered into this _____ day of _____, 200__, by and between Camp Riley, Inc., hereinafter referred to as "Developer," and the Henderson County Board of Commissioners, hereinafter referred to as "Board;"

WITNESSETH:

WHEREAS, the Board and the Developer entered into an Agreement on August 25, 2005 (hereinafter "the original Agreement"), concerning an improvement guarantee for a proposed planned unit development known as Leoni's Mountain Lake Homes, located in Henderson County, North Carolina; and

WHEREAS, the Developer posted with Henderson County an irrevocable letter of credit in the amount of \$82,219.00 in accordance with the original Agreement; and

WHEREAS, the developer obtained approval of a Final Plat from the Henderson County Planning Department on September 7, 2005, and subsequently recorded such Final Plat; and

WHEREAS, the original Agreement provided that all required improvements were to be completed on or before June 30, 2006, and

WHEREAS, the Developer has requested that the Board of Commissioners approve extending the completion date of the original agreement to June 30, 2007;

IT IS THEREFORE AGREED as follows:

1. The Developer will, on or before June 30, 2007 complete as required the following improvements to serve lots in the Project: grading, road construction, installation of sidewalks, water system construction and road shoulder stabilization as required by the Henderson County Subdivision Ordinance, as shown on the Development Plan for the Project approved under Special Use Permit # SP-04-01 by the Henderson County Board of Commissioners on November 10, 2004, and as shown on the attached cost estimates prepared by John B. Jeter, P.E. (sealed 7/5/05 and dated 7/5/05).
2. The Developer will post with Henderson County an amended irrevocable letter of credit guaranteeing completion of said improvements by the required date, and having an expiration date not earlier than 60 days after the completion date stated in Paragraph 1, above.
3. At such time as this Agreement is fully executed and the Developer has filed an amendment to the original letter of credit as provided in Paragraph 2, above, this

Agreement will supercede prior Agreements between the Board and the Developer regarding the improvement guarantee.

4. In the event that the required improvements are completed as required, the irrevocable letter of credit will be released. In the event that the improvements are not completed as required, then the Developer shall be in breach of this Agreement and the Improvement Guarantee and the County shall call the irrevocable letter of credit and use the funds to complete the required improvements.
5. The County Manager shall have the authority to approve the release of portions of the Improvement Guarantee as work progresses, provided the amount remaining under the Improvement Guarantee meets or exceeds 125% of the cost of the remaining improvements. The County Manager has the discretion to require the Developer to provide, at the Developer's expense, an independent verification of the remaining work.

IN WITNESS WHEREOF, the Board has, by appropriate action, caused this Agreement to be reviewed for approval by the County Attorney and executed by its Chairman or other authorized member and attested by the Clerk, and the Developer has caused this Agreement to be properly executed, this the ____ day of _____, 200__.
