SUMMARY OF REQUEST:

Henderson County's FY 2007 budget included \$528,342 for the provision of mental health services. With the closure of Mountain Laurel in October 2006, a number of local agencies submitted grant applications for those funds. At their October 26, 2006 meeting, the Board of Commissioners allocated the majority of those funds, but left a contingency balance which equals \$140,342.

Following the last meeting, Staff sent out funding availability notices and grant applications to the local providers, requesting they formally apply if they wished to be considered for a portion of these remaining funds. The attached matrix outlines which agencies filed applications, what services they provide, how many citizens they will impact and the amount of funding requested. Arthur Carder, CEO of Western Highlands LME, has reviewed this information and provided the following recommendation:
