SUMMARY OF REQUEST:

Henderson County received grants to provide several Emergency Watershed Protection Projects. The Engineering firm of Hobbs, Upchurch, and Associates, P.A. was retained to develop and bid the projects. Bids were received for the Project referred to as the Don Warren Site. The projects are being paid our of grants received by the County and there are no County funds being used in the project.

Two bids were received with the low bid from Hendersonville Equipment Rental and Sales, Inc. at \$55,565 base bid, contingency of \$2,778.25 for a total bid of \$58,343.25. The high bid was at a base bid of \$61,000, contingency at \$3,050 for a total of \$64,050 from Cody-Herve Construction. The proposed work is to address stream bank stabilization along a portion of Clear Creek at Grant Mountain Road. Work will consist of installation of additional rip rap along the waters edge and Gabion Walls to retain the slope. Area is to be regraded and seeded. Staff and the Engineer are recommending that the project be awarded to Hendersonville Equipment Rental Sales, Inc. for \$58,343.25 and that the County Manager be authorized to execute contracts.
