#### **SUMMARY OF REQUEST:**

The Board of Commissioners reviewed the draft implementation schedule for the Edneyville Community Plan at its meeting on August 18, 2010. The Board directed Staff to adjust the proposed target dates on the recreational related recommendations pending the Board's discussion on recreational improvements and allocations. Staff amended the draft implementation schedule to reflect the Board's action at the August 19<sup>th</sup> meeting regarding the recreation projects. **SUBJECT: Update on Edneyville Community Plan Implementation** 

The Board of Commissioners reviewed the draft implementation schedule for the Edneyville Community Plan at its meeting on August 18, 2010. The Board discussed the need to adjust the proposed target dates on the recreational related recommendations pending the Boards discussion on recreational improvements and allocations. At the August 19<sup>th</sup> meeting, the Board approved funding for some construction of the multi-purpose fields at the Edneyville Community Park. Staff amended the draft implementation schedule to reflect the Board's recent action.

The attached and condensed implementation schedule addresses when the components may be completed or studied. Some actual implementation dates cannot be determined at this point until further study is completed. Please remember that the timeline is subject to change as we move through the implementation process. Planning Staff intends to develop an implementation schedule for each individual recommendation and initiate discussions with the applicable agencies, departments, and committees.

Below is a list of the key components in the plan that the Board of Commissioners will address. This information includes a timeframe for when the Board might expect to address or consider each of these recommendations. Please keep in mind that recommendations repeated in all or multiple community plans might warrant deferring action to consider a countywide standard or policy.
