# Attachment to ARTICLES OF AMENDMENT OF THE ARTCLES OF INCORPORATION OF HENDERSON COUNTY HOSPITAL CORPORATION

Pursuant to N.C. Gen. Stat. §55A-10-02, the undersigned sole member of the corporation hereby submits the following Articles of Amendment to its Articles of Incorporation. The amendment is as follows:

1. Article V is amended by striking the second sentence ("There shall be eleven  $(11) \dots$ ") thereof, and inserting in lieu thereof the following sentence:

There shall be twelve (12) voting Trustees, ten (10) Trustees who are not Henderson County Commissioners ("non-BOC Trustees"), and two (2) Trustees who may be a Henderson County Commissioner ("BOC Trustees").

- 2. All references throughout the Articles of Incorporation to "BOC Trustee" shall be amended to read "BOC Trustees".
- 3. Article V is further amended by adding the following sentence to the end of the first paragraph thereof (as previously amended):

In the event that there are two serving members of the Henderson County Board of Commissioners who are serving as voting members of the Board of Directors, the slot for a non-voting member of the Board of Directors who is also a member of the Henderson County Board of Commissioners shall remain unfilled.
