### **SUMMARY OF REQUEST:**

N.C.G.S. 161-11.3 regulates the retention of 10% of the fees collected by the Register of Deeds office. These funds are to be set aside annually in a non-reverting Automation Enhancement and Preservation Fund and are to be used for computer and imaging technology, and document preservation. This fund is a portion of the County's Restricted General Fund Balance.

The Register of Deeds is requesting the Board of Commissioners approve the use of \$45,100 in available funding from the Automation Enhancement and Preservation Fund to pay for the following expenses:

\$27,600 for Contracted Services for annual software maintenance renewal. \$17,500 for Contracted Services for automated electronic backup system for 5 years

Attached for the Board's consideration is a Budget Amendment to use the Register of Deeds Restricted General Fund Balance to pay for software maintenance and to implement the ImageShield System which will offer an offsite backup and 5 years protection of all of our digital images. With the nearing completion of the Phase 1 Digitigation Project, this program will be used to protect over 2.5 million images of our documents.

### **BOARD ACTION REQUESTED:**

The Board is requested to approve the attached Budget Amendment appropriating the funds from the Automation Enhancement and Preservation Fund. No county funds are involved in this request.

#### **Suggested Motion:**

I move the Board of Commissioners approve the attached budget amendment to use \$45,100 in Register of Deeds Restricted General Fund Balance.
