The Register of Deeds Office is constantly working to improve our efficiency and effectiveness in order for us to better serve our citizens. As a result of this, I will be implementing the North Carolina Electronic Birth Registration System (EBRS) which will enable us to interact with the Vital Records Office in Raleigh in a more efficient manner. EBRS will allow us to process Amendments and Legitimations more quickly resulting in a faster resolution to the citizen. It will also enable a citizen born in another North Carolina county to purchase a Certified Copy of their Birth Certificate by coming to our office instead of having to travel to or correspond with the County of their birth.
