CALL TO ORDER/WELCOME

Christopher Todd called the meeting to order and welcomed all in attendance.

APPROVAL OF MINUTES

Upon reviewing the minutes from April 20, 2015 there were no revisions requested. Due to lack of a quorum no vote was made.

DISCUSSION ITEMS
