#### BOARD OF COMMISSIONERS MONDAY, DECEMBER 4, 2017

The Henderson County Board of Commissioners met for a regularly scheduled meeting (Organizational Meeting) at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

#### **CALL TO ORDER/WELCOME**

Attorney Russ Burrell called the organizational meeting to order and welcomed all in attendance.

#### INVOCATION

The invocation was provided by Julie Gordon of the Church of Christian Science.

#### PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the American Flag was led by Matthew King of the Young Naturalists 4-H Club.

#### **ELECTION OF CHAIR**

County Attorney Russ Burrell stated according to Section 153A-39 of the North Carolina General Statutes, on the first regular meeting of this Board during December this Board must select a chairman. The chairman will serve until a successor is elected on the first Monday evening of December in 2018. After the chairman is selected, he will preside over the meeting.

Mr. Burrell opened the floor for nominations.

Commissioner Hawkins nominated Commissioner Mike Edney for chairman.

Hearing no further nominations, Commissioner Hawkins made the motion to close nominations and accept the appointment of Michael Edney as chairman by acclamation. All voted in favor and the motion carried.

The meeting was turned over to Chairman Edney.

#### **ELECTION OF VICE-CHAIR**

Chairman Edney nominated Commissioner Hawkins for vice-chairman.

Hearing no further nominations, Chairman Edney made the motion to close nominations and accept the appointment of Grady Hawkins as vice-chairman. All voted in favor and the motion carried.

#### **PUBLIC HEARING**

Public Hearing regarding Close Out for Habitat for Humanity Dodd Meadows CDBG 2012 N.C. Catalyst Grant (12-C-2469)

Commissioner Messer made the motion to go into public hearing regarding Close Out for Habitat for Humanity Dodd Meadows CDBG 2012 N.C. Catalyst Grant (12-C-2469). All voted in favor and the motion carried.

Planning Director Autumn Radcliff stated Henderson County was awarded the 2012 N.C. Catalyst grant in the amount of \$454,960 on behalf of Henderson County Habitat for Humanity's Dodd Meadows neighborhood located off Crest Road. The Community Development Block Grant (CDBG) funds supported development for moderate and low-income persons in the County. Approximately \$210,600 of the grant funds was used on road improvements; including paving, curbing, and storm water drainage improvements, as well as, public water and sewer extension for a portion of phase two of the Dodd Meadows project. Approximately \$203,000 was used to fund the construction of a community center within the Dodd Meadows development that serves the Dodd Meadows neighborhood as well as the broader community. In addition, 10% of the grant funds were spent on planning and administration costs.

No local match (County funds) was required for this grant. Henderson County Habitat for Humanity had to provide a match of \$790,440 per the grant application, and have provided over 1 million in matching funds for this section of Dodd Meadows.

The NC Department of Commerce requires public hearings as part of its CDBG programs. To complete the grant program, Henderson County is required to hold a close out public hearing to receive public comments concerning the grant prior to completion.

#### **Public Notice:**

The closeout public hearing notice was published in the Hendersonville Times News on Thursday, November 23, 2017, which is within the required time frame of publishing the scheduled hearing.

#### Board action requested:

After holding the closeout hearing to receive public comments, no further action is required by the Board.

#### **Public Input**

1. Chris Berg thanked the Board and staff and noted the new community center will be a great success.

Commissioner Hawkins made the motion to go out of public hearing. All voted in favor and the motion carried.

#### INFORMAL PUBLIC COMMENT

- 1. Chris Walters thanked Tommy Thompson for his 40 years of service. He spoke in regard to separation of religion and state. With the installment of "In God We Trust", which he feels is unconstitutional, he asked the Board not include religious beliefs which he feels undermines others beliefs.
- 2. Jan Partin is concerned that the Ordinance does not include steep slope and ridgetop guidelines. Development of steep slopes and ridgetops can result in landslides and cause problems with emergency vehicle entry.
- 3. Joe Criscione feels steep slopes should be included in the Ordinance as landslides are a serious risk to people and property.
- 4. Susanne Hale is in favor of greenways and would like to see an extension of the greenway from Publix to Erkwood Road. Greenways are great for repeat tourism, health, and the aging population.

The bonds of the officers named in G.S. 58-72-10 shall be carefully examined on the first Monday in December of every year, and if it appears that the security has been impaired, or for any cause become insufficient to cover the amount of money or property or to secure the faithful performance of the duties of the office, then the bond shall be renewed or strengthened, the insufficient security increased within the limits prescribed by law, and the impaired security shall be made good; but no renewal, or strengthening, or additional security shall increase the penalty of said bond beyond the limits prescribed for the term of office.

#### County Financial Report/Cash Balance Report - October 2017

The October 2017 County Financial Report and Cash Balance Report were provided for the Board's review and approval.

- Dues/Non-Profit Contributions Second quarter approved non-profit contribution payments remitted
- Garage Vendor payments and fuel costs to be allocated to user departments
- Rescue Squad Second quarter approved non-profit contribution payments remitted
- Mental Health Second quarter maintenance of effort (MOE) payments to Vaya Health remitted

The YTD deficit in the Edneyville Elementary School, the Hendersonville High School and the Law Enforcement Training Center (LETC) Projects is due to the payment of architect fees for these projects from appropriated fund balance in the Capital Projects Funds that will be reimbursed from future financings.

The YTD deficits in the Recreation Parks Improvements Projects and the Artificial Turf Field Projects is due to these projects being paid from appropriated fund balance in the Capital Projects Fund primarily from proceeds received from the sale of the Bent Creek property as approved in the prior year's budget.

The YTD deficit in the Cane Creek Water & Sewer District Fund is due to final sewer capital project expenditure payments on the Mill Pond Creek Sewer Project, which has been completed. Fund Balance in the Cane Creek Fund was appropriated in the approved budget to cover these capital project expenditures.






#### **Days Cash on Hand**

#### Hendersonville Sanitary Sewer Master Plan

Per the letter from Hendersonville Manager John Connet, the City is requesting the Board of Commissioner's input on their proposed sanitary sewer master plan for the Hendersonville Wastewater Treatment Plant drainage area. Specifically, if they need to modify the plan's scope of work to account for a "comprehensive sewer study for Henderson County" that is a pending item in the County's comprehensive plan (Section 3.7A: Support the development of a countywide sewer and water master plan).

#### Motion:

I move the Board approves the City proceeding with development of a comprehensive sanitary sewer master plan, and to direct Staff to communicate with the City accordingly.

#### Partial tax release - add on

Blue Ridge Humane Society obtained title to two tracts in late 2016. One parcel (10000466) was vacant during 2017, and the other (10000465) was partially used by the Society for tax-exempt purposes. Only property actually used for exempt purposes is not taxed for *ad valorem* property tax purposes. The portion of the property used for tax-exempt purposes is valued as follows:

This amount is out of a total value for parcel 10000465 of \$750,400. It is proposed that a release of obligations for the 2017 tax year be granted for the portion of parcel 10000465 as stated above, and that the status (taxable) for parcel 10000466 be unchanged. Releases for exemption must be granted, if at all, before the end of the tax year. Blue Ridge Humane Society is in agreement with this proposal.

#### Motion:

I move that the Board grant the release of \$223,460 of the value of parcel 10000465 for tax year 2017, as qualifying as exempt from taxation.



# Louise Bailey

Mrs. Bailey was a local historian and author. She penned the column "Along the Ridges" for the Hendersonville Times News for 42 years. Her lasting contribution to Henderson County was leaving a recorded history of our community for generations to come.



# Georgia Bonesteel

Mrs. Bonesteel is an artist and author on quilting. She is a member of the International Community of Quilters and host of her own television program "Lap Quilting" on North Carolina Public Television and PBS. Her lasting contribution to Henderson County was giving recognition and promoting the mountain arts and crafts.



# **Albert Browning**

Mr. Browning began and ran a dairy farm known as
Kalmia Dairy. He went on to become a successful builder
and contractor in our community. His lasting contribution to
Henderson County was his work to establish the
Hendersonville Housing Authority which continues to assist

those in need of housing.



# **Dr. Kenneth Cosgrove**/ Eleanor Cosgrove

Dr. Cosgrove practiced internal medicine with a specialty in heart disease for over 50 cears. His lasting contribution in addition to his medical career included founding the first Pardee Intensive Care Facility, Four Seasons Hospice, Blue Ridge Community, Health Center and Carelina Villago Retirement Home

Mrs. Cosgrove served as Director Emeritus of The Blue Ridge Community College Education Foundation. Her lasting contributions to Henderson County included raising support funds and in leading the change from the Henderson County Technical Institute to The Blue Ridge Community College. She was also instrumental in the formation of the Henderson County League of Woman Voters.



### **Albert Edwards**

Mr. Edwards was Hendersonville's longest serving mayor from 1932-1969. During this time he led our community through the Depression and World War II. His lasting contribution to Henderson County was his support for the building of Pardee Hospital, the construction of Interstate 26, lighting for the city and the creation of an airport.



# **Grace Etheredge**

Mrs. Etheredge was a local artist who taught classes and encouraged art in the Blue Ridge Mountains. Her lasting contribution to Henderson County was the founding of The Art League of Henderson County and helping to found the Opportunity House.



# Frank Ewbank

Mr. Ewbank enlisted in the army in 1942 and after his military service ran a successful insurance business for many years. His lasting contribution was as a member of the Henderson County Board of Education. He also served as a founding trustee of Blue Ridge Community College which continues to educate students of Henderson County today.



# Robroy Farquhar

Mr. Farquhar was a local actor, director, and member of the Professional Actors Union in New York. His lasting contribution to Henderson County was the founding of The Flat Rock Playhouse, the State Theatre of North Carolina, which continue to train actors and entertain people today.



### Josiah Johnson

Mr. Johnson dedicated his life to agriculture and truck farming. His lasting contribution to Henderson County was paving the way for future farmers to grow, sustain and market crops in our community and across the country.



# Robert Morgan

Mr. Morgan is a local author who has written books of poetry, fiction, and non fiction which have brought national attention to our community. His lasting contribution to Henderson County is through his writings on the southern Appalachians, the Green River area and the Blue Ridge mountains. His literary works will influence generations to come.

#### FRENCH BROAD RIVER MPO CORRIDOR STUDIES

Lyuba Zuyeva stated the French Broad River MPO (FBRMPO) has discussed several senarios for setting aside a portion of the MPO budget to fund corridor studies throughout the region on strategic corridors. Issues to consider include the amount of funding available per year, the number of studies to be conducted per year, how the studies should be managed, the selection process, and potential local dues structure. These studies are more for small road congestions not I-26 or I-40.

Commissioner Lapsly noted the FBRMPO members will be voting on a scenerio at their next meeting and this was a chance for the commission to express their opinions. No position is necessary at this meeting, but this will need to be discussed at the budget workshop.

# MUD CREEK GREENWAY FEASIBILITY STUDY – APPLY FOR FRENCH BROAD RIVER MPO PLANNING FUNDS

Autumn Radcliff stated at the request of Commissioner Lapsley and as a result of his recent meetings with NCDOT regarding Kanuga Road improvements, a possible greenway along Mud Creek as been identified from the new Publix to Erkwood Drive. The potential of this greenway has been discussed by the Village of Flat Rock and could provide for alternative cyclist and pedestrian mobility along the Kanuga Road corridor.

The French Broad River MPO (FBRMPO) currently has a call for projects, for greenway planning and feasibility studies. Grant applications are due by December 31<sup>st</sup> and require a 20% local match based on the total project cost and not the requested funding amount. It is anticipated that a feasibility study for this greenway section to cost approximately \$50,000 (requested funding would be \$40,000 and the required local match would be \$10,000). The FBRMPO has approximately \$90,000 for planning and feasibility studies.


It is anticipated this will be a very competive call for projects. It should be noted that this funding would not be available until FY 2019.

Should the Board wish to pursue this project, the Board is requested to authorize County staff to apply for funding from the FBRMPO for a greenway feasibility study along Mud Creek and to submit a commitment letter for the local grant match.



#### French Broad River MPO - Planning Funds

- FBRMPO currently has a call for project for planning funds
- Approximately \$90,000 are available.
- Applications are due December 31st
- Requires a 20% local match based on the total project cost
- Feasibility study for a greenway along this portion of Mud Creek would cost approximately \$50,000
  - Requested funding would be \$40,000
  - Required local match would be \$10,000
- Funding would not be available until FY 2019

Commissioner Lapsley stated he, City Council member Steve Carriker, and Village of Flat Rock Council member John Dockendorf met with NCDOT and discussed issues with the Kanuga Road project. Width of the road was the biggest issue. Lapsley, Carriker and Dockendorf feel the 5 ft. bicycle lanes should be deleted. A potential greenway was discussed to eliminate the bicycle traffic. The NCDOT has no objection.

The location of the greenway was discussed and the possibility of using the sewer lines as the greenway. Commissioner Lapsley feels the County should take the lead in studying the greenway and cost effectiveness. The County could consider taking this on or pass it on to the City.

Commissioner Lapsley made the motion that the Board approve moving forward with the feasibility study, earmarking \$10,000 for the grant match. All voted in favor and the motion carried.

#### **COUNTY MANAGER'S REPORT**

County Manager Steve Wyatt introduced Carlene Dixon, who began as the Parks and Recreation Director on November 27, 2017.
