County Financial Report/Cash Balance Report – October 2014

The October 2014 County Financial Report/Cash Balance Report was provided for the Board’s review and approval.

The following are explanations for departments/programs with higher budget to actual percentages for the month of October:

- Non-Profit Contributions – 2nd quarter approved non-profit contribution payments
- Fire Services – payment of volunteer fire department’s annual worker’s compensation premium
- EMS – purchase order/encumbrance of a new ambulance approved in the FY2015 budget
- Rescue Squad – 2nd quarter approved non-profit contribution payment
- Code Enforcement – professional services for demolition of abandoned manufactured homes to be reimbursed from state AMH grant funds
- Agri-Business – operational costs to be covered/reimbursed from Agri-business membership fees
- Mental Health – payment of 2nd quarter MOE payment to the Smoky Mountain Center
- Non-Departmental – 2nd quarter property and liability insurance expenditures to be allocated out to all departments

The YTD deficit in the CDBG - Dodd Meadows Project Fund is due to the timing difference between the payment of project expenditures and subsequent reimbursement of grant funds from the state.

The YTD deficit in the Immigration and Customs Enforcement (ICE) Fund is due to the timing delay/lag in receiving monthly payments. Federal ICE revenues for October will not be received and posted until December.

The YTD deficit in the 911 Emergency Communications Relocation Project and the Westfeldt Park Project is due to the payment of project expenditures and the subsequent reimbursement of grant funds from the NC 911 Board and the NCDENR – Recreational Trails Grant Program respectively.

The YTD deficit in the Allied Health Education Facility Project budget is due to the payment of architectural fees on the project that will be reimbursed from the proceeds of a future financing for the project in FY2015.

Energy Management Update

An informational report was provided to the Board about the County’s energy management use across all County facilities in the areas of electricity, natural gas, fuel and water. It compares the first FY quarter with previous years to show historical trends in commodity consumption.

Supplementary cost analyses represent the total annual cost percentages (YTD) and the monthly cost profile comparing 2013 and 2014 YTD for the highest-cost commodity at each facility.

Quarterly Construction Project Update

A report was provided for the Board’s review with a quarterly update on County Construction Projects.

Appointment of Deputy Tax Collector

Phyllis Henderson was recommended to be appointed as Delinquent Tax Collector, the position formerly held by Lee King, the new Register of Deeds.

Review of Public Officials’ Bond

Pursuant to N.C. Gen. Stat. §58-72-20 (and the Board’s Rules of Procedure), the next order of business at the Board’s annual organizational meeting is the annual review and approval of the size and issuer of the bonds for county public officials.

Under §58-72-20:

The bonds of the officers named in G.S. 58-72-10 shall be carefully examined on the first Monday in December of every year, and if it appears that the security has been impaired, or for any cause become insufficient to cover the amount of money or property or to secure the faithful performance of the duties of the office, then the bond shall be renewed or strengthened, the insufficient security increased within the limits prescribed by law, and the impaired security shall be made good; but no renewal, or strengthening, or additional security shall increase the penalty of said bond beyond the limits prescribed for the term of office.
