The Henderson County Board of Commissioners met for a regularly scheduled meeting at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

Those present were: Chairman Charlie Messer, Vice-Chairman Tommy Thompson, Commissioner Grady Hawkins, Commissioner Mike Edney, Commissioner Larry Young, County Manager Steve Wyatt, Interim Assistant County Manager David Whitson, Attorney Russ Burrell and Clerk to the Board Teresa Wilson.

CALL TO ORDER/WELCOME

Chairman Messer called the meeting to order and welcomed all in attendance.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the American Flag was led by Shyanne and Star Capps, from the Barnyard Bandits 4-H Club.

PUBLIC HEARING

Public Hearing for Rezoning Application #R-2013-03

Commissioner Young made the motion to go into public hearing for Rezoning Application #R-2013-03. All voted in favor and the motion carried.

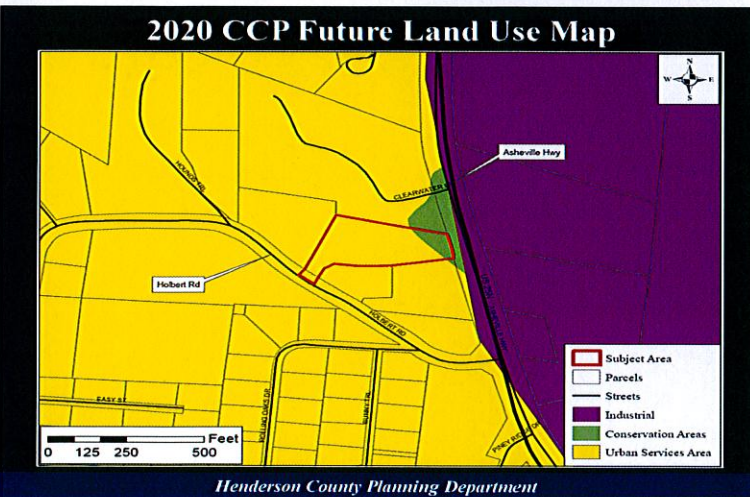
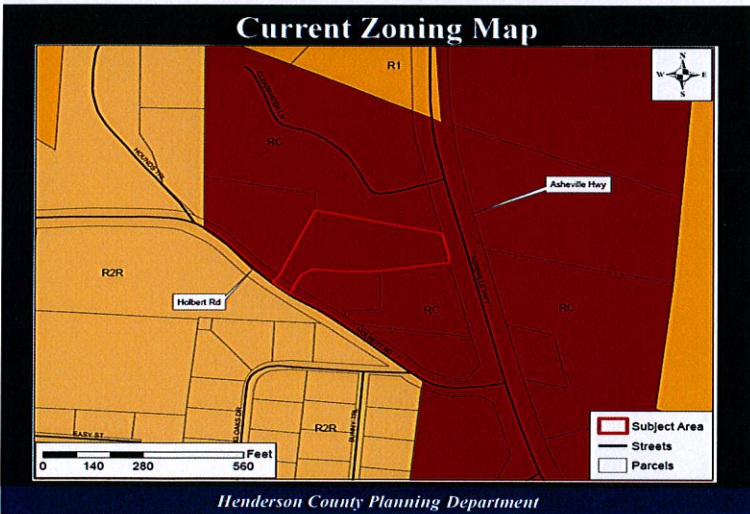
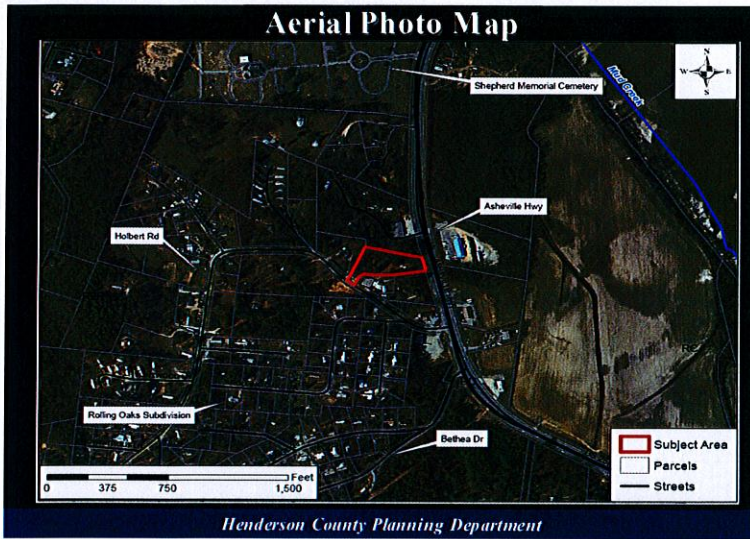
Planner Parker Sloan stated Rezoning Application #R-2013-03, which was submitted on August 6, 2013, requests the County rezone a 1.5 acre tract. The applicant requests a rezoning from a Regional Commercial (RC) to a Residential Two Rural (R2R) zoning district. The subject area is owned by Kerry Bodenheimer (PIN: 9651-52-4024). Mr. Bodenheimer was present at the meeting.

The Henderson County Planning Board considered rezoning application #R-2013-03 at its regularly scheduled meeting on October 17, 2013. During that meeting, the Planning Board voted unanimously to send forward a favorable recommendation on rezoning application #R-2013-03 to rezone the Subject Area to a Residential Two Rural (R2R) zoning district.

Before taking action on the application, the Board of Commissioners must hold a public hearing. In accordance with §200A-314(C) and §200A-337(B) of the Henderson County Land Development Code and State Law, notices of the November 4, 2013, public hearing regarding rezoning application #R-2013-03 were published in the Hendersonville Tribune on October 17, 2013 and October 24, 2013. The Planning Department sent notices of the hearing via first class mail to the owners of properties adjacent to the Subject Area and the subject area property owner on October 18, 2013 and posted signs advertising the hearing on the Subject Area on October 22, 2013.

After holding the required hearing, Planning Staff recommends that the Board of Commissioners approves the application to rezone the Subject Area to a Residential Two Rural (R2R) zoning district. State law requires that the Board adopt a written statement of consistency with the County Comprehensive Plan (CCP). A draft resolution was provided.

Financial Report/Cash Balance Report – September 2013

The September 2013 County Financial Report/Cash Balance Report was provided for the Board’s review and approval.

The following are explanations for departments/programs with higher budget to actual percentages for the month of September:

- Dues/Non-Profits – release of 1st quarter non-profit contribution payments to agencies in July

- Register of Deeds – encumbrance of \$81,883 in July for expenditures to be paid from the Register of Deeds Fund Balance Reserved for Automation Enhancement
- Information Technology – payments made in the first quarter of the fiscal year for various technology maintenance and support contracts for departments approved in the FY2014 budget
- Fire Services – payment of annual fire districts worker’s compensation premium in the first quarter
- Rescue Squad – purchase order encumbered for new ambulance approved in the FY2014 budget
- Mental Health – payment of 50 percent maintenance of effort funding budgeted for FY2014
- Library – new publications purchased for FY2014 are at 34 percent of budget through September
- Recreation – purchase of youth team soccer uniforms for the fall season
- Blue Ridge Community College – monthly operational and capital expense for October was paid at the very end of September causing two monthly payments to be posted to September

The YTD deficit in the Revaluation Reserve Fund is due to a \$23,921 annual payment made early in the fiscal year for enhancements to NCPTS, the County’s ad valorem property tax system.

The YTD deficit in the Emergency Telephone System (911) Fund is due to the final debt service payment (\$107,037.04) being made early in the fiscal year on the 2008 bank loan secured to expand the current Emergency 911 Communications Center.

The YTD deficit in the CDBG – Scattered Site Housing Fund and the Upper Hickory Nut Gorge Project Fund is due to the timing difference between the expenditure of grant funds and subsequent reimbursement from the state.

The YTD deficit in the Immigration and Customs Enforcement (ICE) Fund is due to a timing delay in receiving payments – federal ICE revenues for September will not be received and posted until November 2013.

The YTD deficit in the Solid Waste Landfill Fund is due to operational expenditures running slightly ahead of revenues received through the 1st quarter for the fiscal year.

Motion:

I move that the Board of Commissioners approves the September 2013 County Financial Report and Cash Balance Report as presented.

The Henderson County Public Schools September 2013 Financial Reports were provided for the Board’s information.

Energy Management Update

Megan Piner had provided information to the Board about the County’s energy management use in the areas of electricity, natural gas, fuel and water. It compared the first quarter with previous years to show historical trends.

Proclamation – GIS Day in Henderson County

The Henderson County Information Technology Department requested that the Board adopt a Proclamation designating November 20th, 2013 as GIS Day in Henderson County. In recognition of GIS Day, Henderson County GIS staff will be working on a geography project with a 4H group at the Henderson County Center of

NC Cooperative Extension.

Motion:

I move that the Board adopts the Proclamation designating November 20, 2013 as GIS Day in Henderson County.

EMS Franchise Agreements

Pursuant to the Board's Rules of Order, this is the second reading on the EMS Franchise Agreements, original action taken on October 16, 2013.

Motion:

I move the Board grant a franchise pursuant to Chapter 87 of the Henderson County Code to Gerton Fire & Rescue, Henderson County Rescue Squad, Mills River Fire & Rescue and Arc' Angel Trans-Support Services.

Service Badge and Sidearm Request – Pat Redden and Don Bowen

The Henderson County Sheriff's Office requests that the service badges and side-arms of Pat Redden and Don Bowen be given to them in recognition of their retirements from the Henderson County Sheriff's Office.

Deputy Pat Redden began employment with the Henderson County Sheriff's Office on September 8, 1987. Throughout her career she has worked as a Detention Center Cook, a Detention Officer, a Deputy, a Detective, and Corporal. Deputy Redden has served for a total of 26 years in the Sheriff's Office. She has spent her adult life serving our community and agency with integrity and morals. To honor her and show my gratitude, Sheriff McDonald intends to present her service badge and service sidearm to her.

Sergeant Don Bowen joined the Henderson County Sheriff's Office as a Tele-communicator on December 14, 1994 and held the ranks of Tele-communicator, Deputy, Corporal, and Sergeant. Sergeant Bowen has served 19 years in the field of law enforcement and has spent his adult life serving our community and agency with integrity and morals. To honor him and show my gratitude, Sheriff McDonald intends to present his service badge and service sidearm to him.

Sheriff McDonald makes this request on behalf of the Henderson County Sheriff's Office pursuant to North Carolina General Statute 20-187.2(a).

The Board is requested to allow Sheriff Charles McDonald and the Henderson County Sheriff's Office to present Deputies Pat Redden and Don Bowen with their service badges and side-arms at no charge.

Motion:

I move the Board allow Sheriff Charles McDonald to present these service badges and side-arms as a token of appreciation to Deputies Pat Redden and Don Bowen.

Surplus K-9 Carriers and Patrol Vehicle Cages

A resolution was provided for the Board's consideration declaring a list of K-9 Carriers and Patrol Vehicle Cages provided by the Sheriff's Department no longer used by the County as surplus property. The resolution also authorizes the Purchasing Agent to advertise the surplus property for sale by electronic public auction at www.govdeals.com after the required advertisement of the sale.

K-9 Carriers – 4 portable dog kennels

Patrol Vehicle Cages – 20 Patrol Vehicle Cages with dimensions to accommodate 2007-2010 Dodge Charges only.

Motion:

I move that the Board approves the resolution declaring the list of K-9 Carriers and Patrol Vehicle Cages presented as surplus and authorizes the Purchasing Agent to sell the surplus property by electronic public auction via GovDeals auction services.

Public Records Disposal Request

The Assessor’s staff is requesting approval from the Board of Commissioners to destroy the records listed on the Public Disposal Request and Destruction Logs – three (3) included in accordance with the County’s Record Retention Policy and the provisions of the North Carolina Department of Cultural Resources Records Retention and Disposition Schedule, a copy of said page was provided, as the period of these records have expired, or they have been scanned and retained in said format.

Motion:

I move the Board approves the Public Records Disposal Request and Destruction Log.

Nominations

Chairman Messer noted vacancies and opened the floor for nominations.

Notification of Vacancies

- 1. Henderson County Historic Courthouse Corporation/dba Heritage Museum – 1 vac.
- 2. WCCA Board of Directors (Western Carolina Community Action) – 1 vac.

Nominations

- 1. Hendersonville Planning Board – 1 vac.

Commissioner Young nominated James Thorndike for reappointment to position #1. *Chairman Messer made the motion to accept the reappointment of James Thorndike to position #1 by acclamation. All voted in favor and the motion carried.*

- 2. Juvenile Crime Prevention Council – 6 vac.

Chairman Messer suggested suspending the rules and appointing an individual for position #6 that does not reside in Henderson County. He explained that JCPC is a large council and it is difficult to feel many positions with qualified individuals. He further nominated Jason Robichaud for position #6. *It was the consensus of the Board to suspend the rules for this appointment. Commissioner Thompson made the motion to accept the appointment of Jason Robichaud for position #6 by acclamation. All voted in favor and the motion carried.*

- 3. Mountain Valleys Resource Conservation and Development Program – 1 vac.
There were no nominations at this time so this item was rolled to the next meeting.

- 4. Senior Volunteer Services Advisory Council – 3 vac.
There were no nominations at this time so this item was rolled to the next meeting.

- 5. Smartstart – 1 vac.
There were no nominations at this time so this item was rolled to the next meeting.

RESOLUTION – CONCERNING THE LIMITATION OF VOTING BOARD MEMBERS ON AREA MENTAL HEALTH AUTHORITY BOARDS

Steve Wyatt stated the North Carolina General Assembly recently adopted NCGS §122C-118.1 - Structure of area board. The statute states that “An area board shall have no fewer than 11 and no more than 21 voting members.” Because the newly consolidated Smoky Mountain Mental Health Authority is comprised of 23 member counties, the impact of this statute effectively prevents each county from having the ability to appoint a member to represent their county. The Board is requested to adopt a Resolution, requesting the

General Assembly amend the law, removing the limitation of twenty one (21) members.

To be in compliance with §122C-118.1 at this time however, the Smoky Mountain Center (SMC) Board of Directors must be reconstituted no later than 30 days following the DHHS Secretary's approval of the SMC-WHN Consolidation Agreement. To that end, the SMC Board of Directors has voted to request that each county within the consolidated 23 county catchment area consider and approve the slate of Proposed Board Member Nominations as presented. The slate, if approved, would serve until June, 2014 or January , 2015.

Commissioner Hawkins made the motion that the Board adopts the Resolution requesting that the North Carolina General Assembly amend NCGS §122C-118.1 to remove the limitation of twenty one members and replace that with language allowing each Board of County Commissioners to appoint a representative of their choosing. He further moved the Board approves the slate of proposed Board Members as presented. All voted in favor and the motion carried.

HENDERSON COUNTY PUBLIC SCHOOLS – CONSTRUCTION PROJECT PLANNING

Steve Wyatt stated the FY 2013-2014 Adopted Budget for the Henderson County Public Schools (HCPS) included \$127,343 that was to be utilized to fund a salary increase that had been included in the Governor's budget. That increase however, was not included in the final state budget.

The Henderson County Schools have requested that the Board consider leaving the \$127,343 in the HCPS budget, and redirecting those funds to be used for construction project planning. The funds could be utilized to pay for construction preliminary planning by architects and engineers.

Ervin Bazzle was present and thanked the Board for approving the first step of the process. Plans should be available by January, 2014.

Russ Burrell noted the 9th Avenue road closure application was completed earlier today and presented to the City along with a new survey. The cost of the survey was \$750.

David Whitson stated that RFQ's (Request for Quote) went out several weeks prior with a deadline of November 8, 2013. They will be reviewed over the next couple of weeks and used for preliminary planning.

Commissioner Young made the motion that the Board approves the Henderson County Public Schools request, allowing them to redirect \$127,343 in funding to be used for construction project planning. All voted in favor and the motion carried.

DISCUSSION OF BOARD CHAIR ROTATION

The Board has discussed rotation of the chairmanship. Suggestions for possible ways this can be accomplished will be presented for the Board's consideration.

Attorney Russ Burrell explained that the Board can bend the rules, change to rotation of chairs, or consider the local bill option. This must be done at the first meeting in December, the Organizational Meeting.

Commissioner Edney noted that the Chair position has been rotated in the last three years and can continue without changing legislation.

Commissioner Thompson noted the same and is concerned about it becoming a mandate. If feels the current rules work and there is no reason to change.

Commissioner Young was okay with a legislative change mandating chair rotation. He does feel that a new commissioner should serve at least two years prior to becoming a chairman.

Chairman Messer feels the Board is looking at rotation only, and not the amount of time served.

Commissioner Hawkins was not sure of the intent of rotation, but felt rotation should continue and include all commissioners and all districts.

It was the consensus of the Board to table this discussion item and bring it back before the Board at the mid-month November meeting along with redistricting.

COUNTY MANAGER'S REPORT

There was nothing further at this time.

Commissioner Young updated the Board on the position of Health Director, with Tom Bridges retirement of December 1, 2013. The Board of Health has appointed Betsy Alexander to fill the position of Interim Director until a permanent Director is hired.

Commissioner Hawkins would like to be a part of the agenda meetings. At this time the Chair and Vice-Chair conduct the agenda meetings. Should a third commissioner attend, it would require notification of meetings, and be an open meeting. Commissioner Thompson is willing to not attend the meetings, and allow Commissioner Hawkins to attend in his place. This item will be discussed further at the mid-month November meeting.

COUNTY ATTORNEY'S REPORT

Russ Burrell provided an update on Seven Falls and provided pictures of improvements to roads. He noted four new gates had been installed to prevent four wheelers and other property damage. The site remediation is in good shape, and the Sheriff is patrolling the area. The property owners can now bring in proposals.

CLOSED SESSION

The Board is requested to go into closed session pursuant to N.C. Gen. Stat. §143-318.11(a) for the following reasons:

1. Pursuant to N.C. Gen. Stat. §143-318.11(a)(4) to discuss matters relating to the location or expansion of industries or other businesses in Henderson County, including agreement on a tentative list of economic development incentives that may be offered by the Board in negotiations.

Commissioner Thompson made the motion that the Board go into closed session pursuant to N.C. Gen. Stat. §143-318.11(a)(4) to discuss matters relating to the location or expansion of industries or other businesses in Henderson County. All voted in favor and the motion carried.

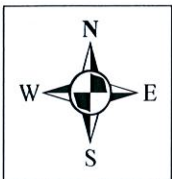
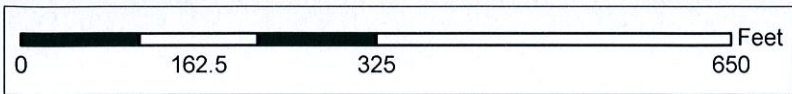

RESOLUTION OF CONSISTENCY WITH THE COUNTY COMPREHENSIVE PLAN

WHEREAS, pursuant to N.C. General Statute §153, Article 18, the Henderson County Board of Commissioners exercises regulations relating to development within the County's jurisdiction; and

WHEREAS, the Henderson County Board of Commissioners (Board) adopted the Land Development Code (LDC) on September 19, 2007 and has amended the LDC to address new and changing issues;

WHEREAS, the Board desires to update and revise the regulations of the LDC; and

WHEREAS, the Planning Director and Planning Board provided recommendations regarding the proposed zoning map amendment with case #R -2013-03; and

WHEREAS, pursuant to N.C. General Statute §153-323, the Planning Director provided the prescribed public notice and the Board held the required public hearing on November 4, 2013; and

WHEREAS, N.C. General Statute §153-341 requires the Board to adopt a statement of consistency with the County Comprehensive Plan (CCP); and

NOW THEREFORE, BE IT RESOLVED by the Henderson County Board of Commissioners as follows:

1. That the Board reviewed the proposed map amendment (#R -2013-03 – Kerry Bodenheimer Rezoning) and finds that it reasonable, in the public interest and it is consistent with the CCP and the Growth Management Strategy located therein; and
2. That the Board determines that the proposed map amendment provides for the sound administration of the LDC while balancing property rights and promoting reasonable growth within the County; and
3. That this Resolution shall be retained in the Office of the Clerk to the Board of Commissioners.





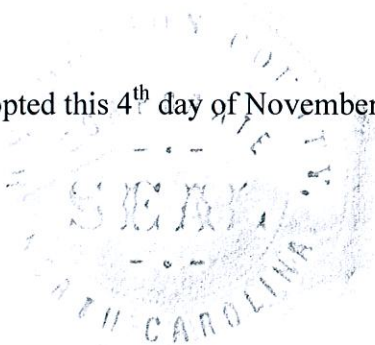

NOW, THEREFORE, BE IT RESOLVED, that the Henderson County Board of Commissioners respectfully requests that the North Carolina General Assembly amend the law to remove the limitation of twenty one members and replace that with language allowing each Board of County Commissioners to appoint a representative of their choosing.
