SUMMARY OF REQUEST:

At their December4, 2006 meeting, the Board of Commissioners reviewed a proposed charter to establish a Blue Ribbon Committee on Illegal Immigration. At that meeting the Board charged staff with bringing back a proposed group of members for the Committee.

The final member may be a citizen at large or an agency representative, at the Board's discretion.
