BOARD OF COMMISSIONERS JUNE 27, 1995

The Henderson County Board of Commissioners met for a Special Called meeting at 5:30 p.m. in the Commissioners' Conference Room of the County Office Building. The purpose of the meeting was a work session on the FY 1995-1996 Budget. This was a continuation of the June 21 mid-month meeting.

Commissioner Edney made the motion that Henderson County shall obtain, at no cost to Henderson County, from the Four Seasons Arts Council and the Hendersonville Symphony, the option to purchase the real property and improvements thereon, currently owned by the City of Hendersonville and located on Grove Street, Hendersonville, Henderson County, North Carolina and further that Henderson County shall exercise the said option to purchase at the time that \$300,000.00 of the funds due to the County from the City of Hendersonville, pursuant to the 1986 Sewer Agreement between Henderson County and the City of Hendersonville, become available to the County.

All voted in favor and the motion carried.

Commissioner Edney made the motion for the Board to go into Closed Session as allowed under N.C.G.S. 143-318.11 for the following:

- 1. (a)(4) to discuss matters relating to the location or expansion of industries or other businesses in the area served by the public body.
- 2. (a)(6) to consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee.

All voted in favor and the motion carried.

Commissioner Edney made the motion for the Board to go out of Closed Session. All voted in favor and the motion carried.
