BOARD OF COMMISSIONERS
NOVEMBER 2, 1992

The Henderson County Board of Commissioners met for a regularly scheduled meeting at 7:00 p.m. in the Commissioners' Conference Room of the Henderson County Office Building.

Those present were: Vice-Chairman Vollie G. Good, Commissioner Hugh D. Randall, Commissioner William McKay, County Manager David F. Thompson, Assistant County Manager/Finance Director David E. Nicholson, Staff Attorney Angela Skerrett and Clerk to the Board Elizabeth W. Corn. Absent were Commissioner F. Richard Baker and County Attorney Don H. Elkins. Chairman J. Michael Edney arrived during Public Hearing # 2.

CALL TO ORDER/WELCOME

Vice-Chairman Good called the meeting to order and welcomed all in attendance.

PLEDGE OF ALLEGIANCE

David Thompson led the pledge to the American Flag.

INVOCATION

Rev. Robert Allred of Wesleyan Methodist Church gave the invocation.

REVIEW OF MINUTES

Minutes of the October 21 and October 26 meetings were presented for review. Minutes were approved as presented.

DISCUSSION/ADJUSTMENT OF AGENDA

There was none.

RECOGNITION OF STEPHANIE GLENN

Vice-Chairman Good informed the Board that Miss Glenn is a student at Flat Rock Junior High School. She recently competed in a State-wide contest that solicited posters with a highway beautification theme. She competed against 800 contestants and her poster won. The Board recognized her achievement. Mr. Good presented her with a single long-stemmed red rose and a county pen. Everyone stood and applauded.

PUBLIC HEARING - Proposed Zoning Amendments

November 2, 1992

Page 2

Commissioner McKay made the motion for the Board to go into Public Hearing to receive public input on the proposed zoning amendments. All voted in favor and the motion carried.

Karen Collins, Planner, reviewed the request by the Kanuga Ridge Property Owner's Association for zoning a previously unzoned area. The area is approximately 368 acres in size, situated along Evans Road in Crab Creek Township including and adjacent to the Kanuga Ridge subdivision. After making slight modifications to the original study area, the Planning Board voted unanimously to recommend that the area be zoned R-40 (low density residential).

The study area contains 93 parcels held by 69 property owners. The petition shows that 40 of the 69 property owners have formally requested the zoning. To date, no opposition to the proposal has been expressed to either the Planning Board or the Planning Department.

In accordance with Section 1204 of the Henderson County Zoning Ordinance, notices of the public hearing scheduled for November 2, 1992, were published in the October 10 and 17 editions of the Times-News. All relevant property owners have also been notified by first class mail. Notices were mailed to 69 property owners within the study area and 17 property owners adjacent to the study area.

Public Input

1. M. Hastings - Mr. Hastings did not wish to speak. Linda Cantrell is his Mother and she came forward. She questioned why they were being considered for zoning. Their property was located on the map and it was determined that they are an adjoining property owner and are not being considered in this zoning issue.

3. Joe Cantrell - Mr. Cantrell did not wish to speak.

4. Lib & William Fellows - Mrs. Fellows spoke in favor of the zoning. She and her husband signed the petition.

5. Bennett J. Sims - Mr. Sims is the original petitioner. Mr. Sims represented the Kanuga Ridge Association and spoke in favor of the zoning.

ACTION

After discussion it was the consensus to postpone a decision especially since there were two Commissioners absent. This will be on the agenda for November 18.

PUBLIC HEARING - Public & Private Road Names

Matt Matteson informed the Board that one of the roads on the list for public hearing is SR# 1333/SR# 1334, otherwise known as Sweetwater Road/Gilreath Loop Road area.

Susan Sneed informed the Board that the list of 84 streets have been properly advertised and posted on or before October 23. There were four streets that the Planning Department requested to be tabled. In addition there were two other streets she requested to be tabled:

1. Ballpark Road (SR 1508) Also known as Balfour Road.
2. Bugleboy Drive.
3. Copeland Drive.
4. River Loop Road (SR 1343, 1344) Also known as River Road and L.L. Moore Road.
5. Robert E. Lee Drive.
6. Talley Road (SR 1191) Also known as River Road and Pleasant Grove Road.

The names of the tabled roads were read aloud several times and numerous people left who had come to speak regarding them. These roads weren't actually tabled but instead action was deferred until a later time.

There were a number of people present who wished to speak regarding Sweetwater Road. The Clerk was instructed to call the names of those who had signed up to speak regarding Sweetwater Road/Gilreath Loop Road.

Input

1. Hal Wininger - Mr. Wininger lives on Sweetwater Road and spoke in favor of the name Sweetwater Road. He stated that it has been known as Sweetwater for so long that everyone knows it by Sweetwater including emergency vehicles.

2. Vincent Lindgrim - Mr. Lindgrim lives on Sweetwater Road and spoke in favor of that name.

3. Robert Herbert - Mr. Herbert lives on Gilreath Loop Road and spoke in favor of that name for the loop, SR#1334.

4-9. Martha Owen, Violet Hall, Mary Alexander, Mary Hendrix, Ellis Parker, Anna Belle Parker - Ms. Owen spoke regarding Sweetwater Road and Gilreath Loop Road. She spoke opposing the name Gilreath but would be in favor of some form of Sweetwater such as Old Sweetwater Road or Sweetwater Loop Road or Old Sweetwater Loop. Several neighbors (as listed) spoke in agreement.

There was some discussion of the recommendation of the Planning Department, naming SR#1334 off SR#1333 Old Sweetwater Road. SR#1333 Sweetwater Road is not recommended for a name change.

5. Joe Gilreath - Mr. Gilreath handed out copies of a Rand McNally insert revised in 1986 which showed Sweetwater Road/Gilreath Loop. He also handed out copies of a D.O.T. map of county roads dated 1/1/90 which shows SR#1333 and SR#1334. He also handed out copies of a letter from D.O.T relative to the paving of SR#1334, Gilreath Road (dated 2/14/91). Stan Pinewar relinquished his time to Joe Gilreath. He spoke in favor of Sweetwater Road and Gilreath Loop.

6. Mark Holbert - Mr. Holbert spoke in favor of Sweetwater Road and Gilreath Loop.

7. Laurie Holbert - Ms. Holbert spoke in favor of Sweetwater Road and Gilreath Loop.

8. Ramon Beas - Mr. Beas spoke in favor of Sweetwater Road.

9. Erma Simmons - Ms. Simmons spoke in favor of Sweetwater Road and Gilreath Loop.

10. Stan Pinewar - Mr. Pinewar spoke in favor of Sweetwater Road and Gilreath Loop.

11. Joe Gilreath again - Mr. Gilreath stated that he would be willing to leave the loop named Gilreath Loop, which would waste approximately one acre of his property.

Discussion followed. David Thompson recommended that the residents be petitioned as to what they want the loop to be named.

Chairman Edney arrived at this time. Vice-Chairman Good called a recess and stated that Chairman Edney would conduct the meeting after the recess.

ACTION

Chairman Edney called for a motion regarding street names.

Commissioner Good made the motion to name SR# 1333 Sweetwater Road. All voted in favor and the motion carried.

All voted in favor and the motion carried.

PUBLIC INPUT

1. Linda Cantrell - Did not speak.

2. Evelyn Nichols - Mrs. Nichols spoke regarding affordable homes. She was opposed to putting trailers or mobile homes in East Flat Rock. She objected to any designation for the Kreckovsky property other than the current R-15. She requested an Affordable Home Board to research affordable homes for everyone and all the alternatives. She also opposes the MR-15 zoning district.

3. Lucy King - Mrs. King protested the continuation of trying to put in an MR-15 zoning designation.

STATUS OF SR# 1333 (Sweetwater Road)

This agenda item was taken care of following the second Public Hearing.

VALLEY HILL 2 FIRE DISTRICT RESOLUTION

Rocky Hyder informed the Board of a petition of the resident freeholders requesting the Board of Commissioners call for an election of qualified voters to vote on the issue of levying and collecting a special tax for the purpose of fire protection in this district. This amount will not exceed 15 cents per \$100 valuation as per General Statute. Mr. Hyder stated that the petition has been reviewed and signatures verified.

N.C. General Statute 69-25.1 requires at least 35% of the "resident freeholders" signatures. We have 49% of signatures of "resident freeholders" on the petition.

Mr. Hyder requested Board approval of the Resolution calling for an election to determine whether a fire response district shall be established and taxed.

David Thompson stated that the election date would be Tuesday, December 29, 1992.

Commissioner McKay made the motion to approve the Resolution as presented setting the election date for December 29, 1992. All voted in favor and the motion carried.

BOND REFERENDUM SURVEY/Blue Ridge Community College

David Thompson reminded the Board that they had previously requested him to draft a letter of endorsement that would not commit the Board or future Boards to funding if the Bond Issue passed for Blue Ridge Community College. In reviewing the forms submitted to the Board previously he recommended that he be allowed to sign off on the forms supplied. He had drafted a letter of endorsement but favored signing the form instead.

By consensus the Board approved the County Manager signing the forms as recommended.

RULES OF PROCEDURE/AGENDA PREPARATION

David Thompson reminded the Board that this item was carried over from the previous meeting so that Commissioners could review these recommended rules and propose any revisions.

Discussion followed. Some minor revisions were suggested. The County Manager was directed to make the minor revisions as suggested.

Commissioner Good made the motion to adopt the rules as presented with the changes suggested. All voted in favor and the motion carried.

MULTIVISION CONSENT REQUEST FOR MANAGEMENT CHANGE

Chairman Edney stated that MultiVision was given a new franchise in 1990. Henderson County received a letter from MultiVision requesting the County Commissioners' consent to allow for a management change from US Cable to CableVision Systems, Inc.

This request has been reviewed by the Cable Review Committee. The Committee voted to recommend on an interim basis to allow for that change. It was decided to retain the services of a professional consultant, especially in light of the fact of the new legislation enacted by Congress. The County has hired Rice, Williams Associates of McLean, Virginia.

A list was received via FAX today from Rice, Williams Association of questions that need to be answered by CableVision before they

will give a recommendation to the Board of Commissioners. The list was given to MultiVisions' representatives present.

Present for MultiVision were Randy Nungester, John Hendrix, Charles Forma, and Kim Morand. Mr. Nungaster and Mr. Forma spoke at length. Mr. Forma is an Attorney for MultiVision and requested a decision posthaste. MultiVision feels that they have supplied enough answers for an immediate response.

MultiVision representatives were requested to respond to the list of questions quickly so that this item will be included in the agenda for November 18 for action. It was also requested that MultiVision contact our consultants personally.

DESIGNATION OF NON-CONFLICTING STATE ROAD NAMES

Matt Matteson informed the Board of a list of 81 non-conflicting road names that have been reviewed for duplication. Mr. Matteson recommended the list for the Board's consideration.

Commissioner Good made the motion to approve the list of non-conflicting road names as presented. All voted in favor and the motion carried.

SET PUBLIC HEARING-Public & Private Road Names

Matt Matteson reminded the Board that pursuant to Section 302 of the Henderson County Property Address Ordinance, a public hearing needs to be called to name or rename both private and public roads in Henderson County. A notice of the hearing will be placed in the Times-News. Once the hearing has been held, the street names may be adopted with whatever changes the Board may wish to make. The list of names will not exceed 100.

Commissioner Good made the motion to set the Public Hearing for December 7, 1992 at 7:00 p.m. here. All voted in favor and the motion carried.

AMENDMENT TO ZONING ORDINANCE-Bed & Breakfast Inns

Matt Matteson informed the Board that at their meeting on October 27, the Henderson County Planning Board reviewed a proposal to allow Bed & Breakfast Inns in residential zoning districts, with conditions. After thorough discussion, the Planning Board unanimously gave the amendment a favorable recommendation.

Matt Matteson submitted the proposal for consideration by the Board of Commissioners. If the Board wishes to set a public hearing on the issue, to meet statutory requirements and in keeping with previous Board policy, the hearing should be scheduled no sooner than Monday, December 7, 1992.

Commissioner Good made the motion to set the Public Hearing for December 7, 1992, at 7:00 p.m. here. All voted in favor and the motion carried.

FORECLOSURE PROCEDURE

Angela Skerrett presented a draft policy and procedure for sale of foreclosed property.

In Section I. Overview of Bid Process - Ms. Skerrett informed the Board that this is written in accordance with the method set out in the statute for letting a taxpayer make an offer and advertising it for a period of ten days and allowing anyone else to make an upset bid. Section I sets out step by step the exact procedures.

Per this policy, if a taxpayer would like to make a bid on any property held by the County they would have to go to the tax office first. The Clerk to the Board is the responsible person for taking the offers and bids per policy. The County Attorney would initiate the process and work with the Clerk to the Board.

If the Board orders sale of property, a quit claim deed would be issued.

Quit Claim Deed - Basically a deed saying that you are giving to the buyer whatever interest that you might have; you are not guaranteeing that they would have a title that would be free from any claims existing.

Ms. Skerrett stated that we do not conduct a full title examination on these properties. It is up to the buyer to do his own research.

David Thompson informed the Board that we have had a problem with foreclosures because the County Attorney could be working on part of it, the Tax Collector's office could be working on part of it, Land Records could be working on part of it, etc.

Discussion followed. Ms. Skerrett was directed to make the revisions as discussed and bring back for the Board's consideration at the November 18 meeting.

TIRE DISPOSAL

Nippy Page stated that for the past two years Henderson County has been collecting tires at the landfill in a trailer that the county owns and hiring to transport those tires to Concord, N.C. In the last fiscal year, Henderson County shipped just over 251 tons of tires at a cost of about \$92 a ton. We presently do not receive any waste reduction credit to haul the tires to Concord because they are monofilled there.

We have received two proposals from companies that have the technology and markets to process used tires, either into a tire derived fuel or a granulated material. Ms. Page recommended a tire disposal contract be awarded to Tires in order to start receiving waste reduction credits and to decrease the cost of handling tires.

Tires will charge Henderson County \$75.00/ton to haul our tires to their facility in Rocky Mount where they will be processed. They will provide a trailer, haul the tires, and guarantee 40% waste reduction credit. They will supply one trailer and have guaranteed a 24 hour turn around.

Commissioner Good made the motion to award a tire disposal contract to Tires. All voted in favor and the motion carried.

EFFECTIVE UTILIZATION OF CURRENT LANDFILL SITE

David Thompson presented the Phase I scope of work Henderson County needs to maximize the useful life of the existing landfill. It is for the expansion of the current landfill through to the closure. He recommended a site utilization study be conducted to determine the most effective way to maximize the useful life of the existing site. This study would include the following:

1. Review of current operation.
2. Updated site plan.
3. Assessment of remaining site soils.
4. Water quality monitoring.
5. Expansion options.
6. Post closure uses.

After this would come a Phase II study which would be actual closure plans for the current landfill site.

Discussion followed. Commissioner McKay made the motion to approve the recommendation of the County Manager. All voted in favor and the motion carried.

TAX REFUND REQUESTS

Robert Baird submitted an accumulation of 21 tax refund requests for the Board's approval. He has reviewed all requests and it is his opinion that the requests are in order. Supporting documentation is on file in his office.

Commissioner Good made the motion to approve the refund requests provided the paperwork is in order. All voted in favor and the motion carried.

TAX RELEASE REQUESTS

Robert Baird submitted an accumulation of 371 tax release requests for the Board's approval. He has reviewed all requests and it is

his opinion that the requests are in order. Supporting documentation is on file in his office.

Commissioner Good made the motion to approve the release requests providing the paperwork is in order. All voted in favor and the motion carried.

REQUEST FOR REMOVAL OF ROOM TAX

David Nicholson informed the Board of a request received from the Woodfield Inn. Their request is based on some confusion between the owner and the lessee of the Inn. The person acquiring the lease was unaware that the owner had not paid the room tax for September. The room tax amounted to \$68.20 penalty.

Discussion followed. Commissioner McKay made the motion to waive the penalty. All voted in favor and the motion carried.

ROAD PETITIONS

Chairman Edney informed the Board of seven road petitions received to be added to the state maintenance system:

1. Meadow Woods Drive
2. Piney Ridge Drive
3. Piney Ridge Court
4. Puma Drive
5. Bethea Drive
6. Viewcrest Drive
7. Wentworth Court

The Planning Department recommends approval of all seven.

Commissioner McKay made the motion to approve the recommendation of the Planning Department and that these be forwarded to N.C. Department of Transportation for their consideration. All voted in favor and the motion carried.

NOTIFICATION OF VACANCIES

Chairman Edney informed the Board of 1 vacancy on the Henderson County Board of Health and 4 vacancies on the Henderson County Travel & Tourism Committee.

EXECUTIVE SESSION

Commissioner Good made the motion for the Board to go into Executive Session as allowed under General Statute 143-118.11 to discuss the following matters:

- A. To discuss a personnel matter.
- B. To discuss the acquisition of real property.
- C. To consult with the County Attorney to the extent that confidentiality is required.

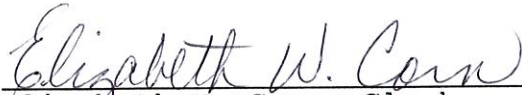
