The Board of Commissioners met at Mountain Home Fire Depart-ment on May 14 at 7:00 p.m. for a Public Hearing.

Present vace Chairman William T. Drake, Vice-Chairman F. Richard Baker, Commissioner Troy L. Maybin, Commissioner J. Michael Edney, County Administrator Jerry D. Myers, and Clerk to the Board Elizabeth W. Corn. Absent was Commissioner Hugh D. Randall, who was on vacation.

Challage Duck) collect the matting to order and opened the Public Hearing. He stated that the purpose of tonight's meeting is to hear public input on expansion of the Mountain Home Fire Tax District to the Hwy. 191 area, this is the western area encompassing Haywood Knolls and Carriage Park. He stated that we are not here to hear public comment on the eastern area or the Clear Creek area tonight.

There were many people in attendance who wished to comment on expansion of the fire district to the Clear Creek area. Chairman Drake informed the crowd that there is a problem with the petition because there is confusion between Dana and Mountain Home. We have received petitions from both fire departments, some of the same people have signed both petitions. He explained that as soon as we work that problem out a public hearing will be scheduled for that area. The General Statutes require that the petition be signed by 2/3 of the property owners of the affected area.

Bob Noble of Haywood Knolls. Mr. Noble asked if there are plans of this department expanding and building a sub-station on 191 in the future? Chairman Drake answered that Mountain Home has no plans of putting a sub-station on 191.

Howard Simpson of Haywood Knolls. Mr. Simpson stated that he is very interested in formal coverage from Mountain Home Fire Department, he is very much for it.

Frank Lee of Haywood Knoils. Mr. Lee favors coverage from Mountain Home Fire Department.

Harvey Nuvall of Haywood Knoils. Mr. Nuvall thanked Chief McCraw for his efforts in trying to get this accomplished. The crowd applauded.

There were approx. 110 in attendance.

Chairman Drake asked if anyone wished to speak in opposition to expanding the Fire Tax District boundaries into this area. No-one came forward.

Chairman Drake closed the Public Hearing and informed the crowd that formal action would be taken at the June 4 meeting before the full Board, concerning tonights meeting on the 191 expansion.
