Types of programs funded include water/sewer infrastructure, and economic development, disaster recovery and neighborhood revitalization. The purpose of this public hearing is to receive citizen input as to the needs of low- and moderate-income residents and neighborhoods within the County. Based on the needs identified, the County may be eligible to apply for CDBG funds to address those needs.
