**Notice of Public Hearing:
Henderson County Applying for a CDBG Neighborhood Revitalization Grant**

The Henderson County Board of Commissioners will hold a public hearing to receive citizen input regarding submittal of a Grant Application to the N.C. Department of Commerce for a Community Development Block Grant (CDBG) Neighborhood Revitalization Program. The public hearing will be held on Wednesday, September 19th, 2018 at 9:00 A.M. in the Board of Commissioners Meeting Room located in the Henderson County Historic Courthouse, at 1 Historic Courthouse Square, Hendersonville, N.C. The public is invited to attend and comment.

Written comments addressed to the Henderson County Board of Commissioners, 1 Historic Courthouse Square, Suite 1, Hendersonville, NC 28792, will be accepted prior to the hearing. Information about the proposed amendment is available for review in the Henderson County Planning Department, 100 N. King Street, Hendersonville, N.C., between the hours of 8:00 A.M. and 4:30 P.M., Monday through Friday, or on the Henderson County Website at www.hendersoncountync.gov. For more information, call the Planning Department at (828) 697-4819.

Each year, the CDBG program provides funding to local governments for hundreds of critically-needed community improvement projects throughout the state to assist with community development projects that serve low- and moderate-income persons. These community improvement projects are administered by Rural Development Division under several grant categories. Types of programs funded include water/sewer infrastructure, and economic development, disaster recovery and neighborhood revitalization. The purpose of this public hearing is to receive citizen input as to the needs of low- and moderate-income residents and neighborhoods within the County. Based on the needs identified, the County may be eligible to apply for CDBG funds to address those needs.

Should the County choose to apply for any CDBG funds during 2018-2019, a second public hearing will be held directly concerning that specific project and application. All facilities are handicapped accessible. All interested persons are invited to attend this hearing. Auxiliary aids will be supplied to the disabled if requested five days prior to the public hearing.
