The Henderson County Board of Commissioners met for a regularly scheduled meeting at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

CALL TO ORDER/WELCOME

Chairman Hawkins called the meeting to order and welcomed all in attendance.

PUBLIC HEARING

2019-01 Consideration of Economic Development Incentives "Project Atlas"

Chairman Hawkins made the motion to go into public hearing for Consideration of Economic Development Incentives for Project Atlas. All voted in favor and the motion carried.

A public hearing has been scheduled on 7 January 2019 in the above matter. The hearing is to consider the request of Project Atlas Company (the "Company") for economic development incentives.

Henderson County Partnership for Economic Development President Brittany Brady stated Project Atlas, is a manufacturing concern located inside and outside the United States (and Henderson County) contemplating expansion at its site in Henderson County.

Under the project as proposed, the public benefit to be derived from the capital project is a total taxable capital investment by Project Atlas of at least \$26,910,000.00 in business personal property (equipment). The project would result in the creation of 68 new jobs, at an average wage of \$47,000, which is in excess of the average wage in Henderson County for full-time employment, plus other benefits. The contemplated incentives would last for a period of five years. The first year's contemplated incentive, if granted, would be not more than \$50,363.80, based on the new investment, the number of new employees, and the Board's incentives guidelines. The maximum amount of incentives to be considered in this grant over the five years would be \$537,575.00.

Fletcher will meet in closed session on January 14, 2019 to consider economic development incentives.

Chris Hykin, President of Operations, stated he feels Fletcher is the right place for this project. This would be the first company to do large projects of RFID Tags. Smartrac bought the company in 2005 and has facilities in Malaysia, China and Fletcher. He thanked the Board for their consideration.








Aerial Map

1. Sherry Brewer is the attorney for the applicant. The owner would like to change the zoning to LC for resale value.

2019-04 Acceptance of North Carolina Governor's Crime Commission Grant Award

The Sheriff's Office is requesting that the Board approve the grant awarded by the North Carolina Governor's Crime Commission. The grant application was submitted under the Crime Victims' Services Committee VAWA (Violence against Women Act) funding Priority. This is a grant that is currently being used to fund the Victims Assistance Coordinator that is staffed within the Sheriff's Office. This grant requires no match from Henderson County.

Motion:

I move the Board of Commissioners approves the grant awarded by the North Carolina Governor's Crime Commission for the Victims Assistance Liaison staffed within the Sheriff's Office.

Replacing K-9 Truck for a Durango

The Sheriff's Office is requesting that the Board approve the Sheriff's Office to replace the 2019 Dodge Ram 1500 K-9 Truck approved in the FY 2018-19 budget with a 2019 Dodge Durango.

Based upon the prevailing supervisor of the K-9 units training, knowledge and experience using this style truck instead of another vehicle will decrease the in-service lifetime of the K-9. The prolonged exiting and entry from a higher profile vehicle will lead to back and hip problems of the K-9 thus decreasing their service life by years. Furthermore, Shallow Creek Kennels a leading NAPWDA (North American Police Work Dog Association) K-9 company that specializes in the breeding, importing and training of these K-9's recommends that we do not use a truck for the above reasons.

The estimated total cost to include the 2019 Durango, patrol vehicle equipment, K-9 equipment and installation is around \$40,827.00. This is \$658.00 above the 2019 Dodge Ram that was currently budgeted. There are currently enough funds available within our Capital Outlay-Vehicle Line Item (115431-553000) to cover this increase in price.

Motion:

I move the Board of Commissioners approve the Sheriff's Office to replace the 2019 Dodge Ram 1500 K-9 Truck with the 2019 Dodge Durango K-9 vehicle.

2019-05 Requests for exemption of property

The tax office has received two requests for exemption of real property for ad valorem tax purposes after the

January 7, 2019

deadline for the tax office to be able to grant such exemptions (the listing deadline). Both are from local congregations, and both detail the reasons for not making application by the statutory deadline.

Under N.C. Gen. Stat. §105-282.1(a1):

Upon a showing of good cause by the applicant for failure to make a timely application, an application for exemption or exclusion filed after the close of the listing period may be approved by the . . . board of county commissioners

Both of the applications show statements which your Tax Office would, if they were empowered by the General Statutes to decide such matters, find to constitute "good cause" for allowing late filing in these cases.

Use of the Courtroom - Henderson County Bar Association

A request has been submitted on behalf of the Henderson County Bar Association for use of the Courtroom on Saturday, February 2, 2019 from 3:00 p.m. until 8:00 p.m. This request is being made on a day that is outside of normal business hours and therefore there will be a charge of \$125.00.

Property Tax Collection

NCGS 160A-461 authorizes cities in North Carolina to contract with the county for the provision of their city property tax billing and collection, and to reimburse the county for those services. This practice has become relatively common across the state, and the County has been approached by the Town of Laurel Park and the City of Hendersonville regarding the possibility of the County collecting their municipal property taxes.

County staff, including the Tax Administrator and Finance Director, have discussed the request, and have found no issues associated with either the billing or collection, or transmission of receipts to the municipalities.

Motion:

I move the Board authorizes Staff to proceed with development of an Interlocal Agreement for Tax Collection with interested municipalities, with a reimbursement rate sufficient to cover the county's cost for those services, subject to final approval by the Board.

2019-07 Replacement K-9 Purchase - Budget Amendment - pulled for discussion

The Sheriff's Office is requesting that the Board approve the Sheriff's Office purchase a replacement K-9 unit for our retiring K-9 unit Maik.

Based upon the prevailing supervisor of the K-9 units training, knowledge and experience it is recommended that K-9 Maik be retired from this agency. K-9 Maik has recently exhibited behaviors towards his handler

that place the handler at risk and the department at a very high degree of liability. These behaviors could be the result of a medical, neurological or training issue that we will not be able to correct with our current staff.

The estimated cost of the replacement K-9 unit will be \$8,500.00. These funds are available to us within the Department of Justice (DOJ) Asset Forfeiture revenue (114431-451005) line as indicated on the attached Budget Amendment.

Commissioner Mike Edney stated the basic request is to use Federal Asset Forfeiture money to replace a K-9. He has no particular issue with that. He issue is long standing concerning how the law enforcement folks seize money and account for it. Commissioner Edney would like to make sure that procedurally the Board of Commissioners are following the Statutes. Taking advantage of the new Sheriff he feels this is a good time to make a new start to look at procedures. Mr. Edney requests that staff either work internally with the County Sheriff's attorney and our audit staff or his preference is to have an external audit person involved as well to give an objective, preview of the Statutes, and how they are being applied.

Chairman Hawkins made the motion that the Board of Commissioners approve the Sheriff's Office to use the available DOJ Asset Forfeiture funds currently available to purchase a replacement K-9 Unit, and direct and County Manager to contract with an independent audit firm to insure we are in compliance with the applicable laws. All voted in favor and the motion carried.

Sheriff Griffin stated the Sheriff's Office is audited by the Federal agencies annually. They have three different account. Two of the accounts are actually asset forfeiture and the third account is the North Carolina controlled substance abuse tax. Typically the Department of Treasury (Homeland Security) account includes assets that have controls and processes in place by the Federal agencies. He is open to the audit and welcomes the opportunity to have the accounts looked at, but feels there are already processes and procedures in place from both Federal and State authorities.

Ms. Erica Brown stated the Comprehensive Annual Financial Report (CAFR) and Compliance Letters have received final approval from the Local Government Commission (LGC) as required. The final report will be placed on the County's website for the public to view and in the main branch of the public library.

It is an unmodified opinion and clean opinion. Director Samantha Reynolds and all of the finance staff were well prepared and cooperative.

We work year round with your finance office. Although you might only see us once or twice a year, we are in constant contact with the finance office. Ms. Brown suggested the Board review the Management discussion and analysis which is located at the front of the audited financials. The MD&A gives a great summary of what occurred in FY 2018, reasons for

increases and decreases as well as a look forward to the FY 2019 FY budget.

Commissioner Lapsley thanked the auditors for all of the work done. This audit is a snap shot in time, as the finances change day to day, and is required of this Board once per year. It is a very thick report, includes a lot of good information, and will be available on-line for the public. The County Finance Department staff put a lot of time and effort into the report.

The \$3,489,711 change in Fund Balance is one year of about 11 years in a row that we as a county has been fortunate to have an addition to our Fund Balance. In his mind it raises the question, do we need to take a closer look at "When is the Fund Balance enough?" This will be discussed in budget discussions next week.

In order to balance the budget each fiscal year, we must appropriate monies from the Fund Balance. During this particular year the amount appropriated was \$12,755,853. This is telling the public that we are predicting more expenses than we are revenues so we must dip into our savings account. However we did not do this and the \$12,755,853 went to zero. This happened from two areas: significant revenue variances; Ad Valorem Tax was up \$2.7m, and Sales Tax revenues were up \$5.6m from what was budgeted; and Sales and Services was up \$1m above what was budgeted. To be fair, there are certain regulations that the State requires us to use in the budgeting process, we must use an experience number that we have proven to collect. This provides a very conservative number on the revenue side. On the other side of the ledger in expenditures, we estimate on the high side to be conservative so that we don't have any huge surprises.

When you look at this from his perspective, through the budget experience last year, there were two categories that jumped out at him. On the expenditure side they were significantly lower than what we had projected in the budget. One was in public safety where we were \$2m less in expenditures. In Human Services we were \$4.3m below what our projected expenditures actually were. A big part of those savings were from lapsed salaries, where a number of positions were not filled. As this Board goes into budget discussions Commissioner Lapsley would like for staff to look at this and see if in fact those expenditures identified in the budget in Public Safety and Human Services should in fact be lowered.

In this report, if you look at the General Fund Balance, there is a history for the last ten years. The increase is a good thing. Discussions and expenditures related to Hendersonville High School have been a topic of discussion for some time. In this report it clearly states that last fiscal year the County spent \$1.8m on school capital projects that were not anticipated and funded by a loan. If this Board had not spent that \$1.8m, in his view, on the Hendersonville High School project, that \$1.8m would have also been added to the General Fund.

Mr. Lapsley asked in next year's report that more information on County investments be included. It would be in the public's best interest if we were more transparent in how \$58m was invested.

He noted in last month's meeting his disappointment that this report takes such a long time to get to us. Here we are six months into the next fiscal year. The world does not come to an end because we did not have it two months ago. It does however put this Board into an awkward position to be six months into our next fiscal year before we can see how we did last year. Mr. Lapsley requested that staff do whatever needs to be done for next year's audit to try to get it a month or two earlier.

Commissioner Edney stated he would take part of the blame for the delay in the audit. A Chairman's letter that is sent out for signature each year, and it was sent in on June 12th. He was busy handling his daughter's heart transplant that day. It fell through the crack and was not picked up again until mid-November. It was part of the delay in the final product.

COUNCIL ON AGING – AGING REPORT

Trina Stokes, Executive Director, stated in February, 2008, the Board of Commissioners designated the Council on Aging as the lead planning agency for older adults in Henderson County. Trina Stokes provided the Board of Commissioners with a brief update on that plan.

The Council on Aging began a multi-year plan when they became the lead planning agency. The plans are used to educate the Home and Community Care Block Grant Advisory Committee, and help make decisions.

We must plan for the 65+ population. Henderson County is in the top 10% of North Carolina's 65+ population. One of three of Henderson County residents will be over 65 in the next three years.

The five core areas of concern are:

- 1. Access to information
- 2. Transportation
- 3. In-home support services
- 4. Housing
- 5. Opportunity for Socialization

WALK OF FAME COMMITTEE - UPDATE

Ronnie Pepper, with the Walk of Fame Steering Committee, updated the Board on the current Walk of Fame activities. He thanked the Board for their support and provided the seven inductees for the year.

- 1) Daniel Gibson was a local banker in Hendersonville, NC for decades. During this time he was active with The Flat Rock Playhouse, the Lions Club, the American Legion, the Blue Ridge College Foundation, the Daniel Boone Council of Boy Scouts, Hendersonville Symphony Orchestra, and served as President of the Apple Festival and Chamber of Commerce. His lasting contribution to Henderson County was the instrumental role he played in the founding Carolina Village which today houses over 250 residents.
- 2) Hugh Randall was an educator who served as Superintendent of the Henderson County Public Schools. He also served in the Navy during World War II and was a local farmer. His lasting contribution to Henderson County were the facilities he constructed including Bruce Drysdale Elementary School, Hendersonville Middle School, and both the Gymnasium and vocational buildings at Hendersonville High School, all are which in still operation today. In addition he instituted full time librarians in each school, high school assistant principals and migrant camp summer schools for children and adults.
- 3) W.A. Smith began his law practice in Hendersonville in 1876. He constructed Fifth Avenue at his own expense, opened the Laurel Park Railroad Company (known as the Dummy Line) which carried residents of Hendersonville, down 5th Avenue to a lake and dance pavilion which he had developed in Laurel Park and was instrumental in the building of the Toxaway Railway. His lasting contribution was his work in the development of Laurel Park.
- 4) Erle Stillwell was an architect and visionary in Hendersonville, NC. He was a leader in the consolidation of schools in Henderson County. His many architectural designs include the Colonial Revival home on the corner of west 5th Avenue and Hendersonville High School. His lasting contribution are the many churches, homes and banks which still stand in Hendersonville as well as statewide military hospitals, college buildings manufacturing plants and over 70 movie theaters.

- 5) George Wilkins was an educator and author in Hendersonville. He fought in both the Korean War and World War II. While he oversaw the integration of schools during the Civil Rights Movement and fought for laws to benefit handicapped students his lasting contribution was his fight to provide public kindergarten for all children which continues today in all 23 elementary schools in Henderson County.
- 6) Harley Blackwell was a leader in agriculture in Henderson County for decades. During his time as Superintendent of the Mountain Horticultural Crops research Station in Fletcher, Mr. Blackwell brought in industries such as Van Wingerden International, Bolton Greenhouses and Carolina Roses. His lasting contribution was bringing NCSU resources and services to Henderson County to assist with modern agricultural practices which continues to help farmers and consumers of farm products in western North Carolina.
- 7) Col. Sidney Vance Pickens fought as a member of the Confederate Army and later became an attorney in Hendersonville, N.C. He founded the Hendersonville Street Car Company and the French Broad Steamboat Company. The steamboat, the Mountain Lily, was designed to link Hendersonville, Asheville and Brevard and could accommodate 100 passengers. These and other transportation projects were in advance of his times. His lasting contribution was the organization of the first Bar Association in North Carolina in 1883 from which the present association arose.

Mr. Pepper thanked the Board and invited the Board to a banquet which will be held in May.


RESTROOM FACILITIES AT ETOWAH PARK AND JACKSON PARK


Carleen Dixon, Recreation Director provided the following information:

Etowah Park:

Currently, the park has one restroom facility that has 3 water closets and 1 urinal. The capacity of this restroom facility was overloaded at the first tournament hosted and we have been renting portable restrooms ever since to accommodate these tournaments.









Jackson Park:

We have 6 fields located in one section of the park and 4 of these fields have close access to restrooms however, fields 6 and 7 do not. The addition of a restroom facility in the proposed location would provide fields 6 and 7 with greater restroom access and safer access for parents who are watching one child play while another needs to get to the facilities. It would expand our overall capacity to host large tournaments and events in the park.



Commissioner Messer prefers option #3 for Etowah and action needs to be taken now.

Chairman Hawkins noted the number one priority is more restrooms and timing is the main issue. The portable units are very nice and the bathrooms currently there are ADA Compliant. We could order three mobile units for half of the cost. He feels the fee schedule for the tournaments should also be addressed, looking at other counties for reference.

Commissioner Lapsley suggests ordering two mobile units and see how they work. If they do not take care of the need we look at permanent.

The life of the portables was discussed and County Manager Steve Wyatt stated they are warranted but due to movement he feels 10-12 years would be a close calculation.

John Mitchell stated the vendor is confinent enough with the product that they will buy the units back. There is also a grant possibility with the Tourism Development Authority.

Beth Cardin, Executive Director of the Tourism Development Authority shared information on the grant possibilities with the commissioners.

Commissioner Lapsley suggested pouring concrete pads with small unit underground to hold capacity.

Commissioner Edney made the motion that the Board authorize staff to purchase two (2) portable units. All voted in favor and the motion carried.

Commissioner Edney made the motion that the Board direct staff to proceed with a detailed study with concrete numbers from vendors and in-house for option #3 in Etowah and bring it back to the Board at the next meeting. All voted in favor and the motion carried.

Steve Wyatt noted that without hesitation the County will apply for the grant. The Tourism Development Authority helped the City with their restrooms and we will ask for the same.

WINTER STORM DIEGO - UPDATE

Jimmy Brissie, Emergency Management Director, updated the Board on the impacts of the storm, and areas that have potential improvement in dealing with future events. Mr. Brissie stated during December 2018, Henderson County was impacted by 18"+ of snow in areas as a result of Winter Storm Diego. Due to the widespread power outages and impacts to travel associated with this storm, the EOC was activated and an emergency shelter opened.

Mr. Brissie thanked the Board for their commitment to Public Safety. He also thanked the other partners for their support including the Fire Departments, Law Enforcement Officers, County Staff, hospitals, 991, School Boards, and Blue Ridge Community College (in many cases will house Duke Power as a staging area). The coordination between NCDOT and Duke Energy was wonderful. This event went much better than it could have because the community was prepared for the storm, it lessened the impact.

Emergency Operations Center Activation

- Good collaboration of Emergency Management/EMS/Fire Marshal/Rescue Squad
- New Facility worked great (At one point there were approximately 30-40 people staying there including the National Guard Unit)

The facility was a tremendous benefit to the community. It enhanced our ability to assist and coordinate resources.

Highlight Emergency Services Responses (15 total)

• 911 Communications Calls for Service (for a 4 day period)

- Law Enforcement Officers 758 calls
- Fire Departments 319 calls
- o EMS 141 calls

Fire - Rescue

- Extra staffing provided by Fire Departments
- NC National Guard Supplemented with transportation needs with 7 personnel from the 211th Military Police in East Flat Rock.
- o Edneyville Fire Department assisted other districts with their 2.5 Ton truck
- o HC Rescue Squad had a Mountain Rescue Team available for access to remote areas

Health & Medical

- o EMS used three 4WD ambulances from HCRS
- o One thing for everyone to realize is all calls take longer. What is typically 5 minutes may take 30 minutes.
- Two facilities had challenges with power 1 Skilled Nursing Facility, 1 residence for Individuals with Functional Disabilities.
 - Both of the above facilities were able to get power restored before the situation became critical, but this did emphasis the importance of emergency planning for every facility

Sheltering

- When deciding on a shelter we have some benchmarks to watch; power outages, trends, geographic area involved
- Sunday AM we met that threshold, after consultation with County Manager we decided to open the shelter
- o NCDOT and Facility Services did great job with snow removal.
- Henderson County Sheriff's Department provided transportation, and the Sheriff assisted with a food run (total of 58 escorts), Planning Staff also available
 - Total of 12 people came through the shelter at East Henderson High School

Areas for Improvement

- o Individual and family preparedness for the community is a must.
- 4WD Ambulances HCEMS has two more on order, this will place 6 in the County. We run 10 ambulances during the day between EMS and Rescue.
- Emergency Planning for Facilities there are 100 total facilities in the County required to have Emergency Plans representing 1,794 beds (not including hospitals). Effective 2017 these facilities are required to exercise their plans annually by the Center for Medicare Services. Emergency Services would like to participate more in these exercises to make sure we are prepared.

Shelters

- o HC relies on American Red Cross for serving as the Shelter Lead Agency, but they do rely on a volunteer workforce.
- Without the Department of Social Services and Public Health it would not be possible, need additional training and depth of staff availability.
- Need to have additional food contingency plans in place.
- o Bring the Gym at the Athletic & Activity Center Online as a Shelter
 - Shelters at schools has worked out well in the past but as we start to look at shelter openings on a sunny day, it creates challenges since they are still trying to operate as a school.
 - We control the Athletic & Activity Center, we already have staff and logistics in place. We currently have 25 facilities on our shelter list. Most of them are schools, some of them are churches.

Power to Critical County Facilities has been identified in our Hazard Mitigation Plan. Some of our county facilities, for instance the gymnasium, could be utilized as a shelter but we would want to get emergency

power in place, and have a generators available. We do have some portable generators that we are able to move around but shelters typically have to be wired for that. Not all the schools are on 100% generator power. At one of our shelters, First Baptist Church, we have a large transfer switch where we can hook up our portable generator. The Historic Courthouse and the King Street building need to have adequate generator power. The Emergency Services Center is at 100% on generator power along with the Law Enforcement Center and the Detention Center.

COUNTY MANAGER'S REPORT

County Manager Steve Wyatt reminded the Board of the Budget Retreat on January 16, 2019, subject to weather. This meeting will be budget planning and the draft agenda reflects a full day. Next year is the reevaluation cycle so we will be looking at several years. If at the end of the day on the 16th we find that we are not finished, it is possible to continue at the first meeting in February.

- 1. That the Board reviewed the proposed map amendment (#R-2018-03 Tracy Grove Community Development Club) and finds that it is reasonable, in the public interest and it is consistent with the CCP and the Growth Management Strategy located therein; and
- 2. That the Board determines that the proposed map amendment provides for the sound administration of the LDC while balancing property rights and promoting reasonable growth within the County; and
- 3. That this Resolution shall be retained in the Office of the Clerk to the Board of Commissioners.


