SUMMARY OF REQUEST:

The City of Hendersonville has requested that the County comment on two proposed water line extensions in Cummings Cove Subdivision. The project would serve 34 lots in Cummings Cove Villas and 28 lots in Phase 9. Cummings Cove Villas is proposed to be served by a 6" water line with a length of 1,750 linear feet. Phase 9 is proposed to be served by a 6" water line with a length of 1,192 linear feet. The existing subdivision's residential structures and amenities are already served by the City of Hendersonville water. The project's location within the Rural/Urban Transition Area is consistent with the Henderson County Comprehensive Plan.

The Planning Board approved the revised master and development plan on June 22, 2018.



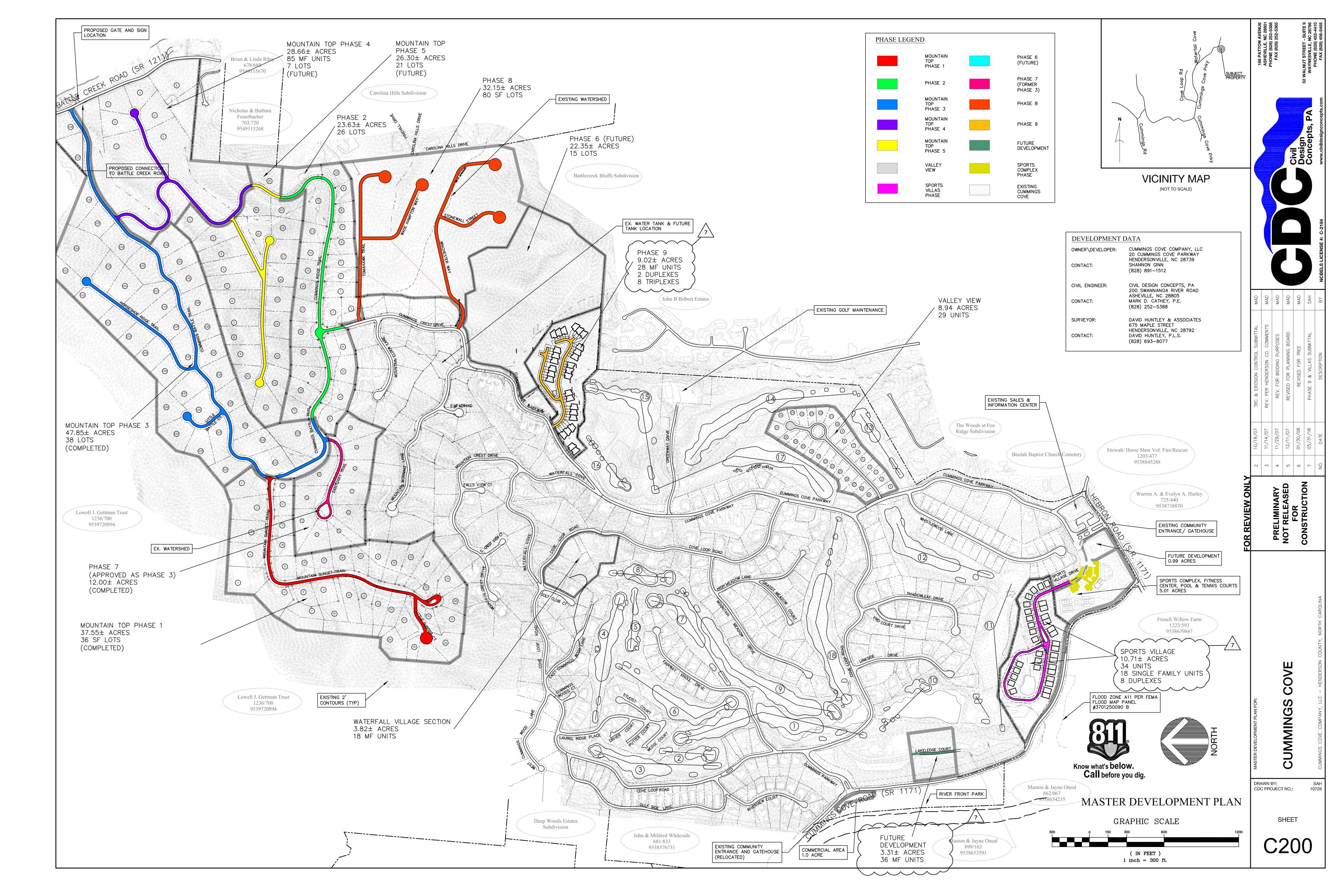



Water Line Expansion Request Cummings Cove Major Subdivision




