The Henderson County Board of Commissioners met for a regularly scheduled meeting at 9:00 a.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

CALL TO ORDER/WELCOME

Chairman Hawkins called the meeting to order and welcomed all in attendance.

INVOCATION

The invocation was provided by John Mason of Main Street Baptist Church.

PUBLIC HEARING

Public Hearing for Notice of Intent to Exchange Public Property

Chairman Hawkins made the motion to go into public hearing. All voted in favor and the motion carried.

Pursuant to N.C.G.S. §160A-271, Henderson County proposes to exchange the following described 0.19-acre portion of the Hendersonville Elementary School property for the consideration described below, said portion being described as follows:

Being a portion of those lands, easements, privileges, and appurtenances as described in and conveyed by that deed dated the 28th day of December, 2009, from the Henderson County Board of Public Education to the County of Henderson, as recorded in the Office of the Register of Deeds for Henderson County, North Carolina, in Deed Book 1417 at page 233. The said property is depicted on a survey plat to be recorded upon completion of the exchange, and is more particularly described on the said plat as follows:

Being the "Recombination Parcel 0.19 Acre" as shown on that preliminary plat by survey dated April, 2019 by Hill and Associates Surveyors, PA, drawing #2019019, and being described thereon as follows: BEGINNING at an existing u-post, the same being a point located in the northern boundary of the property described in the deed referenced above and being the southwestern corner of the property of Thomas F. Ramer, as described in Deed Book 742, page 041 in the Office of the Register of Deeds for Henderson County; thence a new divisional line, South 03°46'14" West, 40.78 feet to a #4 rebar set; thence a divisional line North 82°26'54" East 232.81 feet to a #4 rebar set; thence a divisional line North 11°49'37" East, passing an existing u-post at 2.06 feet, whole distance 14.42 feet to an existing bent axle, the same being the southeastern corner of the Ramer tract as described above; thence with the southern boundary of the Ramer tract, North 83°59'52"

West 133.64 feet to a point; thence South 79°36'47" West, passing a point in the center line of a proposed 20-foot wide easement for a sewer line at 56.07 feet, whole distance 99.79 feet the point of BEGINNING. Being and containing 0.19 acres, more or less.

In consideration whereof, the County shall receive the proposed 20-foot wide easement for a sewer line as shown on the plat referenced above, more particularly described as follows:

Being an easement for the construction, maintenance, and replacement of a sanitary sewer line, and for ingress, egress, and regress across the property of Thomas F. Ramer, described Deed Book 742, page 041 in the Office of the Register of Deeds for Henderson County, being 20 feet in width and centered on a line described as follows:

Beginning at a point in the second divisional line described above, and runs thence North 38°39'44" West 49.23 feet to a point, said point being located North 79°36'47" East 43.72 feet from an existing u-post, formerly the southwestern corner of the Ramer tract; runs thence on the same bearing North 38°38'44" West, 10.19 feet to a point; thence North 09°41'11" West 136.01 feet to a point at the intersection of the southern margin of Forest Hill Drive, a public street, and an existing asphalt driveway, said point further being the location of a sanitary sewer manhole.

The estimated value of the parcel of property that the County is to receive as above described is at least \$22,800.00. The estimated value of the parcel of property that Thomas F. Ramer and wife Brenda J. Ramer are to receive as above described is \$22,800.00.

583 Piney Ridge Drive chronic public nuisance cleanup

Staff requests the Board determine whether it wishes County funded cleanup to proceed under §153A-140.2, which allows the "expense of the action to become a lien upon the property . . . collected as unpaid taxes." Note that the quote does not include any incidental costs of "site preparation" as noted in the bid.




MORE POWERFUL NC

RENAMING OF THE ASHEVILLE METROPOLITAN STATISTICAL AREA

Brittany Brady of the Partnership for Economic Development, stated Henderson County Partnership for Economic Development, the City of Hendersonville and Henderson County would like to establish itself as a "principal city" in the Asheville MSA. Doing so would substantially increase the visibility of both the City of Hendersonville and Henderson County, and enhance the competitiveness for future economic development and further promote tourism activity in Henderson County.


Criteria for identifying principal cities is established by the US Office of Management and Budget. The most recent criteria, established in the Federal Register, Standards for Delineating Metropolitan and Micropolitan Statistical Areas Vol. 75 No. 123; June 28, 2010 in Section 5. Identification of Principal Cities Criteria, provides scenarios in which a city or place can qualify.

The 2010 Standards for Delineating Metropolitan and Micropolitan Statistical Areas, note that that the time is appropriate to petition the US Office of Management & Budget (OMB) to consider Hendersonville's request to attain principal city designation, as the US Census Bureau prepares to conduct the 2020 Census.

The Plan

 In December, the OMB will release the Federal Register call with which have the updated guidelines for MSA naming standards.

- These will be followed by a questionnaire for community feedback. The OMB is aware that there are issues with MSA naming standards.
- There is a 3-year window during which the OMB will rework the changes. That window begins January 1, 2020 when all community feedback must be on the President's desk.
- The OMB reworked the naming standards in the last 2 Federal Register updates (2000 and 2010) to provide for multiple layers and sizes, this opened up the possibility for changes.
- Our contact with OMB is going to make note of our petition with the NC Planners and NC Data Listserve groups, and speak with Census officials at a meeting in September to get additional feedback. A resolution may be advantageous to go along with this petition.
- We have already informed Representative Chuck McGrady and Senator Chuck Edwards of our efforts. Will be meeting with Rep. Johnson in September.
- Additional outreach to Congressman Meadows, Senator Burr and Senator Tillis is forthcoming.

BLUE RIDGE COMMUNITY COLLEGE PROPOSAL

John Mitchell stated Blue Ridge Community College is proceeding with plans to add additional classroom space on its campus. The Board of Commissioners approved a conceptual plan in the FY 19/20 budget planning process and directed that planning for the project continue.

Currently, the construction budget for the proposed project is \$20,110,400. The total project budget for the new facility and the renovation to the Patton Building is \$23,000,000. Additionally, the POPAT (Police Officers Physical Abilities Test) building is proposed to be constructed concurrently with the new facility and renovations to Patton. The construction budget for the POPAT project is \$867,000 and the total project costs is \$1,000,000.

The proposed fees are 6% of the construction budgets: New Facility + Patton Building renovations \$1,206,000 and POPAT \$52,000. The work is proposed to be completed in the spring of 2022.

Commissioner Messer made the motion that the Board accept the contract with Clark Nessen for Blue Ridge Community College. All voted in favor and the motion carried.

JOINT SCHOOL FACILITIES COMMITTEE UPDATE

The Joint School Facilities Committee met Friday, August 9, 2019 and reviewed Henderson County Public Schools Facilities Maintenance and Repair, Technology and Security Initiative Projects for FY19/20 and FY 20/21. Vice-Chairman Lapsley and Commissioner Edney provided an update from that meeting. The School Board asked that projects be shifted in order to utilize funding appropriately.

Commissioner Lapsley made the motion that the Board approves the changes to the school facilities planned projects as outlined. All voted in favor and the motion carried.

UPDATE ON PENDING ISSUES

Items listed for discussion include current and ongoing items of interest in the County, and allow commissioners and staff an opportunity to bring the full Board up to date on issues that occur between meetings. Commissioners may also use this opportunity to report on related committee work and assignments.

Topics for this meeting are as follows:

Construction Projects Update

John Mitchell provided an update to the Board of Commissioners on the status of current construction projects.

Hendersonville High School

Early summer work on GMP #1 is on schedule and on budget (\$1,351,490). Vannoy, PFA Architects and Henderson County Public Schools continue to work together. The Vocational building renovations into a temporary cafeteria is complete, and Henderson County Health Department has signed off. All sewer and storm water work in Oakland Street and Bearcat Boulevard are complete. All asphalt patching and the resurfacing of Bearcat Boulevard was completed yesterday. The final grading and sodding of the students common area around the Stillwell Building was also completed yesterday. Street line stripping is being completed today. The new generator and transformer pad, retaining wall surround between the gym and the track is complete. Staff will begin working on the punch list the remainder of the week. We will make scheduled completion by Friday, August 23, 2019. The scoreboard and lights at the football field have been checked and are ready for a football game. NCDOT requested a meeting that is scheduled for this afternoon at 2:00 p.m. to further discuss the planned parking lot driveway entrance and possible other work at the Five Points intersection.

Edneyville Elementary

The project is on schedule and on budget, with permanent power planned for September 5, 2019. The exterior walls are closed in including brick, decorative panels, and glass. September 18th is the anticipated date for start-up of the HVAC system for operational checks and to condition the building space for flooring installs. Substantial completion is still projected by November 13. Furniture has been ordered and personnel will begin move in on November 14. The Septic tank modifications are a part of Beverly Grant/Barnhill's site contractor, Tennoca, scope. That work was bid and awarded to local company, Allison Contractors, and they have ordered the required tanks and should start work in a couple of weeks (\$135,000).

Flat Rock/Rugby HVAC

Joe Capitan of Delta Engineering is continuing the design work for the system repairs and replacements (\$250,850). Staff plans to bid the work around October 15 – November 1.

DSS Renovation of future space

Cooper Construction was chosen as the Design/Build contractor and we expect to receive a proposal in the next week.

Blue Ridge Community College - new building construction

We have received the contract proposal from Clark Nexsen. Staff has contracted with Holmes Surveying to provide the necessary survey with expected completion by 120 days, between June 27 and October 20. Project completion by September 27 to the BRCC Board, which is well before the October 20 deadline.

1995 Courthouse Skylights

The Kowlwall system was previously reported at a cost of \$65,000 - \$70,000, the same system as now in the Main Library. With this system, the demolition requires extensive scaffolding which could add an additional \$30,000 to the overall cost. However, an advantage is that the work can be done relatively quickly over several weeks. Compared to the removal and replacement of the existing skylights to replace all gaskets at an estimated cost of \$93,000 plus flashings, gutters, contingency at an estimated cost of \$60,000. The project totaling \$150,000 and requiring much more time to perform than the Kowlwall system.

A turnkey all-in proposal has been requested from the Kowlwall system folks, and will be shared with the commissioners for direction once received.

Commissioner Edney reminded staff that the Kowlwall system does not allow as much light into the 1995 Courthouse. Additional lighting will be necessary.

Etowah Park Restrooms

Dunlap Construction is proceeding (\$87,850) with work. The demolition is complete with a new slab in place and masonry walls completed.

The Henderson County Health Department has approved the Brooks Engineering design (\$7,280) for the upgrades required to the septic system. Dunlap Construction will price this work as a change order to his contract. Originally the cost was estimated at \$27,500. If the estimate falls in line, the total cost for the project will be \$122,630.

JACKSON PARK SOCCER FIELDS

Carleen Dixon stated at the June 3, 2019 meeting the Board directed staff to provide a cost to rehabilitate the Jackson Park Recreational Soccer Fields.

Jackson Park Soccer Fields Update

Step 1: Install irrigation and controllers for entire soccer area	\$ 59,895.00
Step 2: Turfplane 4.5 acres at 4" depth for (2) passes creating a smooth playing surface	\$ 39,704.00
Step 3: Springs to renovate the field	\$ 16,250.00

Carleen Dixon stated there is no way to do the Jackson Park project until next May since soccer officially begins in 2 weeks. Flooding will continue in the area, but the surface will be better. Artificial turf could be installed but will not fix the flooding problem and could not be ready in two weeks either.

Commissioner Messer suggested utilizing the turf fields for the younger kids and let the older kids use Jackson Park. We need to look for better land for the fields.

AAC Turf Field Changes

Step 1: Extend existing masonry wall

\$127,085.00

Step 2: Install perimeter 4x4 treated timber to attach to turf

Step 3: Install approximately 400 ft. of 4 inch perforated field drainage pipe in trenches

Step 4: Install approximately 10,000 sq. ft. of artificial turf and fill

Commissioner McCall made the motion that the Board approves moving forward with the turf field changes at the AAC turf field, and further approve a budget amendment to appropriate the necessary funds from the Capital Reserve Fund. The motion passed 4-1 with Commissioner Messer voting nay.

PROPOSED RENTAL AGREEMENT - JACKSON PARK HOUSE

Carlene Dixon stated Hola Community Arts approached the Parks and Recreation Department with an interest in sharing space at the Jackson Park House for their base operation and to host cultural arts events. They have since this time been working on the proposal.

Adriana Chavela and Ron Stamey are the co-founders of Hola Community Arts where they created an innovative social enterprise that gives critical voice to the diversity of our community. Through strategic programs that celebrate cultural diversity with related educational and outreach activities, they bring people together to build stronger and more economically vibrant communities.


Hola Community Arts received a grant from the Community Foundation of Henderson County with the plan to work towards establishing a Cultural Arts Center to be professionally managed by the Community Foundation.

Parks and Recreation has worked with Hola Community Arts for many years and they have always been great partners.

Chairman Hawkins made the motion that the Board authorizes staff to develop a one year lease agreement with details of the lease, and the option to renew at the end of the year for a determined timeframe, after a published notice and a resolution adopted, on 30 days' notice, by the Board of commissioners under GS 160A-272. All voted in favor and the motion carried.


KUNZ FARM PARK

Christine Brown stated in 1996, 27.82 acres of land was donated to the Community Foundation of Henderson County by the Cadgene family and subsequently deeded to Henderson County. As stipulated in the donation, the property adjacent to Broadpointe Industrial Park and the French Broad River, was to be developed into a community park or designated for outdoor recreation.



On July 20, 2016, the concept of the Kunz Farm Project was introduced to the Board, and during the October 1, 2018 meeting, an agreement with McGill and Associates was approved to analyze the construction and cost of the first two phases. Phase 1 has been defined as the planning and engineering phase for the second phase which consists of additional parking at Westfeldt Park and a pedestrian bridge from Westfeldt to Kunz Farm Park over the French Board River. The third phase of the park includes construction of a Riverwalk along the property.






McGill's analysis, completed in May 2019, provided staff with the two most feasible options: bridge location from Westfeldt Park (Option 1) and an alternate access from Old Fanning Bridge Road (Option 2).

Option 1: Westfeldt Pedestrian Bridge:

Proceed with the construction of the Pedestrian Bridge from Westfeldt Park to Kunz Farm Park. The total cost of Phase 1 and Phase 2 is \$1,155,000 with secured funding of \$550,000, including the county's match toward the DEQ Water Resources Development (WRD) grant and local sponsorship. The bridge would be an architectural feature that highlights our parks and county. It also provides a grand bike and ADA accessible pedestrian entrance to Henderson County and supports recreational fishing off the bridge. The project would have plenty of parking and connects to multiple proposed greenways on the desired side of the river. Additional funding sources include pursing sponsorships and applying for a one-year extension to the WRD grant so the county can apply for a PARTF grant next spring.





Option 2: Old Fanning Bridge Road Access:

Proceed with alternative access off Old Fanning Bridge Rd to Kunz Farm Park property. The alternate access includes a parking lot with a stone trail and a culvert crossing over McDowell Creek. The total cost for Phase 1 and 2 is \$340,300.00 with secured funding of \$50,000 in local sponsorship. Unfortunately, this option significantly deviates from the project DEQ originally reviewed and is ineligible for the Water Resources Development grant, requiring staff to terminate the grant contract. This option would also require a formal agreement from NCSU from their main office. NCSU is aware of this potential project and has given staff verbal approval.

Option 2 - Old Fanning Bridge Road

- Construction of a parking lot and trail off Old Fanning Bridge Road to Kunz Farm Park
- Phase 1 & 2 estimated cost: \$340,300
- Secured funding: \$50,000

Suicide is high amongst EMS responders, and by investing in this program, the Board has imbedded counselors in our team as a resource. Recognition of the issue, incredible work by staff, and investing has made a difference. This information will be shared with other counties.
