The Henderson County Board of Commissioners met for a regularly scheduled meeting at 5:30 p.m. in the Commissioners' Meeting Room of the Historic Courthouse on Main Street, Hendersonville.

CALL TO ORDER/WELCOME

Chairman Hawkins called the meeting to order and welcomed all in attendance.

INVOCATION

The invocation was provided by County Manager Steve Wyatt.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the American Flag was led by the Fernleaf 4-H Club.

2019.73 RESOLUTION – SERVICE BADGE AND SIDEARM REQUEST – MASTER DEPUTY LORIE LEVI – ADD ON

Sheriff Lowell Griffin stated the Henderson County Sheriff's Office requests that the service badge and sidearm of Master Deputy Lorie Levi be given to her in recognition of her retirement from the Henderson County Sheriff's Office.

Master Deputy Lorie Levi began employment with the Henderson County Sheriff's Office on August 1, 1988 through December 4, 1994 and returned to employment with the Henderson County Sheriff's Office on October 2, 2001 and held the ranks of Detention Officer, Deputy, Senior Deputy, Master Deputy, and Corporal. Master Deputy Levi has served for over 24 years in the Sheriff's Office. She has spent her adult life serving our community and agency. To honor her and show my gratitude, the Sheriff's Office intends to present her service badge and service sidearm to her.

Sheriff Lowell S. Griffin makes this request on behalf of the Henderson County Sheriff's Office pursuant to North Carolina General Statute 20-187.2(a).

Chairman Hawkins made the motion that the Board allow Sheriff Lowell S. Griffin to present the service badge and sidearm as a token of appreciation to Master Deputy Lorie Levi. All voted in favor and the motion carried.

2019.74 RESOLUTION – 2019 CONSTITUTION

Chairman Hawkins stated September 17, 2019 marks the two hundred and thirty-second anniversary of the drafting of the Constitution of the United States of America by the Constitutional Convention. Henderson County asks our citizens to reaffirm the ideals the Framers of the Constitution had in 1787.

Approved: September 18, 2019

Chairman Hawkins read the Resolution aloud.

Chairman Hawkins made the motion that the Board adopt the Resolution designating September 17, 2019 to September 23, 2019 as Constitution Week in Henderson County and further moved the Board approve placement of a banner in recognition of Constitution Week at the Historic Courthouse. All voted in favor and the motion carried.

PUBLIC HEARINGS

2019. Conditional Rezoning Application #R-2019-03-C, Blue Ridge Gemstone Mine Educational Park
Chairman Hawkins made the motion to go into public hearing. All voted in favor and the motion carried.

Eric Warren stated Rezoning request R-2019-03-C was initiated on May 13, 2019 by Meyer Banz. The application requests Henderson County to rezone approximately 5.82 acres from Residential Two Rural (R2R) to Local Commercial Conditional District (LC-CD). The acreage is contained in one parcel (PIN: 9588-07-2064). The property owners are Philip & Ann Botnick.

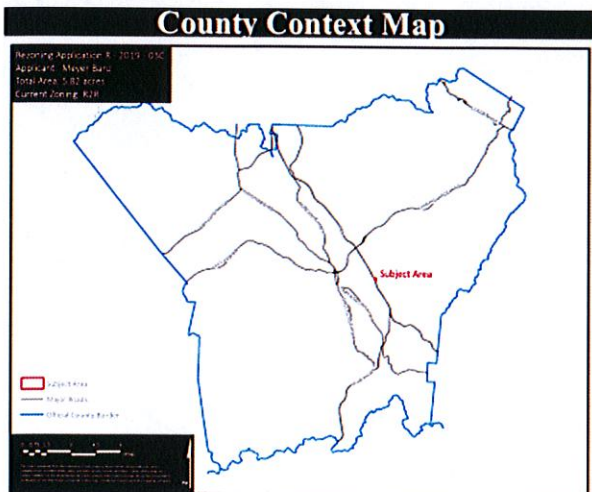
The applicant is proposing a Gem Mining and Educational Park facility with a 6,336 sq. ft. Office/showroom, and two recreational gem mining flumes. The site plan shows the building, parking lot, walking trails, flumes, and other amenities proposed. Conditional rezoning allows for the Board of Commissioners to place conditions on the property to address community concerns and make the proposed development compatible with adjacent uses.

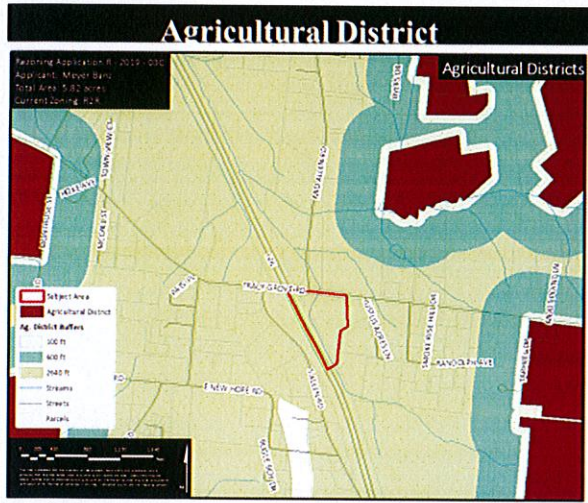
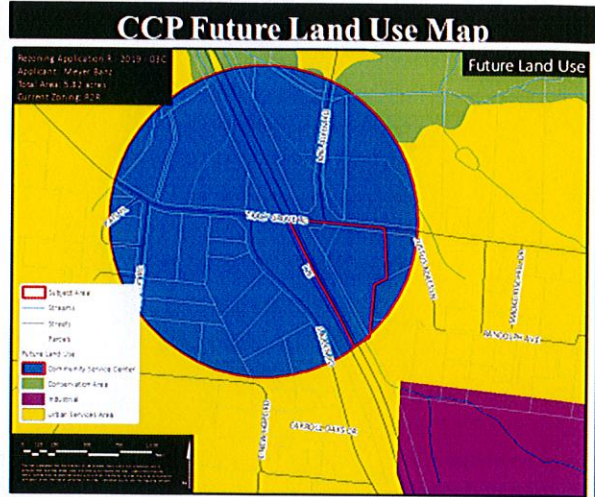
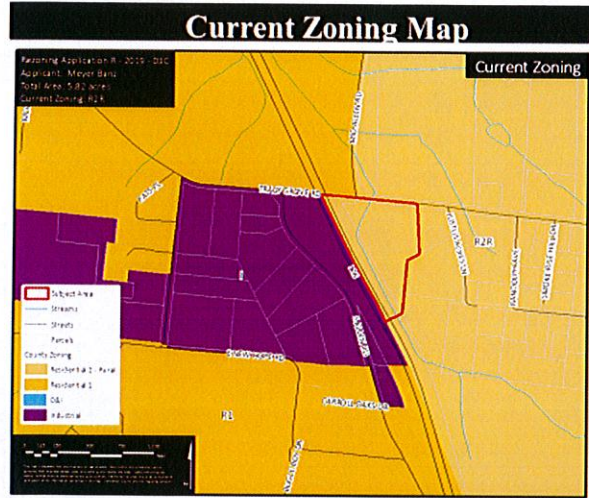
The Technical Review Committee (TRC) reviewed the application on July 2, 2019 and forward the rezoning request to the Planning Board with conditions listed in the staff report.

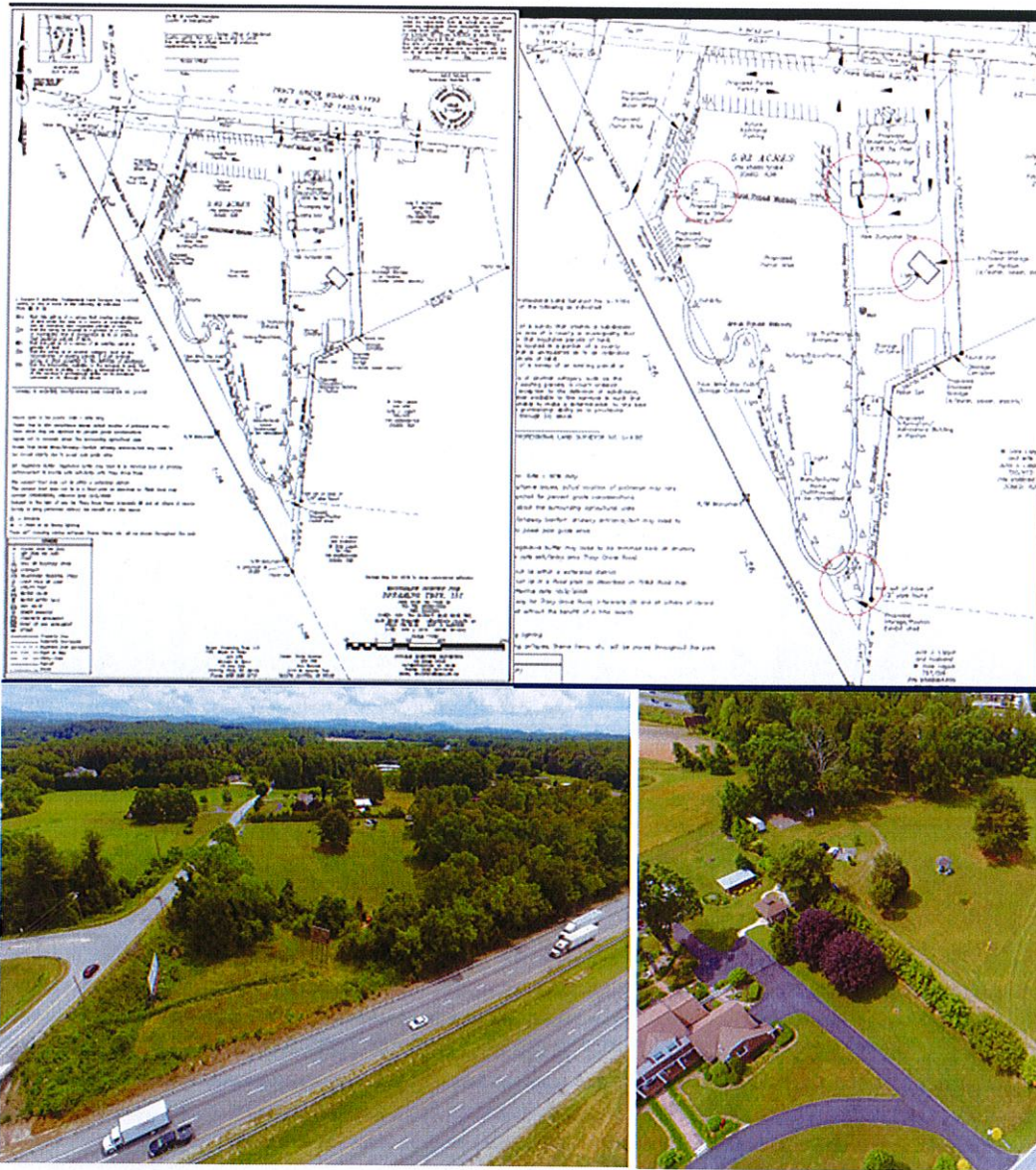
The Planning Board reviewed the rezoning request at its July 18, 2019 meeting. At that meeting the Planning Board recommended conditions addressing hours of operation, buffering, dumpster location, acknowledgment of farmland protection, lighting mitigation, and concerns for adjacent property owner. After discussion, a motion to forward a favorable recommendation with conditions was passed with a 6-1 vote. The site plan included with the agenda has been revised to show the conditions mentioned at the Planning Board meeting.

Public Notice:

Before taking action on the application, the Board of Commissioners must hold a public hearing. In accordance with §42A-303 and §42A-346 (C) of the Henderson County Land Development Code and State Law, notice of the September 3, 2019 public hearing regarding rezoning application #R-2019-03-C was published in the Hendersonville Lightning on August 21st and August 28th. The Planning Department sent notices of the hearing via first class mail to the owners of properties within 400 feet of the Subject Area on August 19, 2019 and posted signs advertising the hearing on August 20, 2019.







Recommended Conditions

Hours of Operation: The Planning Board recommends limiting hours of operation from 9:00am to 6:00 pm as a condition of approval.

- **Street Trees:** Street trees shall be placed adjacent to Tracy Grove Rd. to improve aesthetics and street buffering. Street trees shall be placed following NCDOT guidelines for sight triangles for public roads.
- **Farmland Protection:** Applicant shall sign an acknowledgment of nearby farmland and farm operations and will waive rights to any nuisance complaints for agricultural uses.
- **Dumpster Relocation:** The dumpster shall be moved away from the eastern property line that his shared by Judy McCracken.
- **Lighting Mitigation:** Lighting mitigation shall be installed in accordance with county code to ensure that lighting on the subject area does not project onto adjacent properties.
- **Adjacent Neighbor Protection:** Applicant shall provide proper protections to adjacent owner, Judy McCracken, from any adverse effects of the proposed use.

Public Input

1. Curtis Newman Jr. lives across the street from the property and is against the rezoning. He had provided a petition to the Board with 233 signatures against the project. Their concerns are traffic, speeders and accidents.
2. Anitra Newman lives across the street from the property and is against commercial zoning in a residential area. She feels this area is for family and farming.
3. Cindy Dorn does not want to see a Gem Mine in a residential area. It is a country atmosphere and not right for commercial zoning. She is opposed to the rezoning.
4. Dennis Dorn agreed with the first three speakers and feels commercial should be on the other side of the interstate. He is opposed to the rezoning due to traffic concerns and adverse effects on property values.
5. Madena Dixon is in favor of the rezoning and feels the Gem Mine would be a great educational opportunity.
6. Judy McCracken feels she is the most impacted adjacent property owner. Her concerns are decrease in property values, noise, and traffic. She is against the rezoning as it does not fit in the residential area.
7. Brian Gulden is an attorney for the speakers against the project. He feels the Statutes are against this rezoning as spot zoning and it is not compatible with residential zoning.
8. Lucy Paterson is against the rezoning and concerned with safety of the traffic and a decrease in property values.
9. Heidi Upton lives adjacent to the McCracken property. She is in favor of the rezoning and feels it will buffer them from I-26.
10. Nathan Upton feels there are many other things that could be and have been on the property while zoned as residential. He is in favor of the rezoning. Mr. Upton wishes to remain as a good neighbor.
11. Jill Loggins feels this is a great option for the land use and is in favor of the rezoning. The applicant will be a good neighbor.
12. Juanita Williams would like for the zoning to remain residential.
13. Faye Harrington would like for the zoning to remain residential.
14. Debbie Roundtree feels the Gem Mine would be a great educational opportunity and is in favor of the rezoning.
15. A. J. Ball is concerned about traffic, safety, and how the community will be impacted.
16. Dan Loggins feels with the previous RV Park the property declined. Restrictive commercial zoning is a wise use for the property and he is in favor of the rezoning. The Gem Mine will be good neighbors and an improvement.
17. Applicant Matt Bantz has been in business for 30 years in Rock Gem and Mining. He has met with most adjacent property owners and shared the plan for the business. He feels it is best to be transparent. The Gem Mine will be fun, educational, and a unique experience for everyone. There will be a nature trail, water tower, water wheel, and flume mine. He will retain the beauty of the property and it will blend well in the neighborhood. He asked the Board to please approve the project.

Chairman Hawkins questioned waste water. Mr. Bantz responded there are two septic systems from previous campgrounds on the property that will be utilized.

Commissioner Lapsley questioned water and buffers. Mr. Bantz responded an old well is already located on the property but has not been tested yet. They plan to use a vegetative buffer of fast growing spruce trees. Screening is already there and they can add additional trees or a fence.

Commissioner Edney asked with the current zoning, could the business be located there and do everything but retail business. Mr. Bantz stated this is correct but they need retail business to help pay expenses.

Commissioner Messer questioned the hours of operation (9 am – 6 p.m.). Mr. Bantz is okay with regular hours of 9-6 but needs extended hours for special events. The lights will be turned off when they leave, the dumpster only emptied after gates have been opened at 9:00 a.m., and the dumpster will be located on the I-26 side of the building.

Commissioner McCall questioned signage. Mr. Bantz stated they will be using a sign from the previous campground and a billboard that is already located there. There will also be a sign at the road and on the building.

Attorney Russ Burrell explained with new laws, conditions must be in writing before the Board can vote.

The Board directed Russ Burrell to work up conditions as gathered from each commissioner, which will be available during the action to anyone. The document will be draft for 1-10 days and then finalized for the agenda of the September 18, 2019 meeting.

The applicant is on a time restraint and will have to file for an extension.

Chairman Hawkins provided time for anyone else to speak and noted once out of public hearing no additional public comments would be taken.

Chairman Hawkins made the motion to go out of public hearing. All voted in favor and the motion carried.

Public Hearing for consideration of economic development incentives for Project "Brighter Day"

Attorney Russ Burrell informed the Board that additional time was needed by the company and requested the public hearing be continued to October 7, 2019.

Chairman Hawkins made the motion to continue the public hearing to October 7, 2019 at 5:30 p.m. All voted in favor and the motion carried.

Agreement for Installation and Maintenance of Gaging Station

The US Geological Survey (USGS) has requested to place a rain gaging station at 320 Williams Street, where Facility Services is located, to collect rainfall data within that area of Henderson County. The station will be installed and maintained by the USGS and removed at their expense when the agreement is terminated. USGS will need to access the station as they deem necessary to measure streamflow and/or water-quality sampling during the life of this agreement.

This request is due to the I-26 expansion project so that they accurately measure rainfall in our area for construction.

PUBLIC SAFETY SOFTWARE SUITE

Sheriff Lowell Griffin stated at the Board's May 15, 2019 meeting, the Sheriff updated the Board on the need to update the Public safety Software Equipment utilized for the 911 Center. The software suite that is currently being utilized has become outdated, unstable, and customer support is virtually non-existent. As a result, the current records management system from Tritech is no longer meeting the needs of emergency services or the community. At that time, the Sheriff's Office was researching options for a new vendor. Following discussion, it was the consensus of the Board was to have the Sheriff finalize their recommendation and bring it back to the Board.

After careful consideration, with input from all emergency services partners, and many hours of research, *Southern Software* has been selected as the desired replacement for the current software system. Because many of our surrounding agencies utilize Southern Software, it will allow the opportunity to quickly share and manage data across jurisdictional boundaries.

The total project cost of \$589,414 is itemized on the attachment. Of that total, \$309,610 is 911 fund eligible, subject to 911 Board approval-based on prior projects approved. To begin the project now, staff requests that available funding in the IT Depreciation Fund be utilized for budget purposes, but offset by any 911 funds actually received.

Staff was directed to communicate the 911 plan with the state to ensure we are eligible.

Commissioner Messer made the motion that the Board of Commissioners approves the software system of Southern Software to replace existing Tritech software, and the Budget Amendment to appropriate \$589,414 in Fund Balance from the IT Depreciation Fund, into a project account in the Capital Project Fund, subject to contracts. All voted in favor and the motion carried.

VW SETTLEMENT GRANT PROGRAM

Christine Brown stated in 2015, the Environmental Protection Agency cited Volkswagen (VW) with a Notice of Violation for manufacturing and installing emissions defeat devices in 2009 – 2015 2.0 - 3.0-liter diesel engine vehicles. This led to a settlement with 2.9 billion used to fund U.S. projects that reduce NOx emissions and North Carolina receiving 3.23% or about \$92 million. The settlement was appropriated into a Volkswagen Environmental Mitigation Trust and the Department of Environmental Quality has divided the funding into three phases over the next five years. Phase 1 has two Request for Proposals available that were announced July 1st, 2019: Diesel Bus and Vehicle program and DC Fast Charger program. Both RFPs are due September 30th, 2019.

The Diesel Bus and Vehicle program awards governments 100% of funding to replace or repower Class 4 -7 trucks. Facility Services is interested in replacing a 2006 Diesel Boom truck with a NiftyLift Self Drive Work Platform that costs about \$60,000 for the bienergy option. Rescue Squad is interested in replacing a 2007 Ford F-450 4x4 truck that costs about \$60,000. The truck will have a double cab with a flat bed and fuel tank that is utilized as a tow vehicle. Both models have newer technology that would reduce NOx emissions and improve air quality.

Henderson County Environmental Programs is interested in applying for the DC Faster Charger program that funds 100% of the equipment for a DC Fast Electric Vehicle charging station on government owned property available to the public. The proposed location would be in the 95 Courthouse overflow lot on 4th Avenue and is within a priority corridor that will receive funding preference. It also meets other station requirements including filling in charging station gaps, accessible to the general public and within a short walking distance to retail or service establishments.

Another exciting feature is the addition of a solar canopy to supply power to the charging station, lessening the environmental impact. The solar power generated can be sold to the grid, sent into a building to offset grid electricity, or stored in an on-site battery for emergency situations.

Drivers would pay to use the DC Fast charger station. The county can choose to pass on the direct cost of electricity to drivers by pricing the kWh at the same rate the county pays or mark up the price to cover long-term operation and maintenance costs. The charging station would require two parking spots and if interested, the county could expand to four with additional funding opportunities coming soon for Level 2 chargers. The cost of the charging station with the solar canopy and installation is about \$75,000 with the VW Settlement grant potentially funding 100% or the county contributing a small match to increase the chance for funding.

The DC Fast Charging Station provides various benefits to the County including supplying 80% of the vehicle's charge in less than 30 minutes, diversifying fuel options for citizens, reducing greenhouse gas emissions, supporting the expansion of green infrastructure, and providing a highly visible example of the county's environmental values.

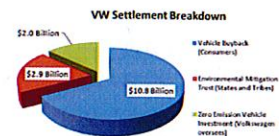
History

Diesel Bus and Vehicle Program

Reimbursement grant that awards governments 100% of required funding

Facility Services is interested replacing a 2006 Diesel boom truck with a NiftyLift Self Drive Work Platform.

DC Fast Charger Program

DC Fast Charger Program

Henderson County is within a priority corridor that will receive funding preference.

Other station requirements:

- Fills in charging station gaps.

- Minimum of two spaces.
- Effort to be ADA accessible.
- On-site lightning, signage and bollards to protect the equipment.

Commissioner Edney made the motion that the Board approves staff to apply for both Department of Environmental Quality's VW Settlement grant programs. All voted in favor and the motion carried.

Steve Wyatt reported that Jimmy Brissie is in Kingston North Carolina awaiting deployment, depending on Hurricane Dorian's path. A swift water rescue team has also been deployed to Williamston.

CANE CREEK WATER AND SEWER DISTRICT

Chairman Hawkins made the motion for the Board to convene as Cane Creek Water & Sewer District Board. All voted in favor and the motion carried.

AGREEMENT FOR INSTALLATION AND MAINTENANCE OF GAGING STATION*

The landowner agrees that the U.S. Geological Survey (USGS), Water Science Center may install and maintain a gaging station on the landowner's property at a mutually agreed-upon site at the location listed below. The landowner also agrees that the USGS will have access to the site, as it reasonably deems necessary for streamflow measuring and/or water-quality sampling during the life of this agreement.

Description of the gaging station, located at Lat: 35.316873 Long: -082.453497, and/or Henderson County Facility Services, 320 Williams Street, Hendersonville, NC

Tipping bucket raingage used to collect and transmit precipitation data



A typical tipping bucket raingage installation consists of a support pole buried in the ground, cabinet for instrumentation, tipping bucket, solar panel, and antenna.

Rainfall data are recorded every five minutes and transmitted via GOES satellite every hour. These data are available at: https://waterdata.usgs.gov/nc/nwis/current/?type=precip&group_key=county_cd

Excavation and/or installation of the gaging station, at the USGS's own expense, may begin any time after this agreement is fully executed. The gaging station shall be excavated, installed, and properly maintained by the USGS. This Agreement shall be regarded as granting a license or easement, whichever may most appropriately characterize it under applicable state law, in favor of USGS to enter landowner's property for the purposes noted herein.

At the expiration of this agreement, the gaging station may be disposed of in one of the following ways:

1- Removal by the USGS, at its own cost and expense, within a reasonable time after the expiration of this agreement. Upon removal of the station, the USGS shall restore the landowner's property, also at its own expense, as nearly as possible to the condition when installed, or

2- Transfer to a state, local, or tribal government agency or Federal Energy Regulatory Commission licensee under a separate written agreement, if approved by the landowner and the USGS Regional Executive.

During the life of this agreement, the Federal Government will be liable for any loss related to the installation, operation, maintenance, and other activities associated with the gaging station described above in accordance with, and to the extent permitted under, the Federal Tort Claims Act (28 U.S.C. §§1346(b) and 2671 et seq).

This agreement shall become effective when fully executed and shall remain in full force for five years unless terminated earlier by USGS upon 60 days written notice. After five years, the agreement will continue in force until terminated by either the USGS or the landowner upon 60 days written notice to the other party.

* For the purpose of this agreement, "gaging station" includes all stilling wells and structure, including cableways and equipment, used in the operation and maintenance of the monitoring site.
