The City of Hendersonville has requested that the County comment on one potential waterline extension:

1. Jeffrey Harvey on behalf of the property owner, Mark Durner has inquired about connection to the City of Hendersonville's water line for PIN's: 9589-36-9594 & 9589-36-9350. The City of Hendersonville has an 8" water main along Sugarloaf Road that touches PIN 9589-36-9594 that only requires a tap application. A waterline extension to serve PIN 9589-36-9350 would be required.

WATER AVAILABILITY

Dear Mr. Harvey:

We received on 5/26/2020 and reviewed your request regarding water availability for the above referenced properties located in the Dana Fire district of unincorporated Henderson County. One of the subject parcels (9589369594) does affirmatively have frontage that abuts an 8-inch City of Hendersonville public water main on Sugarloaf Road. This parcel would not require an extension. Obtaining water service may be initiated through the tap/meter service application on our website.

The second parcel (9589369350) does not have frontage that abuts a City of Hendersonville public water main. In order to serve the subject parcel, a water main extension will be required. An 8-inch City of Hendersonville public water main on Sugarloaf Road is the nearest to this parcel. Please reference the attached system map. An engineered water system design must meet the demand and provide appropriately sized mains.

Any public water or sewer extensions must be designed and constructed in accordance with the North Carolina Division of Environmental Quality's (NCDEQ) <u>Rules Governing Public Water Systems</u> and <u>O2T Rules</u>, respectively. Extensions and connections to the City's <u>public utility</u> systems must also <u>abide</u> by the City's <u>Code of Ordinances</u> and Construction Standards. Refer to the City's Water and Sewer <u>Fee Schedule</u>. Applicable fees may include engineering review, connection and/or construction inspection (per linear foot of extension).

This letter is for informational purposes only, to assist with preliminary plan development and is not an approval for any extension of or connection to the City's public utilities. Field verification is recommended to confirm the location, size and materials of the existing infrastructure. Please don't hesitate to contact me if you should have any questions.


