# **SUMMARY OF REQUEST:**

The City of Hendersonville has requested that the County comment on one potential waterline extension:

 Chris Harpe on behalf of the property owner, Greene River, LLC has inquired about connection to the City of Hendersonville's water line for PIN's: 9599-58-2406, 9599-47-9955, & 9599-47-4615. The City of Hendersonville has an 8" water main along Academy Road that touches PIN's 9599-47-4615 and 9599-47-9955 and only requires a tap application. A waterline extension to serve PIN 9599-58-2406 would be required.

Action by the Board of Commissioners is needed to either grant or deny the request. If the Board decides to approve the extension the following motion has been provided.

Dear Chris Harpe:

We received on 7/1/2020 and reviewed your request regarding water availability for the above referenced property located in unincorporated Henderson County in the Dana Fire District. Two of the subject parcels (9599474615, 9599479955) affirmatively have frontage that abuts the 8" City of Hendersonville public water main along Academy Rd. This parcel would not require an extension. Obtaining water service may be initiated through the <u>tap/ meter service</u> application on our website. Please note that the City's <u>Code of Ordinances</u> (Sec. 52-130) requires separately connected and metered services for each building. One of the subject parcels (9599582406) does not have frontage that abuts a City of Hendersonville public water main. In order to serve this parcel, a water main extension will be required. An 8" City of Hendersonville public water main on Academy Rd is the nearest to this parcel. Please reference the attached system map. An engineered water system design must meet the demand and provide appropriately sized mains. This design must include the demand from all parcels that are expected to connect as part of this project.

Any public water or sewer extensions must be designed and constructed in accordance with the North Carolina Division of Environmental Quality's (NCDEQ) <u>Rules Governing Public Water Systems</u> and <u>O2T Rules</u>, respectively. Extensions and connections to the City's public utility systems must also abide by the City's <u>Code of Ordinances</u> and Construction Standards. Refer to the City's Water and Sewer <u>Fee Schedule</u>. Applicable fees may include engineering review, connection and/or construction inspection (per linear foot of extension).

This letter is for informational purposes only, to assist with preliminary plan development and is not an approval for any extension of or connection to the City's public utilities. Field verification is recommended to confirm the location, size and materials of the existing infrastructure. Please don't hesitate to contact me if you should have any questions.


