CALL TO ORDER/WELCOME

Chairman Hawkins called the meeting to order and welcomed all in attendance.

PUBLIC HEARING

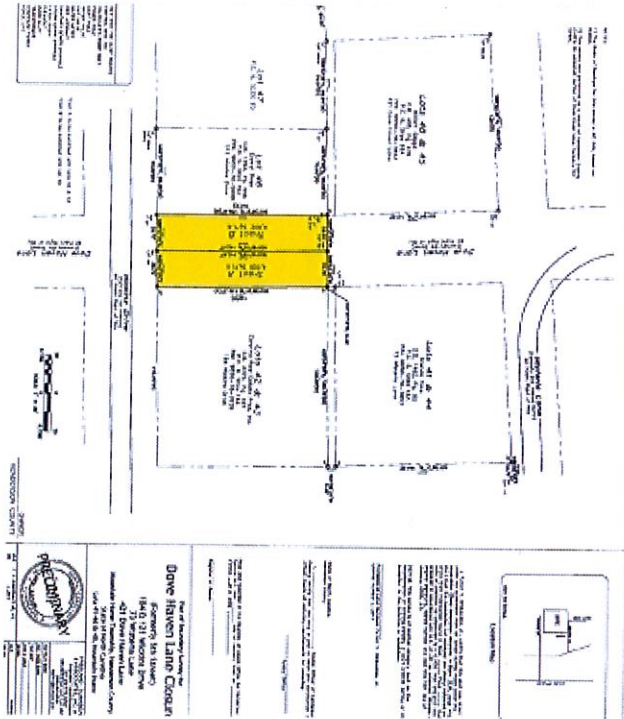
2020.79 Order of Closure - Closing unopened portions of Dove Haven Lane Road Right of Way

Chairman Hawkins made the motion to go into public hearing. All voted in favor and the motion carried.

Sam Starr stated Planning and Property Addressing staff have received a petition and survey to close an unopened portion of Dove Haven Lane. Under North Carolina General Statute (NCGS) 153A- 241, counties have the power to close any public road or easement not within a city, except public roads or easements for public roads under control of the Department of Transportation. To close any road, the Board must:

- Vote to adopt a resolution declaring its intent to close the public road or easement.
- Call and notice a public hearing on closing the road or easement, with notice "reasonably calculated to give full and fair disclosure of the proposed closing to be published once a week for three successive weeks before the hearing, a copy of the resolution to be sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the public road or easement who did not join in the request to have the road or easement closed, and a notice of the closing and public hearing to be prominently posted in at least two places along the road or easement".
- Hold the public hearing, where the Board must "hear all interested persons who appear with respect to whether the closing would be detrimental to the public interest or to any individual property rights".
- Then, if the Board "is satisfied that closing the public road or easement is not contrary to the public interest and (in the case of a road) that no individual owning property in the vicinity of the road or in the

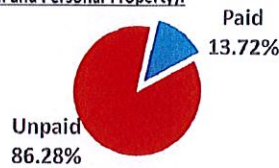

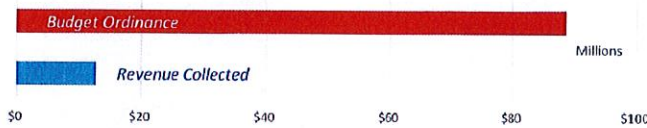

2020.81 Budget Amendment – Hurricane Dorian

During the fall of 2019 Hurricane Dorian struck North Carolina. The State of North Carolina operates a statewide search and rescue program for response to widespread events such as this storm. Henderson County serves as a resource to the State providing a “Type I” team of rescuers from partner Emergency Services agencies. As part of the response Henderson County sent personnel with equipment to assist our neighbors in Eastern North Carolina.

As part of the Statewide Mutual Aid agreement NC Emergency Management provides reimbursement for approved missions. Henderson County Emergency Management staff worked in conjunction with our partner agencies to compile the costs of the deployment which were submitted during the fall of 2019. The State provided reimbursement of \$42,989 to Henderson County for the costs of the deployment. These funds will be distributed to the deployed partner agencies and to reimburse the County for expenses incurred.

Motion:

I move the Board approves the budget amendments authorizing the receipt of funds as reimbursement for the Hurricane Dorian deployment and provide reimbursement to the partner agencies as approved in the State reimbursement package.

2020.82 Proclamation – 2020 Constitution Week – pulled for discussion

September 17, 2020 marks the two hundred and thirty-third anniversary of the drafting of the Constitution of the United States of America by the Constitutional Convention. Henderson County asks our citizens to reaffirm the ideals the Framers of the Constitution had in 1787.

Commissioner McCall read the Proclamation aloud.

Motion:

I move that the Board adopts the Resolution designating September 17, 2020 to September 23, 2020 as Constitution Week in Henderson County. I further move the Board approve placement of a banner in recognition of Constitution Week at the Historic Courthouse.

2020.83 Budget Amendment – MRTS Fiscal Year 20 Projects

The Board is requested to approve a Budget Amendment appropriating fund balance from Maintenance, Repair, Technology and Security (MRTS) for both the Henderson County Public Schools and Blue Ridge Community College. This budget amendment will appropriate funds for projects that were budgeted in FY20, but not completed by the close of the fiscal year.

Motion:

I move the Board approves the Budget Amendment as presented.

2020.84 Budget Amendment – Covertrack Stealth Tracking Devices

The Henderson County Drug Task Force is requesting 1 Pole camera and 1 Tracking device. In 2020 the HCDTF was conducting a drug investigation in Henderson County utilizing a tracker to track the location and destination of our suspect. The suspect located out tracker and destroyed it. The new tracker would be replacing the destroyed tracker.

The tracker’s ability to give us the suspects location keep us from having to directly follow the suspect. This

also keeps from the suspect identifying our vehicles which would negatively affect our investigation.

The pole camera provides the same protections. The pole cam would be set up at a residence, business or an area of suspicious activity. HCDTF would utilize an electronic device to monitor the camera. This would keep the suspect from seeing HCDTF vehicles or personal that would negatively affect our investigation. The sheriff's office does not have a pole camera.

Motion:

I move the Board of Commissioners approves the Budget Amendment as presented appropriating available funds from the United States Department of Justice Federal Asset Forfeiture Funds and authorize the Sheriff's Office to purchase the equipment needed.

2020.85 USDA – NRCS Community Compost and Food Waste Reduction (CCFWR) Grant Award

On June 26th, 2020, Henderson County applied to the U.S. Department of Agriculture - Natural Resources Conservation Service's Community Compost and Food Waste Reduction (CCFWR) Project. On August 24th, 2020, Henderson County was awarded \$90,000 over two-years for the "Organics Pilot Expansion" project. Henderson County is one of thirteen applicants selected from 600 applicants across the county, with only two in the Southeast and the only one in North Carolina.

The County's grant proposal will support critical electrical and equipment needs for the compost facility pilot, expand the lunchroom composting pilot program to six additional elementary schools and start a residential backyard compost bin program. Henderson County will provide a \$64,530 cash match and has already secured \$40,000 of State funds for a total of a \$194,530 project. The County's cash match was included in the approved FY21 budget.

Motion:

I move that the Board accepts the USDA-NRCS Community Compost and Food Waste Reduction grant award of \$90,000 with a \$64,530 cash match of County funds, authorize the County Engineer to sign the grant agreement and approve the attached budget amendment.

Van Winkle Law Firm request for refund of deed excise tax

Attorney Michael M. Thompson has requested, on behalf of The Van Winkle Law Firm, the refund of the sum of Three Thousand Three Hundred Fifty Dollars (\$3,350.00) in real property conveyance excise tax ("deed stamps"). The instrument in question was recorded twice (second time in error) due to a problem with the electronic recording system. The instrument can be found at Henderson County Book 3545, Page 397, *et al.*, and also at Buncombe County Book 5937, Page 394. These details have been verified by Lee King, Register of Deeds.

Pursuant to N.C. Gen. Stat. §105-228.37, a request for refund of overpayment of real property conveyance excise tax must be made within six months of the date of payment. The payment was made on or about August 18, 2020. A letter to the Board of Commissioners requesting refund was provided and an email waiving further notice of your determination in this matter.

If the Board determines that a refund is in order, the refund will be of the amount of the excise tax paid.

Motion:

I move that the Board grants the refund requested insofar as it conforms to the requirements of N.C. Gen. Stat. §105-228.37(b).

Neumann Law Firm PLLC request for refund of deed excise tax

Attorney Douglas R. Campen has requested, on behalf of Neumann Law Firm PLLC, the refund of the sum of One Thousand Twenty-Six Dollars (\$1,026.00) in real property conveyance excise tax ("deed stamps"). The deed in question was recorded twice (second time in error) due to a problem with the electronic recording system. The deed can be found at Book 3538, Page 101, and also at Book 3538, Page 264. These

Set Public Hearing for Conditional Rezoning Application #R-2020-03-C SE Asphalt

Conditional rezoning application #R-2020-03-C was submitted on May 1, 2020 and requests that Henderson County conditionally rezone approximately 6.5 acres of land from Community Commercial (CC) zoning district to a Conditional District (CD-2020-03) to construct a new asphalt plant. The subject area is located on a portion of PIN: 9568-37-1990 along Spartanburg Hwy (US176). The property owner is listed as DGP Holdings, LLC and NKMR Ventures, LLC. The applicant is SE Asphalt-Jeff Shipman, and the agents are Warren Sugg with Civil Design Concepts and Brian Gulden, attorney.

As required by the LDC, a neighbor compatibility meeting was held on Monday, June 8, 2020. A copy of the meeting report will be sent to the Board of Commissioners.

The Technical Review Committee (TRC) reviewed the application on June 16, 2020. The Planning Board reviewed the conditional rezoning request at its August 20, 2020 meeting and voted 5-2 to send forward an unfavorable recommendation.

Motion:

I move that the Board schedule a public hearing for conditional rezoning application #R-2020-03-C for a proposed new asphalt plant for Thursday, October 1, 2020 at 6:00 p.m. at the Technology Education and Development Center on the Blue Ridge Community College campus.

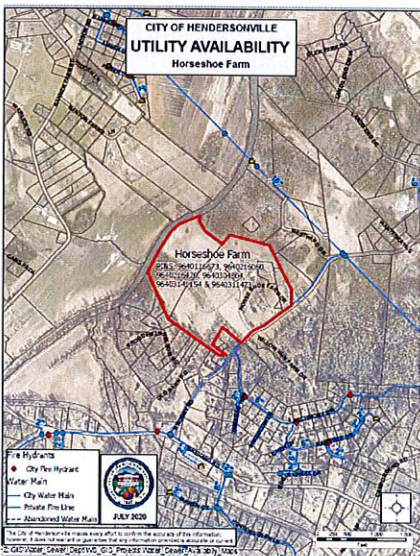

Water Extension Request – pulled for discussion

The City of Hendersonville has requested that the County comment on one potential waterline extension:

1. Nicholas Bowman on behalf of the property owner, Sen-Asheville I, LLC has inquired about connection to the City of Hendersonville’s water line for PIN’s: 9640-21-6060, 9640-31-4154, 9640-11-6673, 9640-21-6420, 9640-30-4804, and 9640-31-1473. The City of Hendersonville has an 8” water main along Academy Road that touches PIN’s 9640-21-6060 and 9640-31-4154 and only requires a tap application. A waterline extension to serve PIN 9640-11-6673, 9640-21-6420, 9640-30-4804, and 9640-31-1473 would be required.



The request (1.) above should have read as follows (changed portions in **bold underlined italics**):

1. Nicholas Bowman on behalf of the property owner, Sen-Asheville I, LLC has inquired about connection to the City of Hendersonville’s water line for PIN’s: 9640-21-6060, 9640-31-4154, 9640-11-6673, 9640-21-6420, 9640-30-4804, and 9640-31-1473. The City of Hendersonville has a **12”** water main along **South Rugby Road** that touches PIN’s 9640-21-6060 and 9640-31-4154 and only requires a tap application. A waterline extension to serve PIN 9640-11-6673, 9640-21-6420, 9640-30-4804, and 9640-31-1473 would be required.

This erroneous reference was approved as corrected in the October 21, 2020 Board of Commissioners’ meeting.

Commissioner Edney stated this property is outside of the City of Hendersonville and the ETJ. Customers outside of the city limits are charged twice as much as those within the city limits. The City has stated that their plan is to equalize rates over the next 10 years, however there is no mention of this within their budget and no evidence that this will be done. The City is also charging a \$5 stormwater user fee for those located within the ETJ, and should not be. Commissioner Edney does not support continued expansion of City water outside of the City.

Commissioner Edney made the motion that the Board deny the waterline extension request for Nicholas Bowman on behalf of the property owner, Sen-Asheville I, LLC, unless the City offers the same rates to the County customers outside of the City limits, and further moved that the Board direct staff to convey the County's comment to the City of Hendersonville. All voted in favor and the motion carried.

2020.87 Budget Amendment – Mobile Command Center (no Budget Amendment attached)

The Sheriff's Department is requesting that the Board approve an appropriation from the Sheriff's Office Restricted US DOJ funds (114431-451005) in an amount not to exceed \$65,000 to upfit the newly purchased Mobile Command Center. The appropriation would be used to purchase items such as radios, lights, and other technology equipment needed to make the Command Center fully functional for field operations.

Motion:

I move the Board of Commissioners approve an appropriation from Restricted US DOJ funds in an amount not to exceed \$65,000 and the necessary budget amendment(s), and to authorize the Sheriff's Office to purchase equipment for this Mobile Command Center currently being held by the Sheriff's Office.

Chairman Hawkins made the motion to accept the appointment of Jean McGrady as Chair of the Library Board of Trustees by acclamation. All voted in favor and the motion carried.

There were no nominations at this time and this item was rolled to the next meeting.



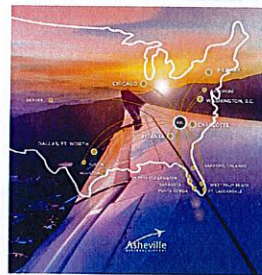

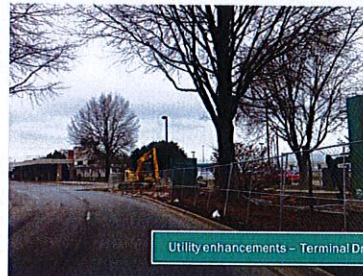

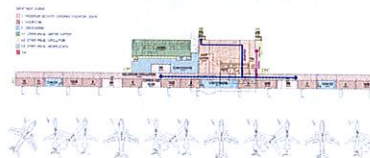

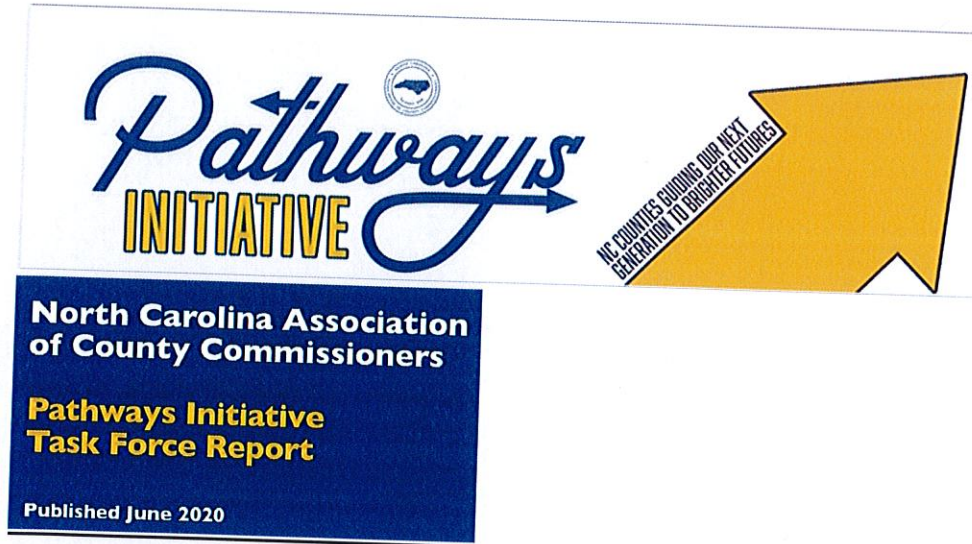


NCACC PATHWAYS TASK FORCE

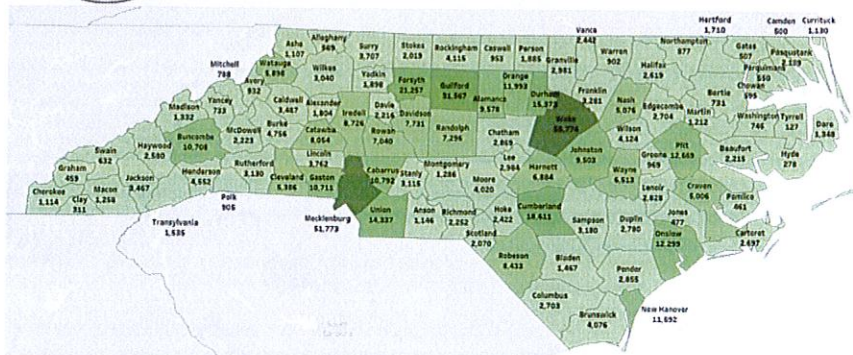
Executive Summary Points

- Disconnected Youth defined as those who are age 16-19, not in school, not working
- If they remain out of workforce for very long, they may never recover
 - National annual cost of \$93b – lost revenue and increased social services
- Purpose of Task Force
 - Better understand issues
 - Determine how counties/state can help provide pathways
- Problem can affect any family, not dependent on economic status, but majority of affect is to those children of low-income families and/or those with lack of adult supervision, direction or involvement



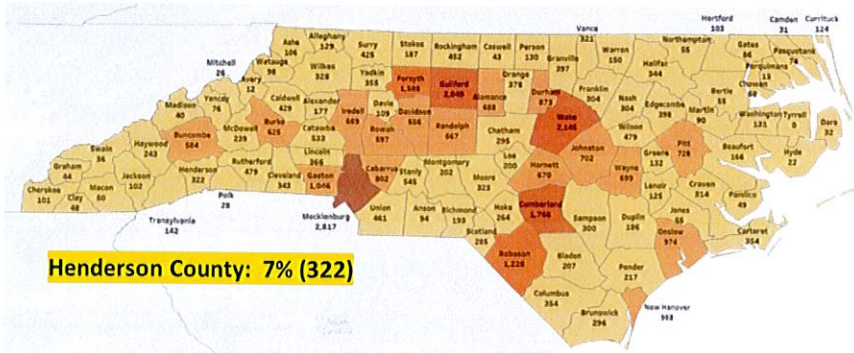
16-19 Year Olds, Estimate

- Had to quit extra-curricular activities
- 16 year-old male – 2 parent home – 2 older siblings (in college)
 - No interest in school
 - No desire to go to college – feels pressured due to siblings
 - Lack of concentration

All three enrolled in F.A.C.E. – Forsyth Academy of Continuing Education – evening high school programs

ORDER CLOSING A PORTION OF THE
RIGHT-OF-WAY FOR DOVE HAVEN LANE

THIS MATTER came on for hearing before the Henderson County Board of Commissioners at its regular September 8th 2020, meeting, pursuant to N.C. Gen. Stat. §153A-241, on the issue of closing a portion of rights-of-way for portions of Dove Haven Lane was heard by the Board after public hearing. The Board of Commissioners makes the following findings:

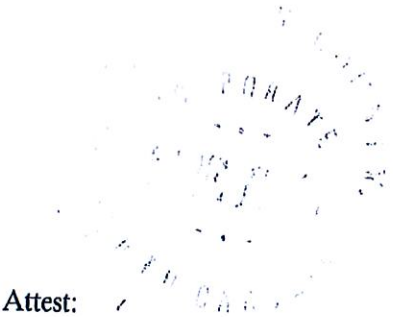
1. This matter first came before the Board of Commissioners on at the Board's regular meeting on August 19th 2020, on the petition of Carolina Real Estate Pros, LLC to close portions of Dove Haven Lane was heard in Henderson County.
2. At the Board's August 19th, 2020 meeting, the Board adopted a resolution "declaring its intent to close" the said portions of Dove Haven Lane.
3. A map showing the area under consideration is shown on the attachment hereto, Exhibit A, (indicated by a highlighted portion indicating closure areas)
4. A notice of this Board's September 8th hearing was published once a week for three successive weeks before the hearing in the *Hendersonville Tribune*, a copy of the resolution was sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the public road or easement who did not join in the request to have the road or easement closed, and a notice of the closing and public hearing to be prominently posted in at least two places along the road or easement.
5. Before the Board on September 8th, the Board heard "all interested persons who appear with respect to whether the closing would be detrimental to the public interest or to any individual property rights" are required by N.C. Gen. Stat. §153A-241.
6. After such hearing, the Board is satisfied and finds:
 - A. That closing the public road or easement is not contrary to the public interest;
 - B. That no individual owning property in the vicinity of the road or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property.

WHEREFORE IT IS ORDERED that portions of Dove Haven Lane in Henderson County

as shown on the attached map is hereby closed.

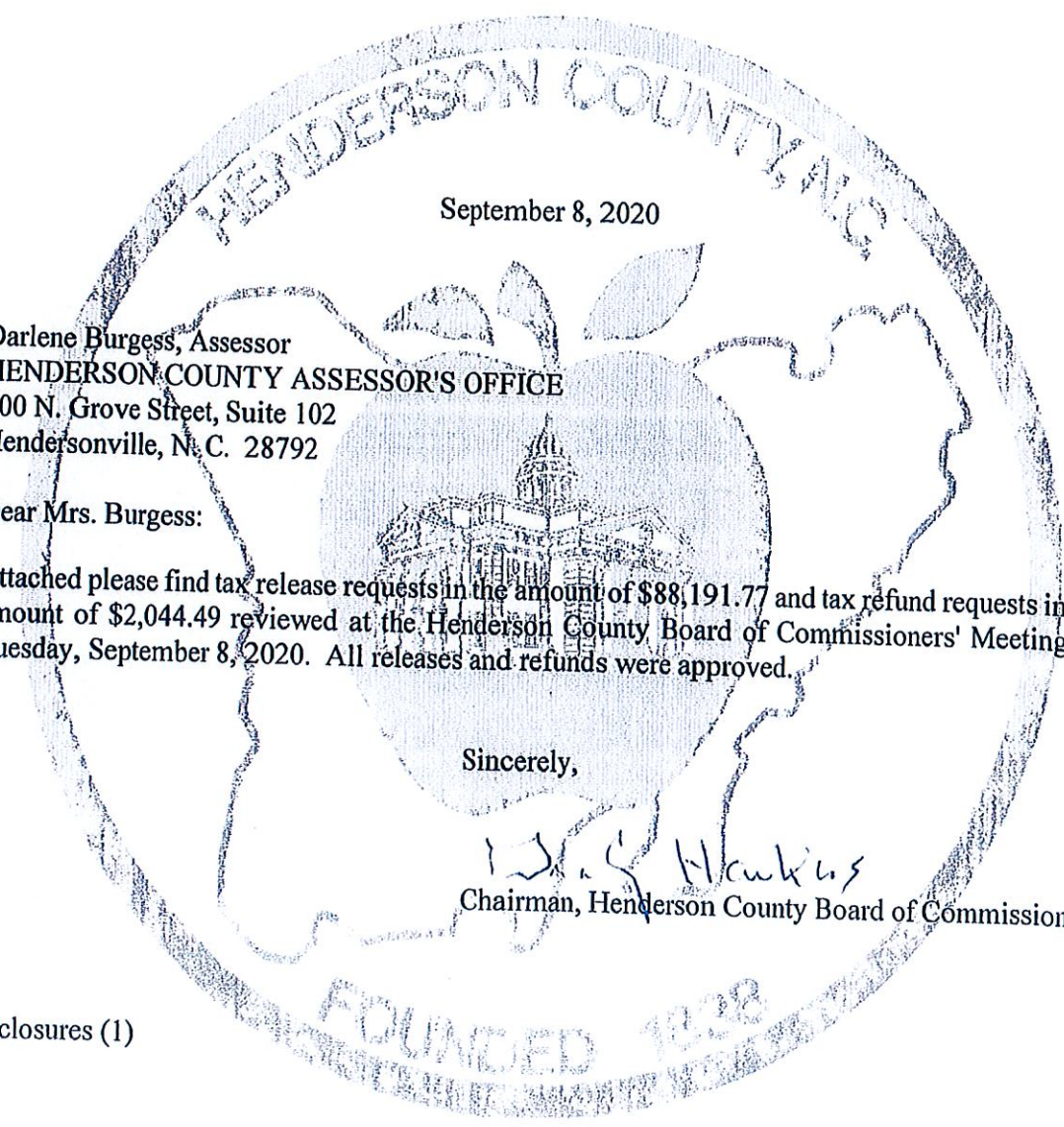



THIS EASEMENT ("Easement") is made this 8th day of September, 2020 ("Effective Date"), from HENDERSON COUNTY, a body politic, ("GRANTOR," whether one or more), to Duke Energy Carolinas, LLC, a North Carolina limited liability company ("DEC"); its successors, licensees, and assigns.

WITNESSETH:

THAT GRANTOR, for and in consideration of the sum of ONE DOLLAR (\$1.00), the receipt and sufficiency of which are hereby acknowledged, does hereby grant unto DEC, its successors, licensees, and assigns, the perpetual right, privilege, and easement to go in and upon the land of GRANTOR situated in Hendersonville Township, described as follows: PIN# 9569-35-9955 containing 3.460 acres, more or less, and being the land described in a deed from Dawsoncourt, Inc. to Henderson County, dated February 25, 1997 and recorded in Book 917, Page 650, Henderson County Registry (the "Property"), LESS AND EXCEPT any prior out-conveyances, and to construct, reconstruct, operate, patrol, maintain, inspect, repair, replace, relocate, add to, modify and remove electric and/or communication facilities thereon including but not limited to, supporting structures such as poles, cables, wires, underground conduits, enclosures/transformers, vaults and manholes and other appurtenant apparatus and equipment (the "Facilities") within an easement area being twenty (20) feet wide, together with an area ten (10) feet wide on all sides of the foundation of any DEC enclosure/transformer, vault or manhole (the "Easement Area"), for the purpose of transmitting and distributing electrical energy and for communication purposes of DEC and Incumbent Local Exchange Carriers. The centerline of the Facilities shall be the center line of the Easement Area.

The right, privilege and easement shall include the following rights granted to DEC: (a) ingress and egress over the Easement Area and over adjoining portions of the Property (using lanes, driveways and paved areas where practical as determined by DEC); (b) to relocate the Facilities and Easement Area on the Property to conform to any future highway or street relocation, widening or improvement; (c) to trim and keep clear from the Easement Area, now or at any time in the future, trees, limbs, undergrowth, structures or other obstructions, and to trim or clear dead, diseased, weak or leaning trees or limbs outside of the Easement Area which, in the opinion of DEC, might interfere with or fall upon the Facilities; and (d) all other rights and privileges reasonably necessary or convenient for DEC's safe, reliable and efficient installation, operation, and maintenance of the Facilities and for the enjoyment and use of the Easement Area for the purposes described herein.

It is understood and agreed that the general location of the Easement Area is shown on the sketch attached hereto as Exhibit A and recorded herewith. The final and definitive location of the Easement Area shall become established by and upon the final installation and erection of the facilities by DEC in substantial compliance with Exhibit A hereto.

TO HAVE AND TO HOLD said rights, privilege, and easement unto DEC, its successors, licensees, and assigns, forever, and GRANTOR, for itself, its heirs, executors, administrators, successors, and assigns, covenants to and with DEC that GRANTOR is the lawful owner of the Property and the Easement Area in fee and has the right to convey said rights and Easement.

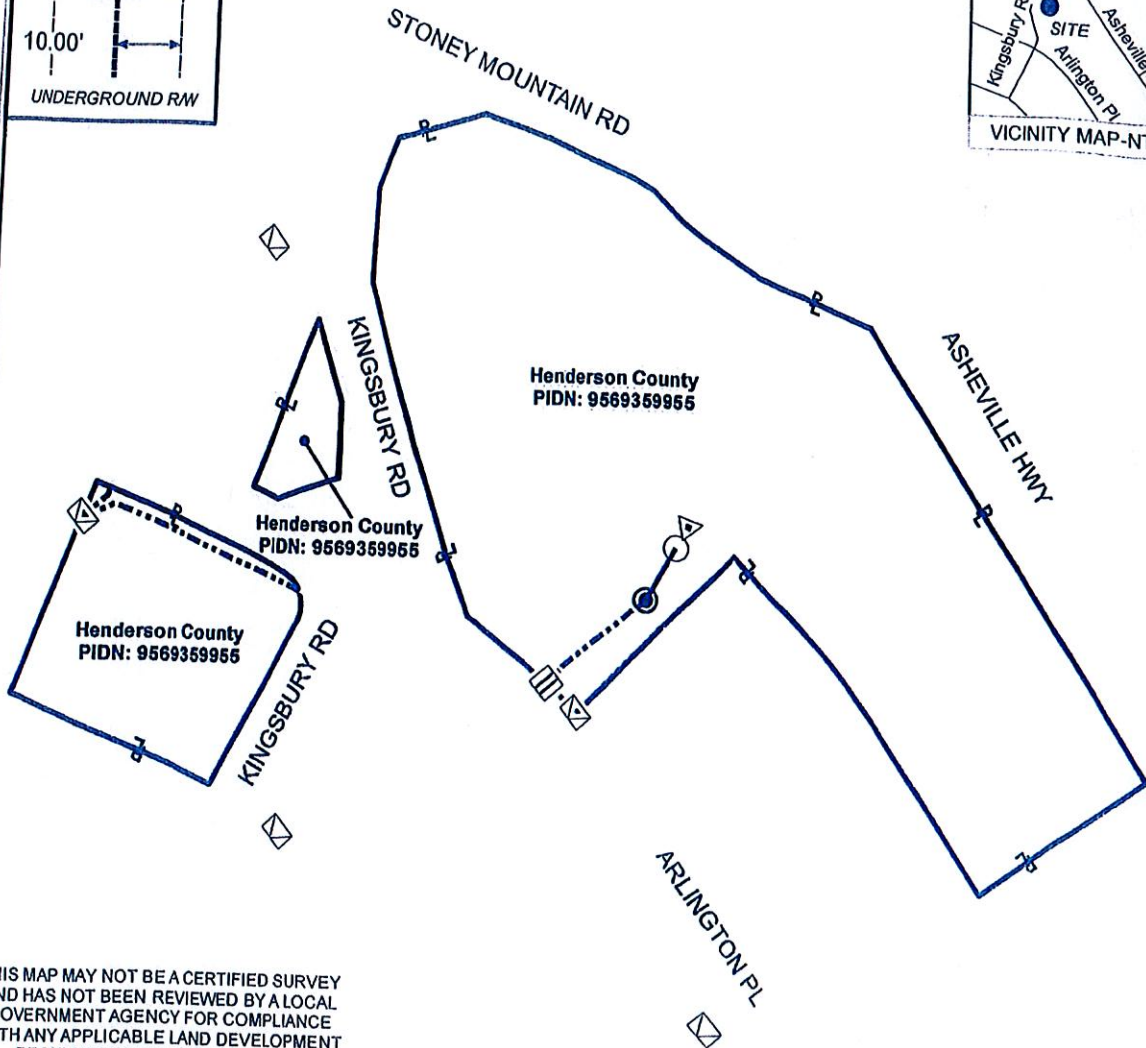
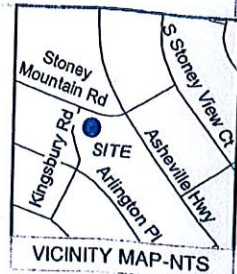
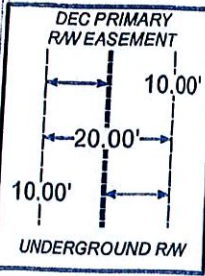
