#### **SUMMARY OF REQUEST:**

In May of this year, the Board of Commissioners approved the contracting of Stewart Consultants for the facilitation of the new Henderson County 2045 Comprehensive Plan. This plan, required by NC General Statutes, will provide a guideline for growth and development in the County.

The plan requires extensive public input and involvement, which equates to a long planning process. The consultants have divided the estimated 18-month process into three phases. We are currently in Phase 1. The Board will receive regular monthly updates throughout the process.

## **HENDERSON COUNTY 2045**

**COMPREHENSIVE PLANNING PROCESS UPDATE** 

### PHASE 1

The comprehensive plan is a detailed plan that will take 18 months to complete. The process is broken into three phases. Phase 1 is anticipated to run through the end of 2021.

### **JULY 2021 UPDATES**

#### **WEBSITE AND DOMAIN CREATION**

The County website was updated to reflect current information about the new plan. A new website was created for ease of use that has a distinct domain name that will be linked directly from Henderson County's website.

#### **SURVEY CREATION**

In an effort to include a paper survey to all real and personal property owners in the 2020 tax bill, a survey was drafted and submitted to the Tax Office for processing. The tax bills will be mailed on August 1<sup>st</sup>, and the survey will also be available online by August 1<sup>st</sup>.

#### **KICK-OFF MEETING**

Staff and the consultants "kicked-off" the comprehensive planning process with the Planning Board which is serving as the plan's steering committee. The Stewart team also met with key county departments to gather data and input.

#### **COUNTY TOUR**

Staff provided a tour of significant County locations for the consultants to help them understand our unique community.

### **UPCOMING EVENTS**

- The tax bill and paper survey will be mailed to property owners on August 1st.
- County staff will do a social media push to let citizens know about the survey. Key community organizations will assist in spreading the word.
