# SUMMARY OF REQUEST:

NCDOT seeks execution by the County (as owner) of two "Deeds for Highway Right of Way" in their favor, regarding the newly constructed turning lane on U.S. Highway 25 into the new parking area at Hendersonville High School. The attached deeds were drafted by NCDOT, and the describe the turning area "as built". Note that these have been approved by the Board of Education.
