RESOLUTIONS AND RECOGNITIONS

Elks Lodge Recognition

Chairman McCall recognized Connie Pace, representing the Elks Lodge, for their assistance and fund-raising efforts for the construction of the new All-Inclusive Playground at Jackson Park. The playground, at almost 10,000 square feet, has been designed for all children and for all physical abilities. JR Spachman built the fence, Chris McCraw helped design the sidewalks and Scott Case spent hours trying to find ideas to make the grading work cheaper and more workable to improve the overall landscape The Elks Lodge raised \$5,000 toward the project, which is in the final stages of construction, with a ribbon-cutting planned for Saturday, May 13, 2023 at 10:00am.

2023.63 Proclamation – Designating June as Elder Abuse Awareness Month

- **WHEREAS,** in 2006, the International Network for the Prevention of Elder Abuse, in support of the United Nations International Plan of Action, proclaimed a day to recognize the significance of elder abuse as a public health and human rights issue; and
- WHEREAS, Henderson County's vulnerable and elder adults deserve to live safely with dignity; and
- WHEREAS, vulnerable and elder adults of all socio-economic, racial and ethnic backgrounds may be targets of abuse, neglect or exploitation which occurs in families, long term care facilities and communities; and
- **WHEREAS,** Henderson County Adult Protective Services received 579 reports in 2022 with 339 screened in for evaluation; and
- WHEREAS, we know that elder abuse and mistreatment are underreported according to a study by the World Health Organization that found only 1 in 24 cases of elder abuse is reported; and
- WHEREAS, recognizing that it is up to all of us, to ensure that proper social structures exist so people can retain community and societal connections, reducing the likelihood of abuse; and
- **WHEREAS,** protecting Henderson County's vulnerable and elder adults is a community responsibility and it is imperative that communities work together to help reduce and prevent abuse, neglect and exploitation; and
- WHEREAS, all residents should watch for signs of abuse such as physical trauma, withdrawal, depression, anxiety, fear of family members, friends or caregivers and report suspected abuse or exploitation to the Department of Social Services.

NOW, THEREFORE, BE IT PROCLAIMED that the Henderson County Board of Commissioners does hereby declare June as Elder Abuse Awareness Month in Henderson County, and encourages the community to work together to help reduce and prevent abuse, neglect and exploitation of our elders.

Adopted this the 1st day of May, 2023.



Motion:

I move that the Board approve the Henderson County Public Schools Financial Reports for March 2023 as presented.

Facility Use Policy Exemption – American Legion

The County has received a request from the American Legion Auxiliary Unit 77 to set up a poppy display in the Historic Courthouse Rotunda. The request would be now through Memorial Day. Part of the would include a donation cup, which would involve solicitation.

To allow for this use on County grounds, the Board is requested to grant a one-time exemption to rule #4 of the County Facility Use Policy, which prohibits solicitation on the grounds. This exemption, if granted, would cover the dates as outlined above.

Motion:

I move that the Board grant an exemption to the County Facility Use Policy for the American Legion Auxiliary Unit 77 to set up a poppy display, including a donation cup, in the Historic Courthouse Rotunda through Memorial Day, 2023.

2023.62 PUBLIC HEARING - To Consider a Moratorium on "Cryptocurrency Mining"

A Public Hearing has been scheduled on a draft Ordinance Imposing a Moratorium on Cryptocurrency Mining.

Chairman McCall made the motion to go into Public Hearing. All voted in favor and the motion carried.

County Attorney Russ Burrell gave the Board an update on what cryptocurrency mining meant from a practical standpoint. It uses tremendous amounts of electricity, and is extremely loud. He stated that the request was to impose a 60-day moratorium on cryptocurrency mining to allow the Planning Board to recommend some regulations in the form of a draft Ordinance for the Board's consideration.

Public Input

There was none.

Commissioner Andreotta stated that he had done some research, and noted that one of the other concerns was about the impact that cryptocurrency mining has on water quality.

Chairman McCall made the motion to go out of Public Hearing. All voted in favor and the motion carried.

Vice-Chair Edney made the motion to adopt an ordinance impose a 60-day moratorium on cryptocurrency mining in Henderson County. All voted in favor and the motion carried.

County Manager's FY2023-2024 Recommended Budget


John Mitchell presented the County Manager's FY2023-2024 Recommended Budget for the Board's consideration. The recommended budget was presented in accordance with the Board's direction from the January 2023 Budget Retreat. The Revenue Neutral Tax Rate as of May 1st is \$0.431, and is what the FY24 Ad Valorem Tax Revenue is based upon. Chairman McCall made the motion that the Board schedule the Public Hearing on the FY 2023-2024 Budget for Monday, June 5, 2023 at 5:30pm.

Budget Amendment - Motorola Body Cameras

The Board had a discussion at the March 15th meeting regarding a request from the Sheriff's Office to approve a five-year contract to allow for a switch to Motorola/Watchguard body cameras. The change is necessary due to the reoccurring failures of our current cameras, for integration with the vehicle car cameras and for officer safety. Sheriff Griffin stated that when we started the Body Camera program, the vendor selected was Intrensic, but with the necessary in-camera upgrades, the upgrade for integrated body cameras seems to make sense timing wise.

The Sheriff's Office has included a Budget Amendment to pay \$33,077 from the FY23 budget to allow them to receive the cameras and start the service. The remaining amounts per the contract will be payable according to the contract schedule. The total cost of the contract is \$379,985 which includes the cameras, video evidence storage, setup, no fault warranty on the cameras, transfer stations, batteries, docking stations, and training.

Following discussion, Commissioner Lapsley made the motion to "approve an appropriation from the Automotive Supplies funds in an amount of \$33,077 and the necessary budget amendment(s), and to authorize the Sheriff's Office to purchase the body cameras." All voted in favor and the motion carried.

Mr. Mitchell noted that the All-Inclusive Playground is nearly finished. A ribbon-cutting is scheduled for May 13th at 10:00am. We anticipate this week having the 100% design drawings for the EMS facility at Fletcher, so a ground-breaking will be scheduled for that project in the coming months. A ribbon cutting at East Flat Rock Park will need to be scheduled. The VFW will be bid out in the very near future and a ground-breaking will be scheduled. And finally the 100% design drawings for the Ecusta Trail are nearing completion and those bids will be received in the near future.

IMPORTANT DATES

Chairman McCall noted the June 5th Public Hearing on the FY24 Budget Recommended Budget. She also stated there is a Special Called Meeting scheduled for June 3rd at 1:00 dedicated to the 2045 Comprehensive Plan. She reminded the public that they are always welcome and thanked those in attendance for being present.

COMMISSIONER UPDATES

Commissioner Andreotta reminded people that with nice weather emerging, to please be careful when bicycling. Cyclists should follow the traffic rules of the road for their protection. He also asked that folks attend the May 13th ribbon cutting for the All Inclusive Playground.

Commissioner Hill stated that May 19th at 8:30am is the FFA Awards breakfast at Tracy Grove Baptist Church.

Vice-Chairman Edney thanked Staff for all the work that has gone into the FY24 budget thus far.

Chairman McCall stated that the litter clean-up held last Saturday had been very successful. The County had partnered with the City for the litter sweep, and about 15 people had removed about 290 lbs. of litter.

CLOSED SESSION

Commissioner Edney made the motion that the Board go into closed session pursuant to N.C. Gen. Stat. $\S143-318.11(a)(5)$, to establish, or to instruct the public body's staff or negotiating agents
