SUMMARY OF REQUEST:

Pursuant to N.C. Gen. Stat. §163-35(c):

Compensation paid to directors of elections in all counties maintaining full-time registration (five days per week) shall be in the form of a salary in an amount recommended by the county board of elections and approved by the Board of County Commissioners and shall be commensurate with the salary paid to directors in counties similarly situated and similar in population and number of registered voters.

Henderson County Board of Elections Chair Clay Eddleman proposed the director's salary in the attached. The amount proposed in Dr. Eddleman's letter is within the range proposed by Henderson Human Resources as "commensurate with the salary paid to directors in counties similarly situated and similar in population and number of registered voters."

The purpose of this letter is to fulfill our duties under to the provisions of N.C. Gen. Stat. §163-35(c), and as such we unanimously recommend the initial salary for the position of Henderson County Director of Elections. The amount recommended below is within the range recommended by your Human Relations Department as "commensurate with the salary paid to directors in counties similarly situated and similar in population and number of registered voters".

The initial salary amount recommended is \$80,000, with the understanding that when director certification is achieved, salary will be raised to \$85,000.

It is the Board's hope and plan that it will recommend the adjustment of this salary in coming years as our new director progresses and grows in the position.
