SUMMARY OF REQUEST:

The Board is requested to approve the low bid and authorize the Department of Soil and Water to proceed with the Lewis Creek restoration at the Edneyville Community Center. Bidding was conducted between August 30, 2023 and October 2, 2023. Baker Grading & Landscaping Inc was the lowest responsive responsible bidder in the amount of \$239,688.50.

This purchase is funded with state grant funds via the NC Attorney General's Environmental Enhancement Grant and NC DEQ Water Resource Development Grant and the federal funds via the EPA 319 NPS Pollution Control Grant, and NRCA EQIP.

The Board is requested to accept the low bid from Baker Grading & Landscaping Inc for \$239,688.50 and authorize Soil & Water to proceed with the Lewis Creek restoration at the Edneyville Community Center.
