## SUMMARY OF REQUEST:

The Board is requested to approve the bid and authorize staff to proceed with the procurement of forty-two computer workstations and accessories. Bidding was conducted between September 13, 2023, and September 27, 2023. The bidder with the lowest responsive, responsible bid was Y&S Technologies for a total price pre-tax of \$113,694. Tech365, LLC was the lowest bid at \$79,388.18 pre-tax; however, they did not meet RAM requirements for the computers as specified in the bid. Brooks Network Services was the second lowest bid at \$91,759.54 pre-tax; however, they did not provide a build sheet with their bid submittal.

These 42 computer replacements with accessories were approved for the Department of Social Services as part of the FY2024 Information Technology listing. \$122,250 was budgeted in the FY2024 Budget for the purchase of these computer workstations & accessories.

## **BOARD ACTION REQUESTED:**

The Board is requested to accept the lowest responsive, responsible bid from Y&S Technologies and authorize Henderson County staff to proceed with the purchase of forty-two computer workstations and accessories in the amount of \$113,694 and authorize the IT Department to proceed with the purchase.
