Bryan Rhodes and Chris Todd will provide the Board of Commissioners with an update on construction projects around Henderson County.


















Etowah Library


West Henderson High Renovation and Addition


- LS3P has delivered their 100% Construction Documents as of 10/20/23, to Carolina Specialties, for them to start the bidding process.










- West High Air Handler Replacement
