
Staff sent letters to all property owners notifying them of the date and time of the public hearing and the proposed road names, and the hearing was advertised in the Hendersonville Lightning.

Dear Mr. Parks,

I am indeed the owner of the parcel at 656 Stoney Mountain RD

I do not know the motivation for the name "Ada Way".

Instead I propose the name "Clingman Lane" after my grandfather John Clingman Hill who bought the parcel with his wife Mamie (mn"Carver") in 1914.

John served as **Sheriff of Henderson County** sometime in the 20's or early 30's I believe. He later owned a grocery store on what is now 7th Ave, but went bankrupt extending credit during the depression.

The name "Clingman Lane" would connect the road to Henderson County history of the early 20th century.
