SUMMARY OF REQUEST:

At the June 19, 2024 meeting of the Board of Commissioners, the FY2025 County funding plan for the Home & Community Care Block Grant (HCCBG) was approved. After reviewing year-todate program expenditures, the Council on Aging is seeking Board approval to reallocate \$2,420 in HCCBG funds from the Liquid Nutrition program to the Congregate Meals program. This request is driven by two main factors: (1) a rise in demand for Congregate Dining services, and (2) difficulties with the Liquid Nutrition program, including the availability of alternative sources, inconsistent participant engagement, and ongoing supply chain challenges.

BOARD ACTION REQUESTED:

The Board is asked to authorize the Chairman to sign the updated HCCBG County Funding Plan documents, including the County Services Summary (DAAS-731) and the Provider Services Summary (DAAS-732), for submission to the Land of Sky Regional Council.
