#### 2025.157 Resolution - We are Hope Week

# RESOLUTION – HONORING THE OBSERVANCE OF "WE ARE HOPE" WEEK IN HENDERSON COUNTY PUBLIC SCHOOLS' MIDDLE AND HIGH SCHOOLS

- WHEREAS, Substance and alcohol misuse adversely affect the brain, liver, heart, and overall health and can cause adverse behavioral, psychological, social, and fatal consequences; and
- WHEREAS, there were more than 83,300 drug overdose deaths in the United States in 2024, and the overall trend since 2018 is marked by a sharp rise, driven largely by synthetic opioids like fentanyl; and
- WHEREAS, substance and alcohol abuse continue to occur among children and youth in our society: with overall usage among youth declining during the last 10 years due to education and prevention efforts; and

- WHEREAS, student leaders in Henderson County Public Schools' six high schools and four middle schools have joined with local Henderson County Hope Coalition in educating their peers on alcohol, tobacco, marijuana, and prescription drug use and misuse; and
- WHEREAS, students at Apple Valley Middle, Flat Rock Middle, Hendersonville Middle, Rugby Middle, East Henderson High, Innovative High School, Henderson County Career Academy, Hendersonville High, North Henderson High, and West Henderson High are pledging to be and remain substance-free.

**NOW, THEREFORE, BE IT RESOLVED** by the Henderson County Board of Commissioners, that September 22nd, 2025 – September 26th, 2025, be observed in Henderson County Public Schools' middle and high schools as "We Are Hope" substance abuse prevention week.

- WHEREAS, Charlie Kirk was dedicated to fostering an environment for open debate and dialogue on some of the toughest issues facing American politics; and
- WHEREAS, The Henderson County Board of Commissioners proudly uphold the First Amendment and believes that exercising that right should come without risk of death or injury; and
- **WHEREAS,** The United States of America was founded upon the universal truths that men are endowed with certain unalienable rights, among which are life, liberty, and the pursuit of happiness.

#### 2025.158 Grant - NC Arts Council Grassroots Program

Revenue Collected

A grant contract and related budget amendment for the North Carolina Arts Council's Grassroots Art Program were presented for the Board's review and approval. Henderson County is acting as a pass-through entity for these funds, totaling \$80,837. With the Board's approval, Henderson County will accept the grant funds from the North Carolina Arts Council, serve as a member on the awardee selection committee, draft grant contracts for each awardee, and disburse all grant funds to the organizations selected by the committee. The Grant Administrator will ensure that subgrantees meet the North Carolina Arts Council's reporting requirements and submit the grant's final report.

Motion: I move that the Board of Commissioners approve the grant contract with the North Carolina Arts Council for the Grassroots Art Program and the associated budget amendment as presented.

#### Architect of Record Proposal – Medical Office Building, Mills River

The Board was requested to approve a proposal letter from LS3P Architects for design services, including Design Development through Construction Administration Phase (finish), for the Mills River location Medical Office Building, and to authorize staff to proceed with the Henderson County/Henderson Hospital Corporation Medical Office Building.

Motion: I move that the Board approve the proposal letter from LS3P Architects, in the amount of \$2,304,571, for the Mills River Medical Office Building location.

#### Chronic Nuisance Property – 264 Misty Mountain Drive

The Code Enforcement and Zoning Department has cited a particular parcel of property three times within the past year for violation of the County's nuisance ordinance, Chapter 52 of the Henderson County Code. The property is listed in the geographical information system under PIN 9528786300, with the owner identified as "Joan Kilpatrick". A copy of each notice of violation was provided as part of this agenda item.

#### Under N.C.G.S. §153A-140.2,

A county may notify a chronic violator of the county's public nuisance ordinance that, if the violator's property is found to violate the ordinance, the county shall, without further notice in the calendar year in which notice is given, take action to remedy the violation. The expense of the action shall become a lien upon the property and shall be collected as unpaid taxes. The notice shall be sent by certified mail. A chronic violator is a person who owns property whereupon, in the previous calendar year, the county gave notice of violation at least three times under any provision of the public nuisance ordinance.

This matter would come back before the Board before a contractor was hired to clear up the property under the authority noted above.

Motion: I move that the Board give the owner(s) of the property which is the subject of this agenda item the notice provided for under N.C.G.S.§153A-140.2.

#### Vaya Health - Quarterly Fiscal Monitoring Report for the quarter ended June 30, 2025

N.C.G.S. 122C-117(c) requires the staff of the local area mental health authority to provide the County Finance Officer with the quarterly Fiscal Monitoring Report (FMR) within 30 days of the end of the quarter. The County Finance Officer is then required to provide the FMR to the Board of Commissioners at the next regularly scheduled meeting of the board. The County Finance Officer received the FMR for Vaya Health on August 25, 2025.

#### **HCPS Needs-Based Public School Capital Fund Grant Application**

Henderson County Public Schools (HCPS) requested that Henderson County partner in applying for a Needs-Based Public School Capital Fund Grant to replace part of the Rugby Middle School HVAC System.

The total grant funding requested is \$397,500 for the project, which is estimated to cost \$530,000. A local match of 25% is required, \$132,500, and is anticipated to be expended from Maintenance, Repair, Technology, and Security (MRTS) funding allocated to HCPS, as appropriate.

Motion: I move that the Henderson County Board of Commissioners approve and execute the Henderson County Public Schools Needs-Based Public School Capital Fund 2025-2026 Grant Application.

#### 2025.159 Grant Project Resolution - NC Department of Environmental Quality

Staff was pursuing grant funding for the design of the Etowah Sewer System. The North Carolina Department of Environmental Quality (NCDEQ) Division of Water Infrastructure requires a resolution for their Fall 2025 grant application, due September 30. Any grant funding awarded by NCDEQ, up to \$500,000, will be used to advertise and contract for the design of the Etowah Sewer System.

Motion: I move that the Board approve the project resolution required for the Division of Water Infrastructure Fall 2025 grant application to fund the design of the Etowah Sewer system.

#### Correction of Motion – September 2, 2025

On September 2, 2025, the Board authorized the County Engineer to execute an agreement with WithersRavenel, Inc. to perform services utilizing the Asset Inventory and Assessment Grant (AIA) Grant for the Etowah Sewer System.

#### 2025.160 Close an Unopened 40 Foot Right-of-Way

Planning and Property Addressing staff received a petition to close a 40-foot unopened right-of-way. Under North Carolina General Statute (NCGS) 153A-241, counties have the power to close any public road or easement not within a city, except public roads or easements for public roads under the control of the Department of Transportation.

To close any road, the Board must:

- Vote to adopt a resolution declaring its intent to close the public road or easement.
- Call and notice a public hearing on closing the road or easement, with notice "reasonably calculated to give full and fair disclosure of the proposed closing to be published once a week for three successive weeks before the hearing, a copy of the resolution to be sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the public road or easement who did not join in the request to have the road or easement closed, and a notice of the closing and public hearing to be prominently posted in at least two places along the road or easement".
- Hold the public hearing, where the Board must "hear all interested persons who appear with respect to whether the closing would be detrimental to the public interest or to any individual property rights".
- Then, if the Board "is satisfied that closing the public road or easement is not contrary to the public interest and (in the case of a road) that no individual owning property in the vicinity of the road or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property, the Board may adopt an order closing the road or easement".
- File a copy of the Board's order with the Register of Deeds.

The Board approved a Resolution of Intent to close the ROW and to hold a public hearing on this ROW closure at its September 2nd, 2025, meeting.



#### 2025.161 Rezoning Application #R-2025-08, Vulcan ETJ


The zoning map amendment, application #R-2025-08, pertains to a portion of PINs 9670-03-8082 and 9670-12-8754, which Vulcan Lands, Inc. owns. The subject area is located off Clear Creek Rd and Nix Rd. The parent parcels are currently split zoned between the City of Hendersonville and the County. The owner has requested the 16.12-acre portion of the property in the City of Hendersonville's Extra-territorial Jurisdiction (ETJ) be removed. The City of Hendersonville recently processed and approved this request. Planning Staff initiated the application on July 28, 2025, to rezone approximately 16.12 acres of land and to regulate via the County's Land Development Code.

The Technical Review Committee (TRC) reviewed this application during its meeting on August 19, 2025, and voted to forward it to the Planning Board. The Planning Board held a public meeting on August 21, 2025, and voted to send forward a favorable recommendation to the Board of Commissioners.


Before taking action on the application, the Board of Commissioners must hold a public hearing. In accordance with §42-303 and §42-346 (C) of the Henderson County Land Development Code and State Law. Notice of the September 17, 2025, public hearing regarding rezoning application #R-2025-08 was published in the Hendersonville Lightning on September 3, 2025, and September 10, 2025. The Planning Department sent notices of the hearing via first-class mail to the property owners within 400 feet of the Subject Area on September 3, 2025, and posted signs advertising the hearing on September 4, 2025.



#### FLUM Character Areas:



Note: Planning Staff recommends extending the Employment & Industry Character Area onto the subject area if the rezoning request is approved.




## Repairing and Rebuilding

- From October 2024 August 2024 the County has issued 722 permits for building repairs and demolitions specifically related to Hurricane Helene.







- ✓ The applicant's household must qualify as lowto-moderate income, with a combined annual household income of no more than 120% of the Area Median Income, adjusted for family size.



#### ORDER CLOSING AN UNOPENED 40-FOOT RIGHT-OF-WAY

THIS MATTER came on for hearing before the Henderson County Board of Commissioners at its regular September 17, 2025, meeting, pursuant to N.C. Gen. Stat. §153A-241, on the issue of closing the unopened 40-foot right-of-way and was heard by the Board after public hearing. The Board of Commissioners makes the following findings:

- 1. This matter first came before the Board of Commissioners at the Board's regular meeting on September 17, 2025, on the petition by close an unopened 40-foot right-of-way located in Henderson County.
- 2. At the Board's September 02, 2025, the Board adopted a resolution "declaring its intent to close" the unopened 40-foot right-of-way.
- 3. A map showing the area under consideration is shown on the attachment hereto, Exhibit A, (indicated by a broken red line).
- 4. A notice of this Board's September 17, 2025, hearing was published once a week for three successive weeks before the hearing in the *Hendersonville Lightning*, a notice of the closing and public hearing was mailed to adjacent property owners as shown on the county tax records, and a notice of the closing and public hearing to be prominently posted in at least two places along the road or easement.
- 5. Before the Board on September 17, 2025, the Board heard "all interested persons who appear with respect to whether the closing would be detrimental to the public interest or to any individual property rights" are required by N.C. Gen. Stat. §153A-241.
- 6. After such hearing, the Board is satisfied and finds:
  - A. That closing the public road or easement is not contrary to the public interest; and,
  - B. That no individual owning property in the vicinity of the road or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property.

WHEREFORE IT IS ORDERED that to close a 40-foot unopened right-of-way located in Henderson County as shown on the attached map is hereby closed. It is further ordered that a certified copy of this Order shall be filed in the office of the register of deeds of the county.

The Needs-Based Public School Capital Fund was established to assist counties with their critical public school building capital needs. Grants from the NBPSCF are funded with revenue from the NC Education Lottery. Grant funds are available to eligible counties for construction of new school buildings and additions, repairs, and renovations of existing school facilities.

#### **ELIGIBILITY**

Counties with an adjusted market value of taxable real property of less than \$40 billion are eligible to apply for a grant under the NBPSCF program. The list of eligible counties is published by DPI annually prior to the NBPSCF application period. The list of eligible counties for FY2025-26 is available here: FY25-26 Eligibility

Grant funds must be used only for construction of new school buildings and additions, repairs, and renovations. Grant funds cannot be used for real property acquisition or for capital improvements to administrative buildings.

#### **PROGRAM FUNDING**

Funding appropriated for NBPSCF Grant awards exceeds \$258 million for FY2025-26.

#### MATCHING FUNDS

Counties receiving a grant are required to provide local matching funds from county funds, other non-state funds, or a combination of these sources, in accordance with G.S. 115C-546.11.(a). Local matching fund requirements range from 0% to 35% of the grant amount, and are published by DPI annually prior to the NBPSCF application period. The local match requirement applicable to the project is the published local match requirement in effect at the time of the grant award. #### MAXIMUM AWARD Grant award maximums are as follows:

- Up to \$42 million for an Elementary School
- Up to \$52 million for a Middle School
- Up to \$62 million for a High School

An applicant may not apply for projects that exceed an aggregate amount greater than the maximum grant award amounts listed above in any single year.

Applications will be reviewed in the context of projected enrollment to evaluate the reasonableness of project size and scope.

#### REPORTING

Grant recipients are required to submit a report by April 1 of each year, with each grant funds distribution request, and upon completion of the project, detailing: the use of grant funds, progress on the project, and impact of the project on the county's school capital plan.

Grant funds will be disbursed in a series of payments based on the progress of the project. To receive a distribution, the grant recipient must submit a request for distribution, along with documentation of the expenditures for which the distribution is requested, and evidence that the matching requirement has been met. DPI will provide grant recipients with Reporting and Distribution Request forms following announcement of awards.

#### **AGREEMENT**

A county receiving Needs-Based grant funds is required to enter into an agreement with the Department of Public Instruction detailing the use of grant funds, in accordance with G.S. 115C-546.12.(a). DPI will provide grant recipients with Agreement Forms following announcement of awards. Signed Agreements are due within 60 days of award announcement.

Short Description of Proposed School Construction Project:

This project will replace the old and inefficient HVAC system that controls temperatures in five areas of the building (A-Hall, E-Hall, Media Center, Cafeteria, and Kitchen.

The current HVAC system serving the school's A-Hall (4 classrooms), E-Hall (3 classrooms), Media Center, Cafeteria, and Kitchen is outdated and no longer able to provide consistent, reliable climate control. The system struggles to maintain proper temperature and humidity levels, which has led to uncomfortable conditions for students and staff. The age and inefficiency of the system also create frequent maintenance needs, diverting funds and staff time away from educational priorities.

Replacing the HVAC system will directly improve the health, comfort, and learning environment of students and staff. A modern, energy-efficient system will ensure that these classrooms, Media Center and Cafeteria maintain appropriate air quality, temperature, and humidity levels. A new system will also create spaces where students can learn and eat in a safe, welcoming environment. Improved air circulation will reduce the spread of airborne irritants and support better overall wellness. Additionally, an updated system will lower energy costs and reduce the frequency of costly repairs, allowing the school to direct more resources toward academic programs and student support. This investment will enhance both the daily student experience and the long-term sustainability of the school facility.
