Mayor Gonce opened the Regular Meeting and led the Pledge of Allegiance.

# **PUBLIC COMMENT**

Katie Breckheimer and Steve Bradshaw spoke during public comment. Both were in support of an aquatics center.

Council member Keith Reed moved to approve the Minutes of July 15, 2025. Mayor Colletta second the motion. No discussion was needed. The vote was unanimous in favor of the motion.

# Adoption of the 2026 Meeting Schedule

Mayor Blakely made a motion to adopt the 2026 Meeting Schedule. The motion was seconded by Council member Goode and passed unanimously.

# **Historic Markers**

Mayor O'Cain brought up the idea of having historic markers throughout the county. There was discussion. Chairman Lapsley suggested the Historic Resources Commission add it as an agenda item.

Mayor O'Cain introduced Phillip Ellis. Mr. Ellis provided a presentation on the Mud Creek Watershed Flood Reduction Feasibility Study.

# **UPDATES**

#### CITY OF HENDERSONVILLE

Mayor Volk gave updates on the last Rhythm and Brews of the season, the Hendersonville Farm Market, seasonal holiday markets, and the famous painted bears for auction. She also reminded everyone of the Trick or Treat street event on October 31 downtown.

#### VILLAGE OF FLAT ROCK

Mayor Colletta mentioned Shred Day and Pill Take Back Day, future Town Hall meetings, and volunteer opportunities. The Village has received some FEMA money for park cleanup. The Dye Creek restoration project held up through Hurricane Helene. The North Highland Lake Road project is wrapping up and a landscape plan is forthcoming.

#### TOWN OF LAUREL PARK

Mayor O'Cain introduced new council member Mark Morse.

### TOWN OF FLETCHER

Mayor Blakely said Fletcher mentioned Bill Moore Community Park had opened back up. Repairs have been made because of Hurricane Helene. A storm water grant program has been established. It is a 90/10 grant. Friday is Community Appreciation Day. Saturday is the Halloween Crawl.

# **HENDERSON COUNTY**

Chairman Lapsley noted groundbreaking on the upgrade and expansion of the detention center has occurred. There was no tax increase. The next phase will include expansion of the courthouse. Other capital projects include the sports complex at Berkley Park and the Clear Creek sewer project. Mr. Lapsley expressed great concern over the lack of reimbursement funds received from FEMA.

# TOWN OF MILLS RIVER

Mayor Gonce understands concerns over the Riverside Stump Dump fire. The Town of Mills River continues with debris cleanup. Ms. Goode thanked Henderson County for being a great partner in the temporary debris site. That project is closing. She mentioned the Town's UDO project and told everyone to visit <a href="www.imaginemillsriver.com">www.imaginemillsriver.com</a> for input. The Town's Santa Tour is December 13. The Mills River Farm Market's last day for the season is October 25. There will be a holiday market where proceeds go to Mills River Elementary. The Farm Market also has a new field kitchen that can be rented for catering or by farmers to process food.

Mayor Gonce reminded members the next meeting will be held on January 20, 2026, at 3:00 p.m. and hosted by the City of Hendersonville.
