SUMMARY OF REQUEST:

Henderson County is pursuing funding for the completion of Phase I of the Clear Creek Sewer System project. The North Carolina Department of Environmental Quality (NCDEQ) Division of Water Infrastructure requires a resolution for the SRF (State Revolving Fund) Helene Supplemental application. Funding received up to \$5 million will have the principle forgiven entirely by NCDEQ.

BOARD ACTION REQUESTED:

The Board is requested to adopt the project resolution stating Henderson County's intent to request State Revolving Loan Funds for \$5 million toward the completion of Phase I of the Clear Creek Sewer System.

I move that the Board adopt the resolution required for the Division of Water Infrastructure Decentralized Wastewater System-Helene loan application to fund \$5 million toward the completion of Phase I of the Clear Creek Sewer System.

PROJECT RESOLUTION NC DEPARTMENT OF ENVIRONMENTAL QUALITY CLEAR CREEK SEWER SYSTEM PHASE I

WHEREAS, Henderson County has need for and intends to construct, plan for, or conduct a study in a project described as the Clear Creek Sewer System Project, Phase I.

WHEREAS, Henderson County intends to request State loan and/or grant assistance for the project.

NOW, THEREFORE, BE IT RESOLVED by the Henderson County Board of Commissioners that Henderson County, the applicant, will arrange financing for any remaining costs of the project, if approved for a state loan and/or grant award.

That the applicant will provide for efficient operation and maintenance of the project on completion of construction thereof.

That the applicant will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the Henderson County Board of Commissioners agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the County to make a scheduled repayment of the loan, to withhold from the County any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That John Mitchell is an Authorized Representative, and successors so titled, is hereby authorized to execute any agreements and Emily Schwartz, Grants Administrator is an Authorized Representative and successors so titled, is hereby authorized to file an application on behalf of the applicant with the State of North Carolina for a loan and/or grant to aid in the design of the sewer system.

That the Authorized Representatives, and successors so titled, are hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project: to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the applicant has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, ordinances, and funding conditions applicable to the project and to Federal and State grants and loans pertaining thereto.
