## ADDENDUM TO CONTRACT OF PURCHASE AND INTERLOCAL COOPERATION AND SETTLEMENT AGREEMENT

THIS ADDENDUM made and entered into this the <u>3</u> day of <u>4</u>, 2002, by and between Henderson County, a body politic and corporate, hereinafter "County," the Mud Creek Water and Sewer District, a body politic and corporate, hereinafter "District," and the City of Hendersonville, a municipal corporation, hereinafter "City,"

#### WITNESSETH:

WHEREAS, the County, the District, and the City entered into a CONTRACT OF PURCHASE AND INTERLOCAL COOPERATION AND SETTLEMENT AGREEMENT dated December 20, 2000 (hereinafter "Mud Creek Agreement"), and

WHEREAS, the Mud Creek Agreement provided for, among other things, the following: the transfer of certain assets from the County and the District; the creation of the Mud Creek District Advisory Council; the definition of a generalized boundary of an area called the Mud Creek Service Area, encompassing the majority of the Mud Creek Drainage Basin attached thereto as Exhibit F; the process for extending sewer lines by the City, County, and District; the responsibility for operation and maintenance of sewer lines; the provision of sewerage treatment services for the Mud Creek Service Area; and the granting of an option to the County to purchase certain property; and

WHEREAS, Section 4.02 of the Mud Creek Agreement provides that when the generalized boundaries of the Mud Creek Service Area are made more specific and given a legal description through the work of the Mud Creek District Advisory Council, the new, more specific boundary shall be reclassified as the Amended Mud Creek District; and

WHEREAS, the Mud Creek District Advisory Council approved for recommendation to the County, the District and the City, more specific boundaries for the Mud Creek Service Area on October 23, 2001; and

WHEREAS, the County, the District, and the City have approved the more specific boundaries for the Mud Creek Service Area and are desirous of incorporating them into the Mud Creek Agreement as the Amended Mud Creek District;

NOW, THEREFORE, THIS ADDENDUM, that for and in consideration of the mutual promises and covenants contained hereinbelow, the parties agree as follows:

The Amended Mud Creek District is hereby established, having an effective date of July 1, 2002. The boundaries for the Amended Mud Creek District shall be those shown on the attached Exhibit A and described in Exhibit B, said Exhibits A and B being incorporated by reference as if fully set forth herein. Any reference to Mud Creek Service Area in the Mud Creek Agreement shall be deemed to refer to the Amended Mud Creek District as established herein.

All other terms and conditions of the Mud Creek Agreement shall remain in full force and effect, and all parties agree to be bound thereby.
