Old Business:


Review of procedures for early voting.


- a) Observers at the BOE One-Stop complained they were not able to see the vote count after the polls closed. According to the Director, Observers are not allowed to be in close proximity to the scanner or read the vote count number at closing of One-Stop polls because they are not allowed in the voting enclosure. Director was asked to check with the State regarding this rule.
- b) At closing, the ballot box should be removed from the scanner, locked and sealed with a numbered seal. Director will remind poll workers of this procedure.
Question: Is there a form to place the duplicate seal on and signature for chain of custody?
- c) There were complaints about prompting UNA voters for type of ballot and voters full name. Director states her training directs poll workers not to prompt voters and will remind them not to do so.

New Business:

Approval of One-Stop Applications (ATV's) and Absentee Ballots. Received 95 mail-in ballots. 2 ballots were not approved due to no witness signature. They will be voided, and new ballots issued. 93 Ballots were approved and scanned. and Chain of Custody form signed. Total Mail-in ballot count to date is 210 (117+93). 1,537 One-Stop voters up to 5/2/22.

There being no further business, the meeting was adjourned at 6:37 PM.
