October 18, 2022

The Board of Elections met October 18, 2022, at 5:00 PM at the Henderson County Board of Elections office at 75 E. Central Street. Members present were Charles Medd, Chairman, Debbie Dante, Secretary, Linda Rebuck, Christian Stolz, Members, and Director, Karen Hebb and William Cutler, Member attended remotely via Zoom due to illness.

Pledge

Minutes: Minutes were approved for 10/4/22 and 10/11/22.

Agenda:

Linda moved to approve the agenda. Chris 2<sup>nd</sup>. Passed unanimously.

Old Business:

- a) Memo 2022-09 states mail in ballots postmarked on Election Day (Nov 8) are due on the Monday following the election at 5 PM (Nov 14) as opposed to the Friday after election because Friday, Nov 11 is Veterans Day and the Post office is closed. Director will confirm this is still the case.
- b) At the 9/21/22 meeting Debbie asked: 08 NCAC 10B.0105-Procedures at Close of Voting, Section (i)(2) states precinct judge is to *"...report by telephone or other electronic means the total precinct vote for each ballot item to the county board of elections"*. Director stated this has never been done and will consult with the State on these closing requirements. As follow-up, the Director emailed Paul Cox a help ticket with the question, but to date has had no response. Director will follow-up again.

New Business:

Approval of Absentee Ballots

Scanner opened and the number of ballots in the counter window was 536. Seals were removed and confirmed. Ballot box and emergency bin were checked and empty. Ballots from last meeting were removed, put in order, segregated and placed in fireproof box in locked Ballot Room by staff.

Ballots were approved by Linda & Charlie and Debbie & Chris.

Final scanner count was 888. Scanner sealed, ballot box locked and sealed, and Board signed Chain of Custody form.

There being no further business, the meeting was adjourned at 7:02 PM.
