The Board of Elections met February 20, 2024, at 5:00 PM at the Henderson County Board of Elections office at 75 E. Central Street. Members present were Clay Eddleman, Chair, Debbie Dante, Secretary, Linda Rebuck, William Cutler, and Sharon Pearson, Members, and Summer Heatherly, Director.

Pledge

Minutes:

Minutes were approved for 2/13/24.

Agenda:

Bill moved to approve the agenda. Linda 2<sup>nd</sup>. Passed unanimously.

Old Business: None. Chair thanked Debbie for substituting and Summer and the staff for a wonderful job in the past few days of Eary Voting.

New Business: **Approval of Absentee Ballots**. Seal # 0094037 from last Tuesday was read aloud. Checked empty ballot box and Emergency Bin that they were empty and inserted ballot box into scanner. Beginning Public Count is 89. Ballots were divided into 2 approval Teams: Bill & Debbie, Sharon & Linda. Chair opened and a bi-partisan team of the staff scanned ballots into scanner. We will be scanning ballots by precinct.

68 ballots Approved and scanned.

1 Photo ID Exception form (Reason: work or school schedule) Board unanimously returned for cure and requested Director to contact voter to bring ID to the BOE office.

Scanner was switched out during scanning when it refused to accept ballots at public count of 138. Thumb drive was removed and placed in replacement scanner. (Scanners do not store data).

Scanner sealed (#0094099), ballot box locked and sealed (#15120383), and Board signed Ballot Reconciliation form. Ending Public Count is 157.

Director's Comments. Tentatively, we will begin signature matching in April. The State is reviewing software now.

Our county BOE website has a link to the lists of voters updated at 10 am, 2 pm and 4 pm. By 2 pm today 2,132 have voted.

933 ballots have been mailed out to date, plus 5 Military & 70 Overseas ballots have been emailed.

Same day registration receives a regular ballot if they have photo ID & HAVA document, if not, they receive a Provisional ballot. They are retrievable, as are all Early Voting ballots. Confirmation cards are mailed that evening.
