**CANVASS**

The Board of Elections met March 15, 2024, at 11:00 AM at the Henderson County Board of Elections office at 75 E. Central Street. Members present were Clay Eddleman, Chair, Debbie Dante, Secretary, Linda Rebeck, Sharon Pearson, William Cutler, Members, and Summer Heatherly, Director. Staff present: Aaron, Chasity, Vicki.

Pledge

Chair reminded visitors to hold any questions until the end of the meeting.

Linda moved to recess until the 5<sup>th</sup> member of the Board appears. Sharon 2<sup>nd</sup>. Passed unanimously.

Recessed at 11:03 AM.

Reconvened at 11:37 AM. Chair called meeting back to order.

Minutes: Minutes were approved for 3/14/24.

Agenda: Linda moved to approve the agenda. Sharon 2<sup>nd</sup>. Passed unanimously.

Old Business: None.

New Business: **Review, tabulate and add results of approved Supplemental Absentee Ballots, Complete Supplemental Abstract and Certificates of Oath.** Received 1 cured Ballot yesterday before 5 pm. Board signed Absentee Abstract for the 604 Absentee Ballots approved on Election night. Broke seal # 0094056 on Absentee Supplemental scanner and seal # 15120380 on the ballot box. Supplemental Absentee scanner Public Count: 49. Printed results tape, Board signed and completed the Vote Total Verification forms.

**Review, tabulate and add results of approved Provisional Ballots, complete Provisional Ballot Returns.** Broke seal # 230592 on Provisional scanner and seal #15120379 on ballot box door. Public Count: 33 (actual count was 34 but one ballot was entered into the scanner on Election Day by mistake). Printed results tape. Board signed and completed Vote Total Verification.

**Review and approval of total vote counts and voter history from Pre-Canvass audit and Final Canvass Spreadsheet.** Aaron had to add Provisional Ballots into the Absentee Supplemental scanner to hide possible discovery of Provision voter name and ballot choices. Director reviewed Final Canvass Spreadsheet. County turnout was 30.68%, about 4% lower than 2020 Primary.

**Review Hand to Eye Count.** Performed 3/11/24, for Brickton Precinct and Southeast Precinct. DS200 scanner compared with Hand Eye count was the same; Brickton Precinct 251 votes, Southeast Precinct 131 votes. Note that Brickton actual votes were 252; counted 1 vote from yesterday that the scanner refused.

Chair moved to recess for 5 minutes. Sharon 2<sup>nd</sup>. Passed unanimously.

Recessed at 12:35 PM.

Reconvened at 12:40 PM. Chair called meeting back to order.

Board signed Final Abstract of Votes.

**Chair Comments:** The Chair thanked the Board, staff, and audience because he never realized how complex the voting systems were.

**Directors Comments:** Director thanked everyone as her first election as Director was a great success, including using the BOE office as the sole Early Voting location.
