Minutes:


- Member Poller moved to accept the minutes. The motion was approved unanimously.

New Business:


- 109 absentee ballots were reviewed, all approved, and the ballots tabulated. All necessary steps were completed per legal requirements.

Chair Rebuck reminded the board that the next meeting would be at 5 pm Tuesday, March 3.






