Agenda:

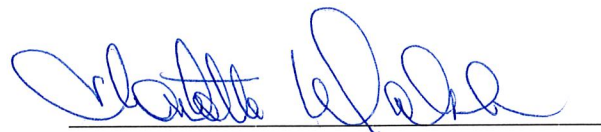

New Business:

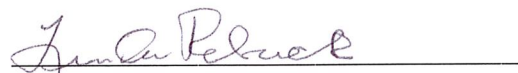
- 13 absentee ballots were reviewed, all approved, and the ballots were tabulated. All necessary steps were completed per legal requirements.

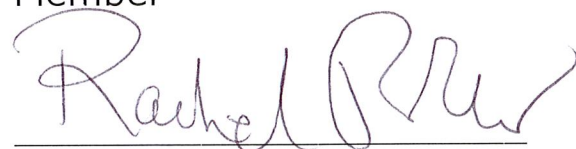
