Minutes: Minutes were approved for 4/23/24.

Agenda: Chair requested amending the agenda by inserting Chair Comments after Approval of Agenda. Linda moved to approve the agenda as amended by the Chair. Cindy 2<sup>nd</sup>. Passed unanimously.

Chair Comments: Chair congratulated our newest member, Cindy Ellis, who will be inducted into the Hendersonville County Education Hall of Fame tomorrow night. The meeting was called tonight to discuss the Early Voting Plan for the Nov. 2024 Presidential & Municipal Election. Chair reminded Members that the Plan should be agreed to unanimously, otherwise it will be decided by the State Board.

New Business: **General Election Early Voting Discussion.** Director reviewed the attached Early Voting Proposal with the Members. Director's recommendation is to open one Early Voting Site at the Board of Elections office. Cost-effectiveness and safety were also discussed in relation to opening one site only. Members also discussed possible concerns of voters from the outer areas of the county. After mapping research, it was determined that it takes the Chair as long, if not longer, from the top of the mountain in Laurel Park, as it does some of our furthest precincts in the county to come to the BOE. Linda moved to accept the Early Voting Proposal as presented. Sharon 2<sup>nd</sup>. Passed unanimously.

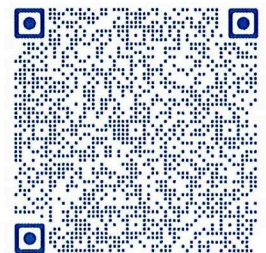
