i. MountainTrue Holiday recycle event- Holiday recycle event with MountainTrue, City of Hendersonville Public works, Henderson County solid waste. ~350 trees collected. Addition of foam collection this year.

- ii. EPA-SWIFR- Working on this grant now. \$500,000-\$4,000,000 available for Solid waste infrastructure. Proposal to include 3rd transfer station shed and compost expansion.
