 - a. Guests
 - i. Ward Sequin, Retired NOAA Meteorologist Ward presented data on frequency of heavy rainfall events and the impact on the French Broad River.

- ii. Toby Linville, Henderson County Floodplain Administrator Toby reviewed the flood ordinances in Henderson County. Henderson County joined National flood insurance in 2005 through FEMA. Flood ordinance resides in the Land Development Code (LDC). Basics: No construction in flood way, can build in flood plain but must build 2 ft above base flood elevation, can fill up to 20% with permitting, can fill more with special fill permit and no rise certificate, no fill in the flood way without special fill permit and nor rise certificate. Anything in flood plain requires elevation certificates.
- b. Vice Chair selection and promote vacancies on EAC

Vice chair role is to step up and lead meetings when the chair is unavailable. Vice chair is typically invited to meeting to plan agenda for the next meeting. Chris Berg, current Vice chair, has completed 2 terms with the EAC and this is his last meeting. The EAC needs new vice chair-no interested members present. Nancy asked Ben to fill in at next meeting if available, he will reach out to Amy if he is unavailable. Will discuss vice chair position at next meeting. As of July, the EAC will have 3 open positions. There are currently 4 applications, Amy will review and make recommendations.

c. Hendo Earth Fest steering committee

Hendo Earth Fest is planning for their 3rd event in 2025. There may be an opportunity for a member of the EAC to join the steering committee for the event and be involved in the planning. Will discuss again once new members join EAC.
