Temporary Food - Event Organizer Application

This application should be filled out and submitted to Henderson County Environmental Health to provide information about any expected food vendors at a special or temporary event in Henderson County. This application should be filled out by the event organizer, not individual food vendors. This form is informational only. There is no fee associated with this application. Please include a map/layout of the event showing food vendor locations. Please note:

- Temporary food vendors are required to submit the Temporary Food Establishment (TFE) application separately at least 15 days before the start of the event and pay the \$75.00 TFE permit fee for each selling location.
- North Carolina-permitted mobile food units (MFU’s), food trucks, food trailers, and pushcarts may be required to obtain a TFE permit from Henderson County Environmental Health depending on the duration of the event.
- Out-of-state-permitted mobile food units, food trucks, food trailers, pushcarts, and caterers **MUST** obtain a TFE permit from Henderson County Environmental Health. An out-of-state permit is not valid in North Carolina.
