"SNOW PLAN" Purpose Statement:

Henderson County's plan for prioritized and efficient removal of snow, ice and debris from County Facilities to ensure a safe environment for Citizens and Employees.

The Engineering Department is indirectly integrated into the operations of all the other County Departments during its normal operations. However during Snow and Ice events, Engineering becomes directly integrated; most importantly, with the Emergency Response efforts of the County. Engineering must ensure the Sheriff and Emergency Management Departments are encumbered as little as possible by the effects of weather. Additionally, Engineering is responsible for safe hours of operation for all the remaining Departments during weather events.

Specifically, the purpose of this plan is as follows:

- Provide guidance to County staff and contractors for snow and ice removal operations to assure a safe environment for employees and Citizens.
- Provide the ability for County Departments and other associated organizations to review operations.
- Provide the ability to efficiently review, prepare and train for operations on an annual basis.
- Provide financial accountability for the resources used to removal snow and ice from County facilities.

Annual Snow Meeting:

An annual "Snow Meeting" will be held in September each year with all staff tasked with responding to weather events, see available personnel below. The County Engineer will lead the meeting and accomplish the following:

- 1. Review the Snow Plan and make any revisions or updates needed since the previous year's meeting.
- 2. Train all appropriate personnel on equipment used to address weather events.
- 3. Test and repair all equipment used to address weather events, see available equipment list below.
- 4. Review and update if needed the Contractors used to address weather events, see Contractor list below.

Prioritized List of Facilities:

See the attached list of facilities which have been prioritized with the following criteria:

- 1. Priority One: Bare Pavement Facilities, Remained Clear of Snow & Ice at all times
- 2. Priority Two: Snow & Ice cleared by and during the facilities hours of operation
- 3. Priority Three: Snow & Ice cleared when priority #2 facilities have been addressed

Procedures for Removal Operations:

The following items are important to consider prior to adverse weather event:

- Monitor multiple weather media and Emergency Management Updates during periods of possible weather events.
- Key snow accumulation is 1.5 to 2". Over this threshold, ice melt is not needed until removal down to 1.5 / 2".
- Send Admin Alert to ask that all vehicles left during Event be moved to farthest space in lots away from buildings
- Coordinate with libraries, shelter and other Saturday operating departments to determine if they will be open
- Meeting Room & Recreation Facility Scheduler: review schedule to reschedule or if necessary notify CS to clear snow
- Continuously coordinate with Emergency Shelter and EMS to make sure Contractors are keeping clear

The following items are important to consider during adverse weather

- Snow that is being removed should be stockpiled at the lowest grade of a parking lot when possible. If needed, take a couple parking spaces to store excess snow.
- All handicap parking places, curb cuts, ramps or other similar areas, must be cleared and considered a priority for the sidewalk crews. Steps and walkways for the public or employees should be next on the crews list when going from building to building.
- Traction aid added to ice melt on critical locations where ice melt may not completely remove ice
- For continuing ops while snow is falling, utilize two teams alternating shifts. Make sure both teams have equal and capable equipment operators
- Sidewalks at Green River Library, Etowah Library and Fletcher Library need to be cleared in House

After adverse weather the following need to be considered:

- After City and NCDOT operations entrances may get blocked with plowed snow and need to be re-cleared
- After the bulk of the removal is complete, the icy spots will be monitored and addressed daily if the temperatures stay below freezing.
- Need the barricades to close facilities that can't clean
- Our Facilities need to be cleaned at least as well as the City & State Roads
- Facilities will need sweeping / washing for remaining salt, sand and salt residue

The following are some important points on utilizing chemicals during weather events:

 Often, removing the snow is just the first step in the process of making your driveways and walkways snow and ice-free. Dealing with the ice left behind is the next challenge. Ice does not just freeze on the pavement, it freezes to the

- pavement. Breaking that bond, or keeping it from forming in the first place, is the task of chemical de-icers or anti-icers.
- A de-icer is a chemical agent that is spread on snow or ice. It does not melt all the snow; it seeps through to the surface of the pavement and melts the ice there, breaking the bond and making it easier to remove the snow.
- An anti-icer is a chemical agent that is applied before the snowfall begins. It prevents the bonding, thereby facilitating the removal of snow down to the surface of the pavement.
- There are many chemicals and chemical blends available to use as de-icers and anti-icers. While the chemistry is simple, the choice of which to use is not. Many factors must be considered and much of the information is confusing or even conflicting.
- For many years, the most common de-icer has been rock salt. The indirect damage and environmental concerns were offset by its cost-effectiveness. Today, more environmentally friendly and considerably more effective chemicals are available.
- Any de-icing chemical has the potential to harm the environment if misused. Some will chemically attack concrete. All must be used strictly according to the manufacturer's guidelines. Over application of any can damage vegetation; even those products claiming to be made from fertilizing ingredients can cause harm.
- If you apply the chemicals as precipitation begins, their effectiveness is increased and the amount needed is diminished.
